

MOTION

A&B filed a petition for judicial review on June 27, 2011. The petition concerned the Interim Director's April 27, 2011 *Final Order on Remand Regarding A&B Irrigation District Delivery Call*. On July 7, 2011, IDWR filed a motion to dismiss A&B's petition. The Court granted A&B's motion by its *Order on Motion to Dismiss and Motion to Strike* ("Order") issued on August 11, 2011.

Idaho Rule of Civil Procedure 54(b) allows the district court to direct the entry of a final judgment upon one or more but less than all of the claims in a case upon an express determination that there is no just reason for delay. In this case the Court dismissed A&B's original petition but concurrently authorized A&B to amend its petition to appeal the Interim Director's amended final order issued on June 30, 2011. A&B filed an amended notice of appeal and petition for judicial review on August 25, 2011. Accordingly, not all of the claims in this case have been decided.

A&B submits there is no just reason for delay of the entry of a final judgment with respect to the Court's August 11, 2011 *Order*. Which agency order is subject to judicial review is a threshold question of law that should be decided at the outset of the case. Moreover, the parties should have certainty as to which final agency order will be the subject of this Court's review (i.e. April 27th final order as opposed to the June 30th amended final order) to avoid any unnecessary costs and time associated with potentially multiple appeals.

Counsel for A&B has contacted counsel for IDWR, and counsel for the parties to the administrative proceeding, IGWA, City of Pocatello, Fremont-Madison Irrigation Dist. et al. No other party opposes A&B's motion for a Rule 54(b) certificate.

No oral argument is requested. A&B respectfully requests the Court to grant this motion.

A proposed order and judgment is attached for the Court's consideration.
