



judicial economy and the economy of the parties, the Court in its discretion will reset the hearing on the *Motion to Remand* in accordance with the *Unopposed Motion*.

THEREFORE THE FOLLOWING ARE HEREBY ORDERED:

1. The hearing in the above-captioned matter on the *Motion to Remand* set for November 26, 2012 is hereby vacated.

2.
