Comes now, The City of Pocatello (“Pocatello”), by and through its counsel of record, and respectfully objects pursuant to Idaho Appellate Rule 29(a) to the clerk’s record filed in this matter. Pocatello is authorized to state that the Idaho Department of Water Resources and Idaho Ground Water Appropriators, Inc. stipulate to these additions to the record.

The clerk’s record is incomplete in that it does not include all of the documents considered by the District Court in reaching its April 25, 2013 *Memorandum Decision on Petition for Judicial Review* in the above-captioned matter. Accordingly, Pocatello requests that the following documents filed in Minidoka County Case No. CV 2009-647 be included in the clerk’s record on appeal:






