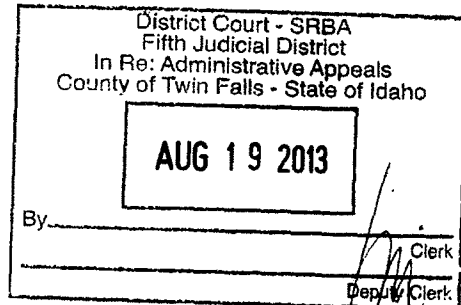


YOU ARE HERBY NOTIFIED THAT Randall C. Budge and Thomas J. Budge of Racine, Olson, Nye, Budge & Bailey, Chtd., hereby enter an appearance as attorneys of record for and on behalf of the Respondent/Intervenor, Idaho Ground Water Appropriators, Inc. ("IGWA"), acting for and on behalf of its members, who was a party/respondent to the underlying administrative action.

Additionally, IGWA hereby moves this Court to be designated as a Respondent-Intervenor since IGWA has been actively involved in the proceedings, is a real party in interest and was a party to the underlying administrative proceeding from which judicial review is being requested.

IGWA represents the interests of the owners of water rights that are junior in priority to American Falls Reservoir District #2's ("AFRD#2) water rights, could potentially be subject to curtailment and required to provide mitigation for predicted reasonable carryover shortfalls to AFRD#2. 
