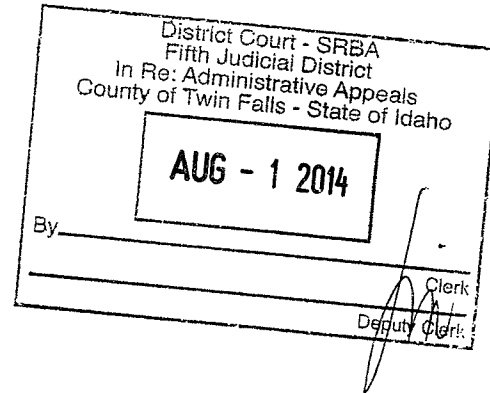



The Court having received a stipulation of the parties reflecting the following order, and being fully advised of the premises, IT IS ORDERED AND THIS DOES ORDER:

1. That the appeal in the above-entitled matter be severed from the request for writ of mandate and declaratory judgment.
2. That the appellate Petitioner/Plaintiff is to file an amended notice of appeal in the above-entitled case, bearing the above-entitled case number, deleting therefrom references to the *Verified Complaint* on file herein.
3. That the processing of the appeal be stayed until further order of the Court.
4. That the Petitioner/Plaintiff shall also forthwith file a supplemental complaint for declaratory judgment and writ of mandate.
5. That the Clerk shall give the new complaint on file herein a new case number, and shall transfer thereto all pleadings applicable thereto. In the event a pleading is applicable both to the appeal and the supplemental complaint, the Clerk shall copy necessary

pleadings in the appeal file and file the copy with the supplemental complaint under the new case number.
