**ORDER GRANTING MOTION

On October 8, 2015, Karl T. Cook and Jeffrey M. Cook filed a *Motion to Intervene* in the above-captioned matter. Although the movants were parties to the underlying administrative proceeding, they were not made named parties in the *Petition for Judicial Review* filed by the Petitioners. This Court find that the movants are real parties in interest to this proceeding, that

they were parties to the underlying administrative proceeding from which judicial review is being requested, and that they have interests that could be affected by the outcome of this proceeding. This Court further finds that the *Motion to Intervene* is unopposed.¹ Therefore, in exercising its discretion, this Court finds that the movants are entitled to leave to intervene as parties to this proceeding.

THEREFORE THE FOLLOWING ARE HEREBY ORDERED:

1. The *Motion to Intervene* is hereby **granted**.
2. All further captions used in this proceeding shall include Karl T. Cook and Jeffrey M. Cook as Intervenors as shown above.
