**ORDER GRANTING JOINT MOTION TO
SHORTEN TIME PURSUANT TO I.R.C.P.
56(C)**

On January 27, 2015, a *Joint Motion to Shorten Time Pursuant to I.R.C.P. 56(c)* was filed by counsel for Defendant Thomas M. Ricks (“Ricks”), Defendants Gary Spackman and the Idaho Department of Water Resources (collectively “IDWR”), and Plaintiff D.L. Evans Bank (“D.L. Evans”). The motion moved the Court to alter and shorten the time periods and requirements of Idaho Rule of Civil Procedure 56(c).

For good cause shown, the Court orders the following response and reply deadlines for the motions for summary judgment filed by Ricks and IDWR:

- February 6, 2015 – D.L. Evans response brief to Ricks’ motion for summary judgment;

- February 9, 2015 – D.L. Evans response brief to IDWR motion for summary judgment;
- February 12, 2015 – Ricks reply to D.L. Evans response to Ricks’ motion for summary judgment
- February 12, 2015– IDWR reply to D.L. Evans response to IDWR’s motion for summary judgment

This order does not alter the response and reply deadlines as to the motion for summary judgment filed by Ballentyne Ditch Company, Ltd. and the Directors of Ballentyne Ditch Company, Ltd.
