AMENDED PREHEARING ORDER

BACKGROUND

On August 2, 2017, the Idaho Department of Water Resources (“Department”) denied Joint Application for Permit No. S82-20066 in the name of Gay Richardson (“Richardson”) for suction dredge mining within the Red River, a tributary of the South Fork Clearwater River.

On August 2, 2017, the Department denied Joint Application for Permit No. S82-20067 in the name of John Stickley (“Stickley”) for suction dredge mining within the Red River, a tributary of the South Fork Clearwater River.

Richardson and Stickley had fifteen days from August 2, 2017, to notify the Department, in writing, of their request for hearing before the Idaho Water Resource Board (“IWRB”) on the denial of their respective Joint Applications for Permit.

The Department received a letter from Richardson on August 15, 2017, requesting a hearing on the denial of Joint Application for Permit No. S82-20066. The Department received a letter from Stickley on August 17, 2017, requesting a hearing on the denial of Joint Application for Permit No. S82-20067.

On September 15, 2017, the IWRB appointed John M. Melanson as the hearing officer to preside over the hearings requested by Richardson and Stickley and issue a recommended order or recommended orders in accordance with Idaho Code §§ 67-5243(1)(a) and 67-5248.

On October 2, 2017, the hearing officer issued a *Notice of Prehearing Conference* notifying Richardson and Stickley of a prehearing conference scheduled for October 18, 2017. The hearing officer held the prehearing conference on October 18, 2017. Richardson and Stickley attended the prehearing conference by telephone.

Based upon and consistent with discussion at the prehearing conference, the hearing officer issued a *Prehearing Order* authorizing discovery, adopting a schedule, and notifying the parties a hearing would be held on December 11, 2017, at 9:00 a.m. (MDT), and continuing through December 12, 2017, if necessary, at Grangeville City Hall, located at 225 West North Street, Grangeville, Idaho, 83530.

Due to medical issues, the hearing officer must reschedule the December 11 and 12, 2017, hearing dates to February 8 and 9, 2018. The hearing officer will also amend the deadlines set forth in the schedule adopted in the *Prehearing Order*. Counsel assisting the hearing officer contacted Richardson and Stickley prior to issuance of this *Amended Prehearing Order* to coordinate hearing dates and discuss amending the deadlines.

AMENDED SCHEDULING ORDER

IT IS HEREBY ORDERED that the schedule adopted in the *Prehearing Order* is amended as follows:

- January 8, 2018** Deadline for Richardson and Stickley to submit to the hearing officer a list of expert witnesses, if any, they intend to rely upon at the hearing, including the expert's name, address, and phone number. By this deadline, the Department must also submit to the hearing officer and to Richardson and Stickley a list of employees who may testify at hearing.
- January 12, 2018** Deadline for the Department to submit answers to Richardson and Stickley pertaining to written interrogatories.
- January 12, 2018** Deadline for completion of discovery.
- January 25, 2018** Deadline for Richardson and Stickley to submit to the hearing officer a list of witnesses they intend to call to testify at the hearing, including the witness's name, address, and phone number.
- January 25, 2018** Deadline for Richardson and Stickley to submit to the hearing officer copies of exhibits they intend to rely upon at the hearing. By this deadline, the Department must also submit to the hearing officer and to Richardson and Stickley copies of exhibits the Department intends to rely upon at the hearing.

AMENDED NOTICE OF HEARING



Richardson and Stickley must be represented at the hearing in person.

The hearing will be held in accordance with provisions of Chapters 2 and 17, Title 42 and Chapter 52, Title 67, Idaho Code, and the adopted Rules of Procedure of the Department, IDAPA 37.01.01.
