

On December 8, 2017 the Palisade Water Users, Inc., City of Idaho Falls, Surface Water Coalition, Shoshone-Bannock Tribes, Bureau of Indian Affairs, and the Upper Valley Storage Holders filed statements of issues the Director has jurisdiction to determine in this matter, in response to the Director's request for the same in his November 20, 2017 Order. Pocatello, through its undersigned counsel, hereby responds to those pleadings.

Pocatello agrees with the characterization of the Director's authority and jurisdiction in the statements of issues filed by the above-referenced parties, including but not limited to the Director's administration of existing decrees and stipulations that control the administration of the Snake River reservoirs, and incorporates the legal bases for such issues into its own statement filed December 12, 2017. Further, although Pocatello does not necessarily endorse the positions taken by other parties in their listings of issues, Pocatello does endorse the issues as being properly within the scope of this proceeding.


