**ORDER EXTENDING STAY AND  
SETTING DEADLINE**

**BACKGROUND**

On March 20, 2018, the Director (“Director”) of the Idaho Department of Water Resources (“Department”) held a status conference in the above-captioned matter. All parties were present at the status conference. Later that day, the Department received a *Stipulated Motion to Extend Stay and Schedule Status Conference* (“Stipulated Motion”), requesting the Director “extend the stay indefinitely and schedule a status conference for Thursday April 26, 2018 at 10:00 a.m.” *Stipulated Motion* at 1. On March 26, 2018, the Director issued an order granting the parties’ request to schedule a status conference for April 26, 2018, and extended the stay until May 3, 2018.

On April 26, 2018, the Director held a status conference. All parties were present at the status conference, except Aberdeen Springfield Canal Company. At the status conference, the parties requested that the Director extend the stay of this matter for an additional 30 days from May 3, 2018. The parties also requested that the Director establish a deadline for the parties to submit a joint draft agreement for a one-year reset of the storage water rights for the fall of 2018.

**ORDER**

Based upon and consistent with the foregoing, IT IS HEREBY ORDERED that the contested case in this matter is STAYED until **June 4, 2018**.

IT IS FURTHER ORDERED that the parties must submit a joint draft agreement for a one-year reset of the storage water rights for the fall of 2018 by **June 4, 2018**.
