PER THE ABOVE REFERENCED "AMENDED NOTICE OF HEARING; ORDER AUTHORIZING DISCOVERY; SCHEDULING ORDER DATED 27 MAY 2016 (RECEIVED ON 03 JUNE 2016)", THIS DOCUMENT IS OUR "NOTICE OF INTENT TO PARTICIPATE ("NOI") AS DIRECTED AND REQUIRED BY THE ABOVE REFERENCED "AMENDED NOTICE OF HEARING". ONE OR BOTH OF THE PARTIES, SIGNATURES BELOW, WILL PARTICIPATE IN THE 29 JUNE 2016 SCHEDULED HEARING.

ALSO, PER THE ABOVE REFERENCED "AMENDED NOTICE OF HEARING"; ORDER AUTHORIZING DISCOVERY; SCHEDULING ORDER DATED 27 MAY 2016 (RECEIVED ON 03 JUNE 2016), THIS DOCUMENT IS OUR "EXPRESS STATEMENT", THAT WE **DO NOT SUPPORT** THE "PRELIMINARY ORDER SUSPENDING ROTATION CREDIT IN WD34" and **CHALLENGE IDWR'S rationale and authority to legally do so.**

Melvin Marx Hintze, P.E. and Darla Ann Hintze, WD34 water users strongly give notice to IDWR that the "BASIS" for "Rotation Credit Suspension" as documented in the nineteen (19) "FINDINGS OF FACT" and the five (5) "CONCLUSIONS OF LAW" stated in the "PRELIMINARY ORDER SUSPENDING ROTATION CREDIT IN WATER DISTRICT 34, DATED 29 APRIL 2016" are completely without merit and with respect to supporting this action!

As such and also, "ROTATION CREDIT PRACTICES" have been thoroughly and strongly affirmed by the now completed, "Snake River Basin Adjudication (SRBA)". IDWR's "29 April 2016 PRELIMINARY ORDER SUSPENDING ROTATION CREDIT IN WATER DISTRICT 34" is, in simple language, an attempt to Relit agate the SRBA.


