Idaho Power Company (“IPC” or “Company”), by and through counsel, hereby submits its *Notice of Intent to Participate* in the Accounting for Distribution of Water to the Federal On-stream Reservoirs in Water District 63, pursuant to the Director’s *Scheduling Order: Notice of Hearing; Order Authorizing Discovery* issued in this matter on October 14, 2014.

The Company owns 17 hydroelectric projects on the Snake River and its tributaries, many of which are located below Federal on-stream reservoirs, and operates those projects for power generation and other beneficial public uses. The definition of fill and the resolution of the refill issue in the Boise River drainage, as well as Water District 01, will have direct bearing on water supply in the Snake River and the Company’s integrated resource planning. IPC is

currently participating in the Water District 1 matter and believes that these two matters may have cross implications. Accordingly, IPC has a right and interest in this matter, and desires to participate in this matter.


