Supplement to Document Overview

This proceeding was initiated "to address and resolves concerns with and/or objections to how water is counted or credited toward the fill of water rights for the federal on-stream reservoirs pursuant to existing procedures of accounting in Water District 63." Notice of Contested Case and Formal Proceedings, and Notice of Status Conference (Oct. 24, 2013). The federal on-stream reservoirs to which water is distributed in Water District 63's existing water right accounting system are: Lucky Peak, Arrowrock, and Anderson Ranch (collectively, "the federal reservoirs").

During a pre-hearing conference, parties requested that the Department identify documents which may be relevant to this proceeding. The Director agreed to have Department staff identify documents which may be relevant to this proceeding. In response to the request, a "Document Overview" was posted on the Department's website for the "Water District 63 Contested Case" which listed certain documents that may be relevant to this proceeding.

Subsequent to the posting of the Document Overview of November 4, 2014, the United States notified counsel for the Department, counsel for the Boise Project Board of Control, counsel for the "Ditch Companies," and counsel for United Water Idaho, "that [the Bureau of] Reclamation has retrieved documents from the Federal Records Center that relate to the Boise River reservoir system. You are welcome to review the documents."

The documents made available for review by the Bureau of Reclamation may be relevant to his proceeding. The Document Overview of November 4, 2014 and this Supplement are not intended to restrict the parties to the documents identified or listed therein, but rather to notify the parties of potentially relevant documents.
