COMES NOW the petitioner, A & B Irrigation District, by and through its attorney Roger D. Ling and Timothy J. Schneider of the firm of Ling & Robinson, and petitions to intervene in the above-captioned proceeding. This petition to intervene is filed pursuant to Rules 350 to 354, Rules of Procedure of the Idaho Department of Water Resources, IDAPA 37.01.01.350 to 354.

A & B Irrigation District is an irrigation district organized under the laws of the State of Idaho and is the beneficial owner of certain water rights used for the delivery of water to lands within the irrigation district for irrigation by landowners within the district. A & B Irrigation District diverts ground water in Basin 36 for the irrigation of over 68,000 acres under water rights having

3 a priority of September 9, 1948. Land irrigated under these rights  
4 is within the area petitioners propose for establishment of a ground  
5 water management area within Basin 36. Designation of only Basins  
6 35 and 36 as ground water management areas and not all of the Eastern  
7 Snake Plain Aquifer would significantly affect the water rights of  
8 A & B Irrigation District.

9 A & B Irrigation District protests the designation of ground  
10 water management areas in Basins 35 and 36 as purportedly requested  
11 by petitioners for the reason that the management of only a portion  
12 of the Eastern Snake Plain Aquifer as a ground water management area  
13 is a violation of due process and equal protection guaranteed under  
14 the Constitutions of the State of Idaho and the United States and  
15 the prior appropriation doctrine of the State of Idaho.

16 A & B Irrigation District requests waiver of the  
17 requirements of Rule 352 of Procedure of the Department of Water  
18 Resources, IDAPA 37.01.01.352 insofar as filing at least 14 days  
19 before a formal hearing or pre-hearing conference, based upon the  
20 truncated time periods established in the Director's Order of August  
21 3, 2001, and the need to review this matter with the Board of  
22 Directors of A & B Irrigation District prior to having authorization  
23 to file this *Petition*. To satisfy the 14-day requirement in this  
24 case, a *Petition* would have had to be filed on or before August 14,  
25 2001. Counsel for A & B Irrigation District did not receive the  
26 Director's Order until August 15, 2001, which made it impossible for  
27 A & B Irrigation District to file a *Petition to Intervene* prior to



August 14, 2001. It is respectfully submitted that the normal 14-day requirement of Rule 352 was unduly and unreasonably restrictive under the circumstances of this case.

A & B Irrigation District respectfully requests that this *Petition to Intervene* be granted and that it be allowed to participate as a party in these proceedings.


