
IDA is the non-profit organization which represents all dairy farmers in Idaho who sell milk for human consumption. Several Idaho dairy farmers divert ground water within the American Falls Ground Water Management Area ("AF GWMA") as it was originally designated and as it has been modified by the Director. On behalf of those IDA members, IDA has a direct and substantial interest in any change to the boundaries of the AF GWMA, and any related change to the manner in which water rights within those boundaries are administered by the Director.

**ORIGINAL**

The Director granted IDA intervention and full party status in the proceedings through which the AF GWMA was originally designated by his September 14, 2001 *Order* staying those proceedings.
