**IGWA'S SECOND SUPPLEMENTAL
RESPONSE TO DIRECTOR'S JUNE 7,
2005 ORDER REGARDING
REPLACEMENT WATER PLAN
(BLUE LAKES DELIVERY CALL)**

Idaho Ground Water Appropriators, Inc. ("IGWA"), through its counsel Givens Pursley LLP and on behalf of its ground water district members, Magic Valley Ground Water District ("MVGWD") and North Snake Ground Water District ("NSGWD") (collectively the "Ground Water Districts"), hereby supplements its June 14, 2005 and June 17, 2005 Responses ("Responses") to Director's June 7, 2005 *Order Regarding IGWA's Replacement Water Plan* ("June 7 Order") in this matter with the attached documentation of additional measures—including voluntary curtailments and conversions of primary ground water use to surface water irrigation—that the Ground Water District's irrigator members have undertaken to implement IGWA's Replacement Water Plan in this matter.

As soon as it is available, IGWA expects to submit an analysis from its consultant, Dr. Charles Brendecke, describing the hydrological effects of these measures in terms of increased steady-state reach gains to springs in the Devil's Washbowl to Buhl Reach. In the meantime, IGWA wants the Director to have the supplemental information so that he and his staff may begin analyzing it as soon as possible.

IGWA further anticipates that this information will be considered in connection with the separate delivery call filed by Clear Springs Foods, Inc.


