**SCHEDULING ORDER
(Blue Lakes Delivery Call)**

On August 16, 2005, the Director of the Department of Water Resources (“Director” or “Department”) conducted a status and scheduling conference in the above captioned matter.

During the status and scheduling conference, the Director stated that the Department would provide a partial agency record on CD-ROM to the parties. The Director also stated his preference to schedule a hearing in the above captioned matter by March 2006. While discussing the time frame for the hearing, it was suggested that the parties have an opportunity to review the partial agency record before committing to a hearing date and prehearing schedule.

Served with this Order is a copy of the partial agency record in this matter contained on one CD-ROM disk.

ORDER

Based upon the foregoing, IT IS HEREBY ORDERED as follows:

On October 25, 2005, after opportunity to review the partial agency record, the parties shall appear at the Department at 10:00 a.m. for a status and scheduling conference. The parties must be prepared to address the following:

- (a) Identify the issues they anticipate raising at the hearing to be conducted in this matter;
- (b) Present proposed prehearing schedules identifying time limits to file and hear motions, complete any authorized discovery, simplify issues, identify witnesses, exchange exhibits, hold a final prehearing conference, and address other matters as appropriate;
- (c) Identify dates and an estimated length of time for the hearing;
- (d) Address the potential for utilizing evidence taken at hearing in multiple related proceedings;

- (e) Address ways to avoid unnecessary proof and submission of cumulative evidence;
and
- (f) Such other matters as will expedite the disposition of the case.

The parties are encouraged to coordinate prehearing schedules prior to the conference.


