RE: Order Reaffirming Curtailment of Ground Water Rights Junior to July 13, 1962 and Not Covered by an Approved Mitigation Plan – Rangen Delivery Call

Dear Water User:

On March 13, 2020, the Idaho Department of Water Resources (“Department”) sent you a *Notice of Pending Curtailment of Ground Water Rights with Priority Dates Junior to July 13, 1962 and Not Included in a Mitigation Plan – Rangen Delivery Call*. That notice advised you that the Department would initiate curtailment of the above referenced ground water right(s) after twenty-one (21) days of issuing the notice unless you could prove the rights are covered by an approved mitigation plan or that you are a participant in good standing with one of the local ground water districts that have an approved mitigation plan. Neither the Department nor the Water District 130 (“WD130”) watermaster has received verification from you that the above referenced water rights are covered by an approved mitigation plan or that you are a participant in good standing with one of the local ground water districts that have an approved mitigation plan.

The enclosed curtailment order requires that, at 12:01 a.m. on or before May 13, 2020, holders of ground water rights bearing priority dates junior to July 13, 1962, within WD130 and listed in Attachment A to the order, must cease diversion and use of ground water pursuant to those water rights unless notified by the Department that the curtailment order has been modified or rescinded as to its applicability to their water rights. The enclosed curtailment order also requires the WD130 watermaster to send written notice to the holders of water rights listed in Attachment A to the order that their rights will be curtailed in accordance with the terms of the order. With this letter, WD130 is serving you notice that the above referenced water right(s) listed in Attachment A to the enclosed order are curtailed in accordance with the terms of the order.

By May 13, 2020, I or other staff from WD130 will contact you to confirm that you have ceased diversions from your well(s) that supply ground water to the curtailed junior water

right(s). You must demonstrate that required curtailment will occur and will remain in effect, and that any ongoing diversions are: 1) occurring entirely under senior water rights, 2) are non-consumptive, OR 3) are within statutory deferrable limits. In-house culinary uses of water will not be subject to curtailment. In-house culinary uses and the use of water for stock water as defined by Idaho Code § 42-1401A(11) and domestic purposes as defined by Idaho Code § 42-111 (see attachment) are not subject to curtailment.
