
On May 10, 2010, a hearing and status conference was held at the request of Petitioners, North Side and Twin Falls Canal Companies on their Motion for Clarification Regarding Procedural Standing of Protest and Request for Status Conference. At the hearing and status conference the Petitioners were represented by Shelly M. Davis of the law firm Barker Rosholt & Simpson, LLP, the Intervenors, Idaho Water Resource Board, were represented by Michal Gilmore of the Attorney General's office for the State of Idaho, the Upper Snake Ground Water Users and Ground Water Districts were represented by Rob Harris of Holden Kidwell Hahn & Crapo, PLLC, and Candace McHugh of Racine Olson Nye Budge & Bailey, Chtd., respectively, and the Idaho Department of Water Resources was represented by Garrick Baxter.

Counsel for the Petitioners requested that the Hearing Officer amend its Opinion and Order Granting Motions for Summary Judgment and Recommendation, to clarify that the Recommended Order is interlocutory in nature in conformance with IDAPA Rule 37.01.01.710. The Hearing Officer hereby GRANTS this Motion. There are additional matters still pending before the Hearing Officer in this matter and therefore, the proceedings relating to the Recommended Order issued April 29, 2010, including the filing of Petitions for Reconsideration of the Hearing Officer's Recommended Order granting the motions for summary judgment are stayed until this matter has been fully resolved after hearing, submission of post-hearing briefing, and after the Hearing Officer has entered his Recommended Order on all proceedings in the License Protest action.

Further, the Petitioners represent that the additional issues to be resolved in this matter include the Petitioners protest of the term limit condition, and volumetric limitation included in the License issued in October, 2008. Petitioners will not attempt to re-open or re-argue the subordination issue disposed of by the Hearing Officer pursuant to the Recommended Order issued April 29, 2010, during the hearing. Therefore, a hearing on the remaining protested license terms and conditions will be held June 2-3, 2010, beginning at 9:00 a.m., at the Idaho Department of Water Resources located at 322 E. Front Street, Boise, Idaho. All Intervenors to this action have agreed that they will not participate in the hearing to be held on the remaining protested issues, as their intervention was limited to the issue of the subordination condition already ruled upon by the Hearing Officer. Intervenors shall have the right to challenge matters relating to the subordination condition as those issues may be subject to reconsideration or appeal after final determination on all matters.

The Petitioners will produce any exhibits, witness lists, and pre-hearing memoranda to the Hearing Officer on or before May 26, 2010. The Idaho Department of Water Resources will submit pre-filed testimony of Shelley Keen on or before May 26, 2010. The Hearing Officer will set a deadline for submission of post-hearing briefing at the conclusion of the Hearing.
