MODIFYING AREA BOUNDARY

ORDER

WHEREAS, Under the provisions of Idaho Code Sections 42-226 to 42-239, the State Reclamation Engineer, on July 23, 1963, designated the following described area as a "CRITICAL GROUND WATER AREA""

Beginning at a point on the southerly boundary of the Burley Irrigation District on the line common to Ranges 24 and 25 East; thence South on said range line to the westerly boundary of Marsh Creek drainage; thence southerly on said westerly boundary to Harrison Mountain; thence southerly on the westerly boundary of Raft River drainage to the south line of the State of Idaho; thence east on said south line to a point on the easterly boundary of Raft River drainage; thence northerly along said easterly boundary to the Snake River; thence westerly along Snake River to the easterly line of the Burley Irrigation District; thence southerly and westerly along the boundary of said District to the point of beginning.

and,

WHEREAS, by subsequent order dated August 2, 1965, the State Reclamation Engineer modified said "Critical Ground Water Area" by excluding therefrom the following described area.

Beginning at a point on the east boundary line of Section 36, T. 10 S., R. 24 E., common to the boundary of the Burley Irrigation District and the range line between Ranges 24 and 25 E.; thence south along said range line to the SW corner Sec. 7, T. 11 S., R. 25 E., thence easterly to the SE corner Sec. 12, T. 11 S., R. 25 E., thence northerly to the northeast corner of Sec. 24, T. 10 S., R. 25 E., thence easterly through the center of T. 10 S., R. 26 E., to the northeast corner of Sec. 24, T. 10 S., R. 26 E., thence northerly following the range line common to R. 26 and R. 27 E., to an intersection with the township line common to T. 9 and 10 S., thence easterly along said township line to the southeast corner Section 33, T. 9 S., R. 28 E., which is also a point on the Cassia-Power County line; thence following said county line northerly

to the Snake River; thence following Snake River vesterly to its intersection with the easterly boundary of the Burley Irrigation District; thence southerly along said Burley Irrigation District boundary to the point of beginning.

and.

WHEREAS, Pursuant to Notice published in the Burley Herald Bulletin on August 24, 1966, a hearing was held at Albion, Idaho, on September 14, 1966, as a result of which it appears that the Marsh Creek Drainage or the "Albion Basin" should also be removed from the designated "Critical Ground Water Basin"

NOW, THEREFORE, It Is Hereby Ordered, that the following described area is removed from the "Raft River Critical Ground Water Area".

Beginning at the SW corner of Section 7, T. 11 S., R. 25 E., B. M.; thence South along the range line between Range 24 E and Range 25 E., to the westerly boundary of the Marsh Creek drainage; thence southerly along said westerly boundary to Harrison Mountain; thence easterly on the drainage divide between Marsh Creek and Cassia Creek to the easterly boundary of the Marsh Creek drainage; thence northerly along said easterly boundary to the section line which is two miles south of the township line between Township 10 South and 11 South; thence westerly to point of beginning, which area is commonly referred to as the "Albion Basin".

AND, IT IS FURTHER ORDERED, That this modification of the boundary of the Raft River Critical Ground Water Area shall be effective at 8:00 A. M., Monday, September 19, 1966.
