COME NOW Gene D. Fredericksen and Judi K. Fredericksen, the lawful holders of water rights **36-07359**, and petition for hearing as follows:

1. Petitioners are aggrieved by the *Order* dated February 25, 2004;
2. The basis of such *Order* is arbitrary and is not based on real or scientific facts;
3. Such *Order* is based on speculation and conjecture, without showing or proof that a ground water well located ten, fifteen, twenty or more miles away could or would affect or relate to Rangen's water rights numbers 36-15501, 36-02551, 36-07694, or any other alleged 'spring flow' rights of other permit holders;
4. Such *Order* defies the principles of equity and law;
5. Even if water rights numbers 36-15501, 36-02551, 36-07694 are "first in time", there is no indication the water claim has been applied to a beneficial use, i.e. how much used and how much wasted;
6. There is no indication if the Rangen right is a waste water right or a ground water right;
7. The economic impact of the *Order* would not only devastate the economy of Southern Idaho but would negatively impact the entire State of Idaho;
8. Most ground water pumpers who pump ground water for their crops have been true conservationists, resorting to water savings techniques and management practices to lessen waste. The *Order* penalizes conservation of water and good farm management practices;

9. We find it hard to believe that a water right acquired in 1962, used for other than crop growing purposes, would not have increased its consumption in light of increased population and technology;

10. We have consistently used less than our allocated rights in our effort to conserve water.

WHEREFORE, Petitioners hereby contest the action to be taken by virtue of said *Order* and request a hearing.

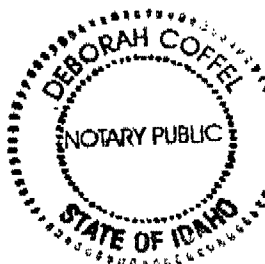
