NOTICE OF WITHDRAWAL OF
PROTEST TO IMAP AND RESPONSE
TO NOTICE OF PARTICIPATION**

The U.S. Bureau of Reclamation hereby notifies the Idaho Department of Water Resources that it withdraws its protest in the above-captioned proceeding. In withdrawing its protest, Reclamation reserves the right to protect its water rights from injury in a delivery call or other proceeding of any kind made by or involving United Water Idaho, Inc. and its water rights.

Reclamation's withdrawal of protest is based on its understanding that the remaining issues, as represented by United Water Idaho, Inc, are limited to securing alternative points of diversion with appropriate protective conditions and quantifying its "reasonably anticipated future needs" over a 50-year planning horizon to protect its water rights from forfeiture. Reclamation has no objection to how these issues are resolved. Reclamation reserves the right to

intervene in these proceedings in the event the scope of issues is expanded in a manner that potentially undermines Reclamation's ability to protect project water rights.
