At the October 16, 2012 status conference, the Director (“Director”) of the Idaho Department of Water Resources (“Department”) established a schedule for parties to submit responses to the matters raised during the Status Conference including recent documents filed by United Water Idaho, Pioneer Irrigation District and the Boise Project Board of Control. Additionally the Director asked for parties to submit information setting out their position on a number of preliminary issues that will need to be addressed for the contested case to proceed forward.


I. All initial statements addressing the following matters shall be submitted no later than **October 31, 2012**:

- 1) Matters raised at Status Conference including recent documents submitted by the parties;
- 2) Scope of the Hearing;
- 3) Scope of Responsibilities of the Parties;
- 4) Scope of Discovery;
- 5) Timetable for Discovery and Hearing

II. All responses to the initial statements shall be submitted no later than **November 14, 2012**.

III. All replies to the responses shall be submitted no later than **November 21, 2012**.

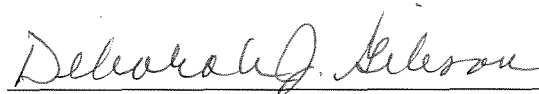
