COME NOW A & B Irrigation District, American Falls Reservoir District #2, Burley Irrigation District, Milner Irrigation District, Minidoka Irrigation District, North Side Canal Company, Twin Falls Canal Company, and the Bureau of Reclamation, Department of the Interior of United States of America, and jointly move that the Director amend his *Scheduling Order* of July 22, 2005 in the following respects, to-wit:

1. Paragraph 5 of the *Scheduling Order* by changing the date for submittal of expert witness reports from October 17, 2005 to November 4, 2005.

2. Paragraph 6 of the *Scheduling Order* by changing the date for submittal of rebuttal expert opinions from October 31, 2005 to November 18, 2005.

3. Paragraph 7 of the *Scheduling Order* by changing the deadline for all dispositive motions from November 7, 2005 to December 2, 2005.

4. Paragraph 8 of the *Scheduling Order* by changing the deadline for responses to all dispositive motions from November 21, 2005 to December 16, 2005.

5. Paragraph 9 of the *Scheduling Order* by changing the deadline for replies to responses to all dispositive motions from December 5, 2005 to January 3, 2006.

This joint motion is made on the grounds and for the reasons that additional time is needed for the preparation and submission of expert witness reports, which also requires that the time for filing rebuttal expert opinions, dispositive motions, and responses and replies to said motions also to be extended.




