**STIPULATED MOTION FOR
HEARING SCHEDULE / RESOLUTION
OF IGWA AND POCATELO MOTION
REGARDING PRE-FILED
TESTIMONY AND EXHIBITS

The parties hereto jointly move the Director of the Idaho Department of Water Resources, pursuant to Rule 26(c) of the Idaho Rules of Civil Procedure, and IDAPA 37.01.01.532 to enter an order adopting the following schedule stipulated to by the parties with respect to the hearing on the Director's *May 2, 2005 Amended Order*. This motion further addresses the *Motion for Order Requiring Prepared Testimony and Exhibits* filed by IGWA and Pocatello on May 31, 2007. As this is a stipulated motion, no oral argument or hearing is requested.

Proposed Hearing Schedule:

August 22--deadline for updating expert reports previously disclosed.

August 22 – deadline for pre-filed direct testimony (required for retained consultants / optional for others), and all exhibits to be used at hearing with experts.

October 3 – deadline for rebuttal reports.

October 3 – deadline for pre-filed rebuttal testimony and all exhibits to be used in rebuttal.

October 17 – disclose all lay witnesses / identify all exhibits to be used at hearing with lay witnesses (as well as any pre-filed direct testimony for lay witnesses).¹

November 1 – deposition deadline / discovery completed deadline.

November 15 – written opening brief / trial brief (if desired).

November 16 – pre-hearing conference and hearing on pre-hearing motions.

November 28 – Hearing Commences (with expected hearing to run through December 18 if necessary).


Pre-Filed Testimony:




