SCHEDULING ORDER

On December 5, 2013 the Director (“Director”) of the Idaho Department of Water Resources (“IDWR”) held a status conference in the above referenced matter. The participants in the status conference agreed to the following deadlines:

- January 6, 2014:** Deadline for those entities participating in the status conference to file petitions to intervene.
- January 21, 2014:** Response deadline for petitions to intervene.
- February 7, 2014:** Deadline for filing Statements of Procedural Issues in the matter. The parties’ statements are limited to 5 pages maximum length.

The Director also agreed to have IDWR staff review IDWR files and produce documents related to the American Falls Ground Water Management Area. This information may be found at the following website:


