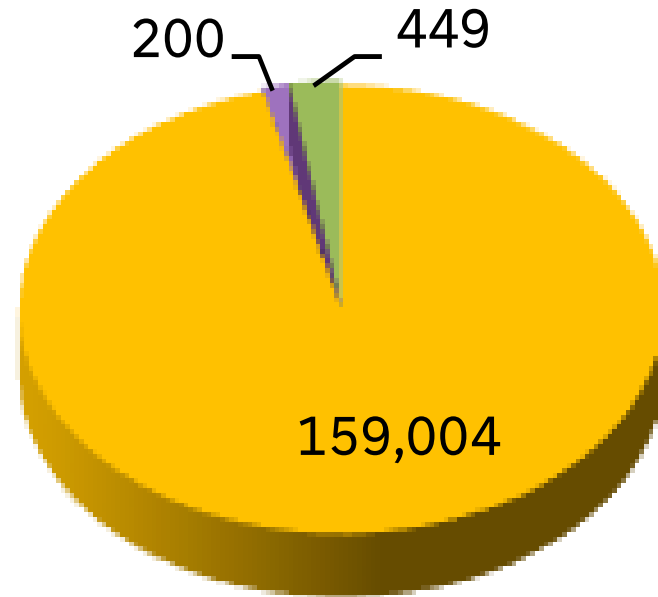

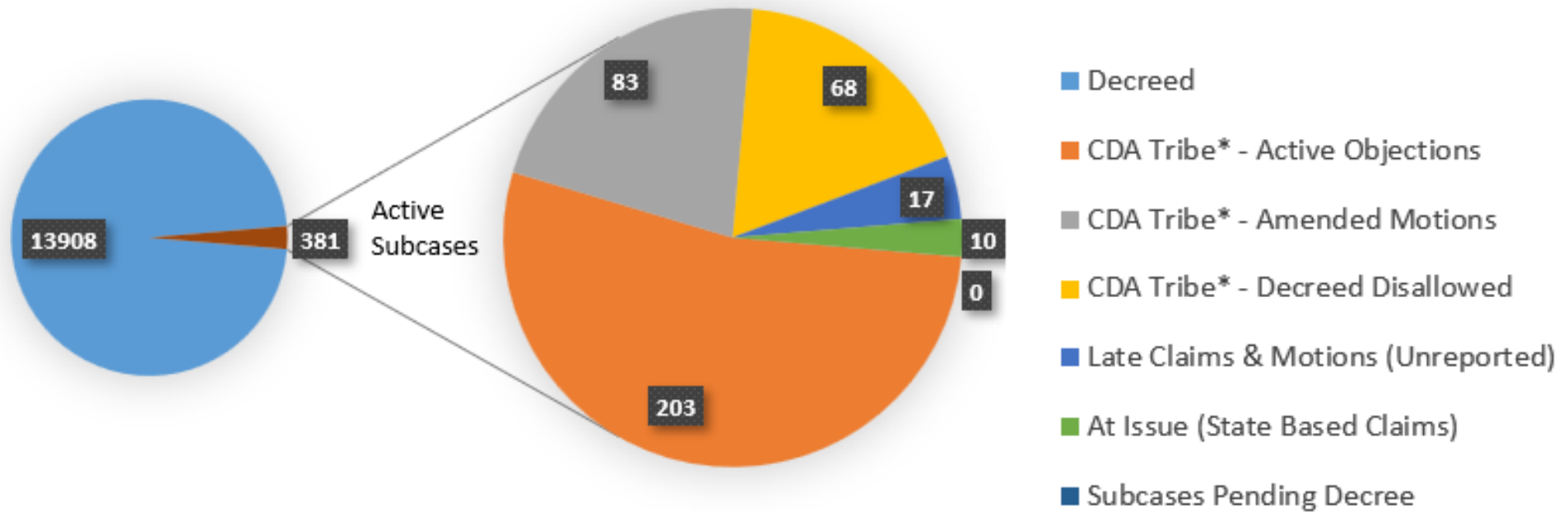

CSRBA FEDERAL RESERVED CLAIMS

On March 5, 2026, the United States, Coeur d'Alene Tribe, State of Idaho, and 15 other signatories executed the Coeur d'Alene Tribe Water Rights Settlement Agreement at a signing ceremony in the Borah Courtroom in Boise.

The Settlement Agreement is supported by more than 300 stakeholders who have claims or objections in the CSRBA. The Settlement Agreement fully resolves all the Tribe's federal reserved water rights. The parties have been working toward resolution since the federal reserved claims were filed in 2014.

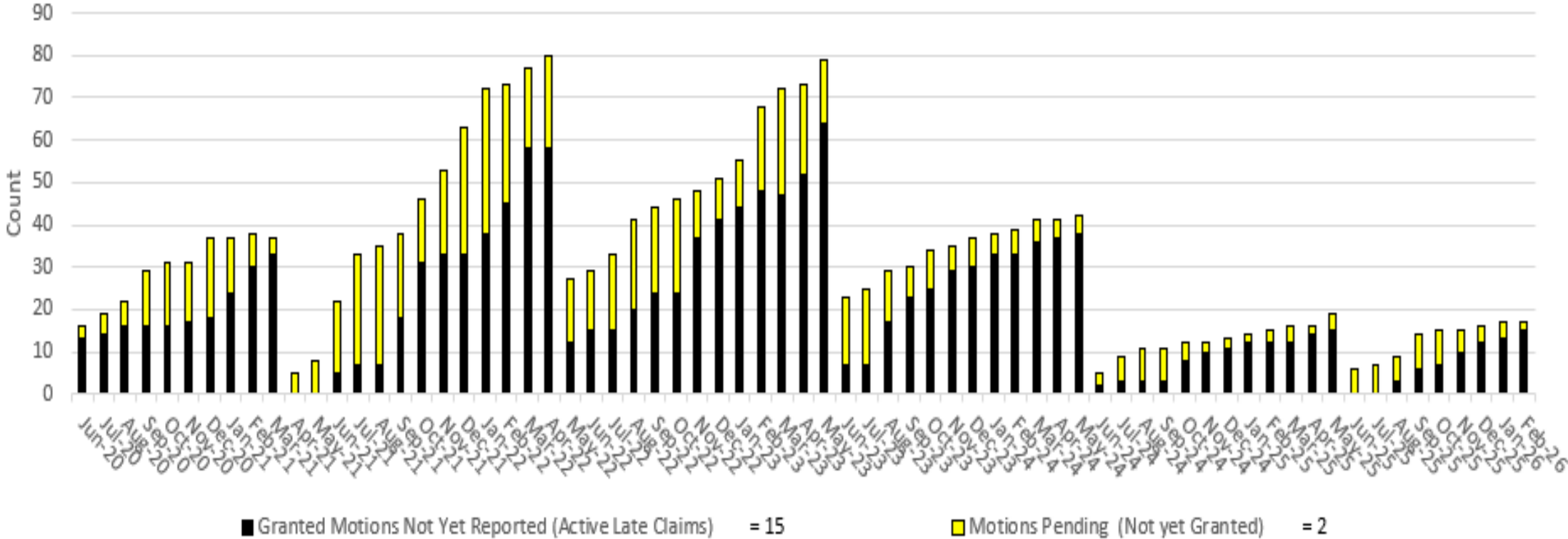
Coeur d'Alene Lake claims

- Next status conference for the state-based lake claims is scheduled for April 1, 2026.

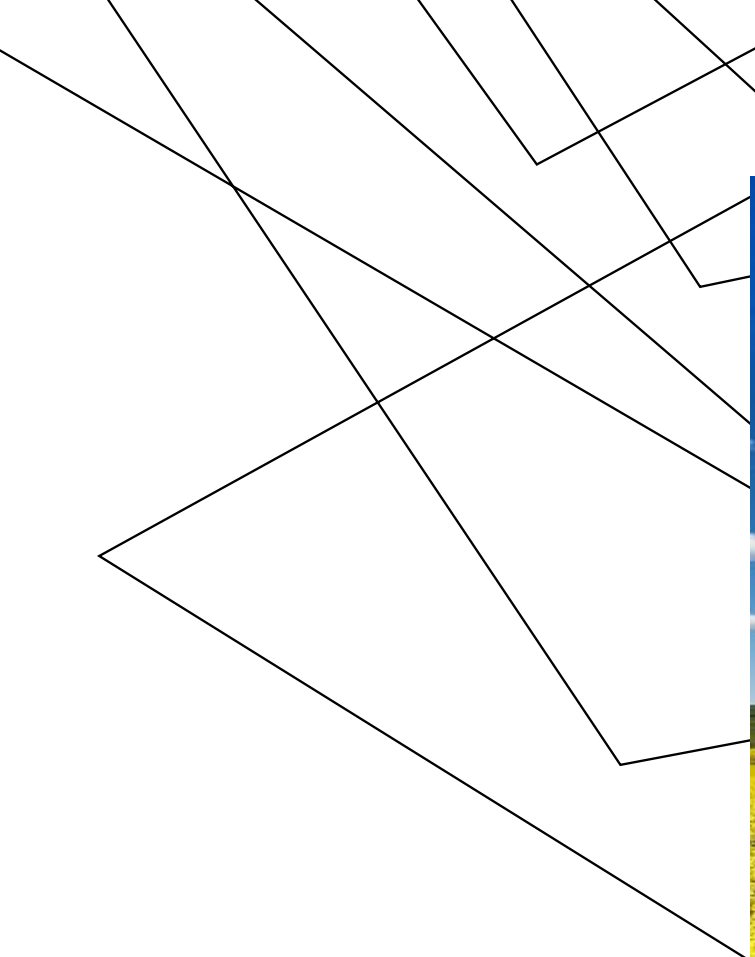

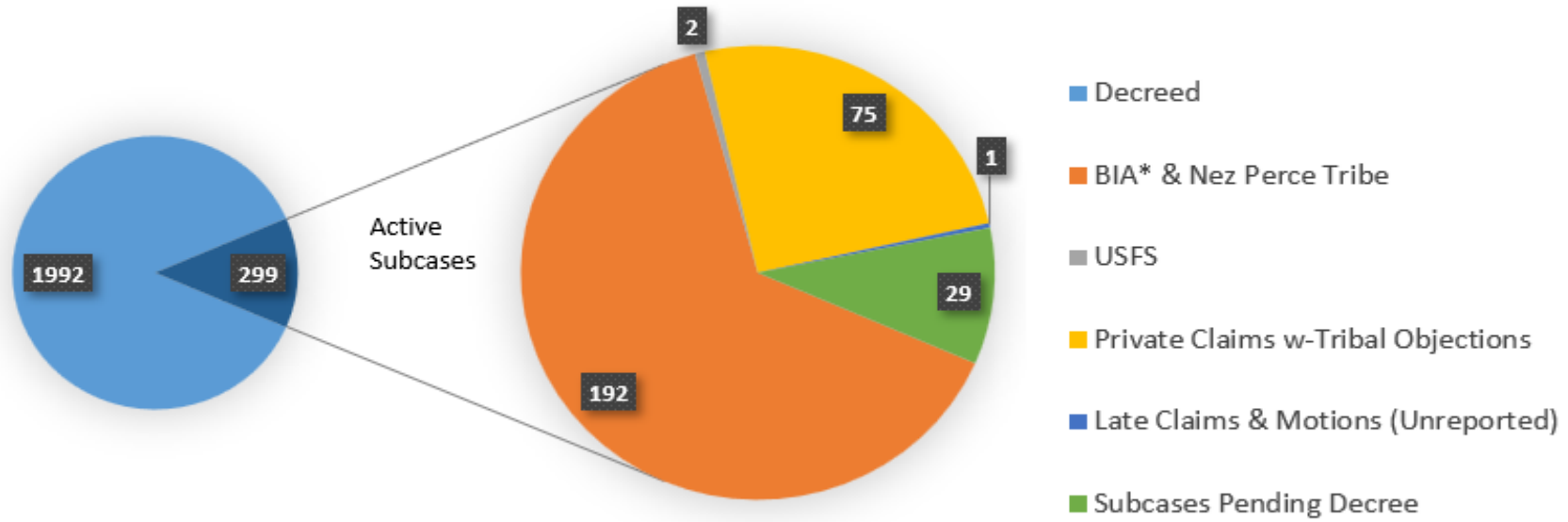

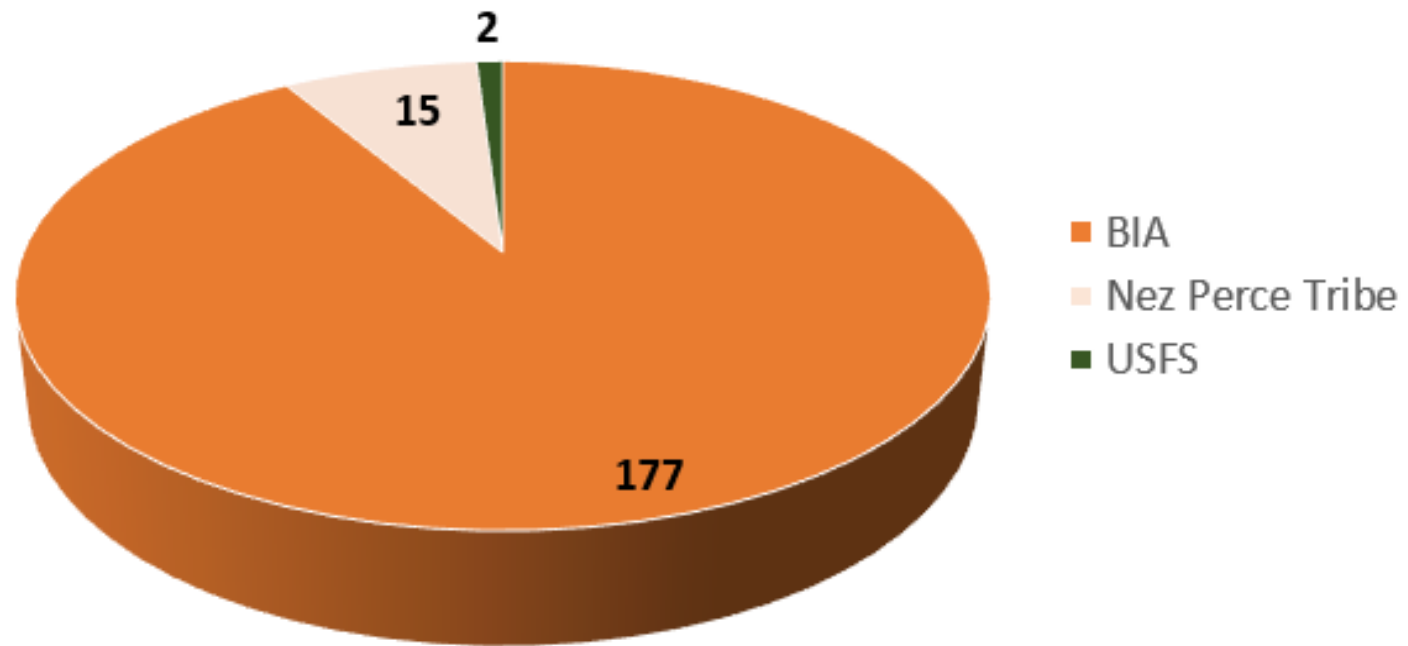

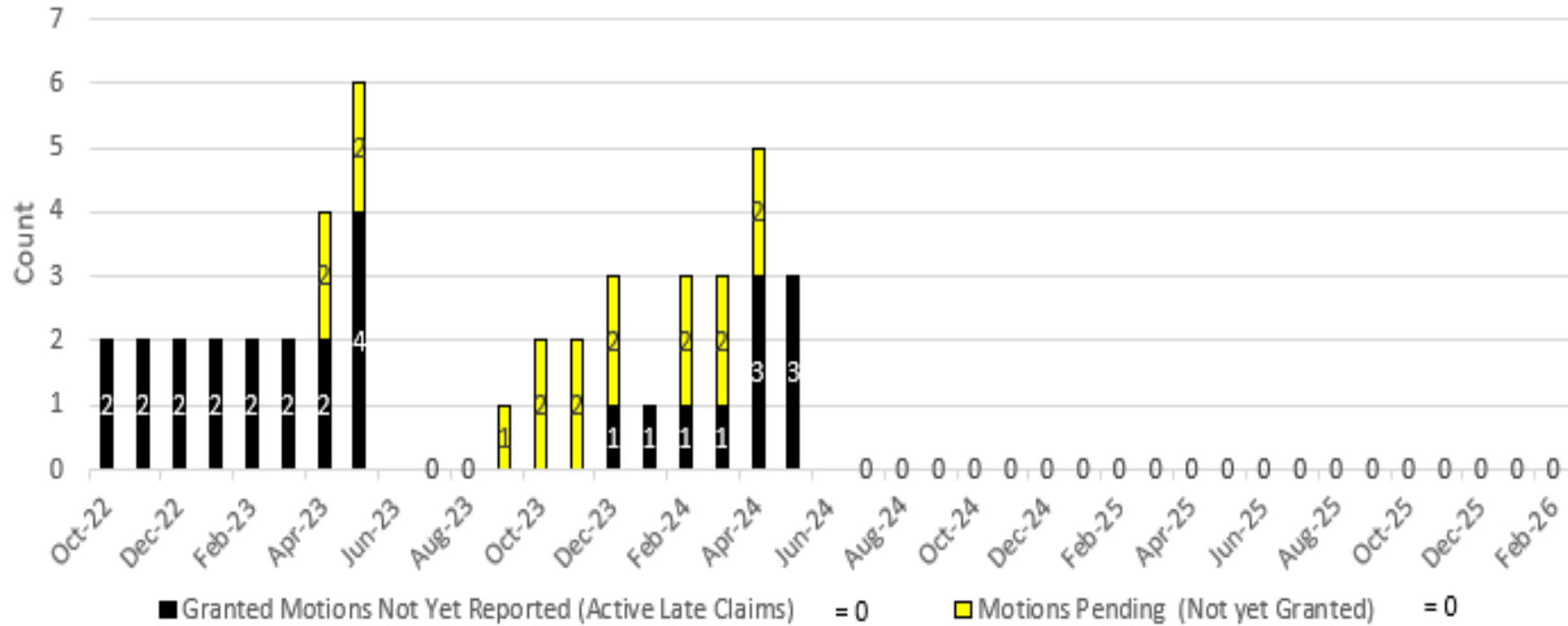

Clark Fork-Pend Oreille River Basin Adjudication (CFPRBA) Status Update



BASIN 97, PART 1

- The Director's Report for Basin 97 Part 1 was mailed on December 17, 2024.
 - Deadline for objections = Ran on May 12, 2025
 - Deadline for responses = Ran on July 28, 2025
 - **Hearing on Uncontested Motions = June 16, 2026**
- There are 1,087 claims pending in the CFRBA
- Next round of Initial Hearings are scheduled for early April



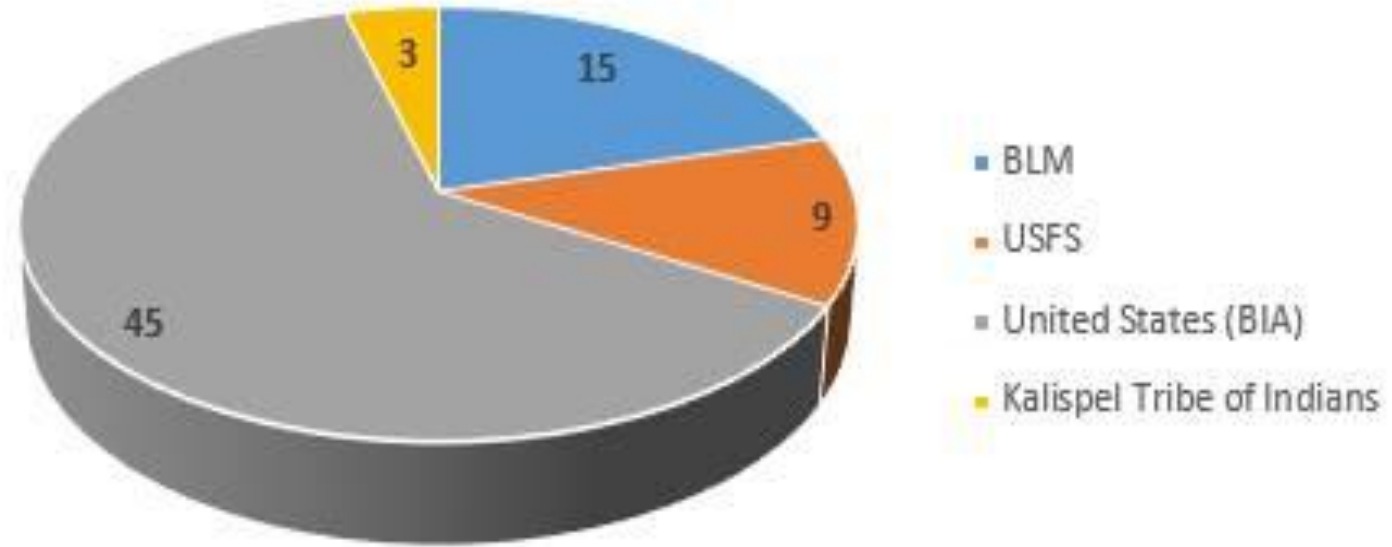
BASIN 97, PART 2

- The Director's Report State-based claims for Basin 97, Part 2 was mailed on January 16, 2026 (995 recommendations)
- Deadline for objections is May 22, 2026.
- Response deadline is July 21, 2026.
- Hearing on Uncontested is scheduled for December 15, 2026.



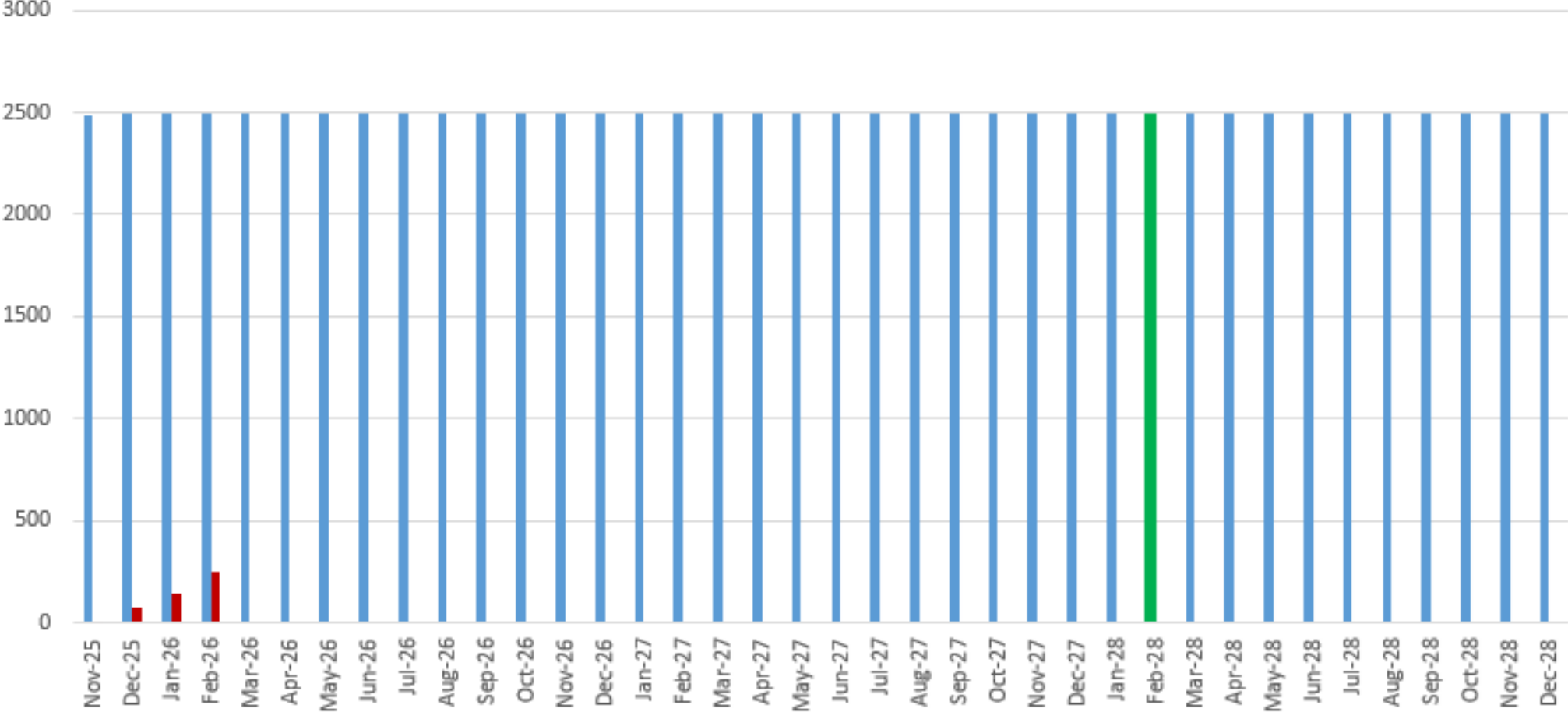

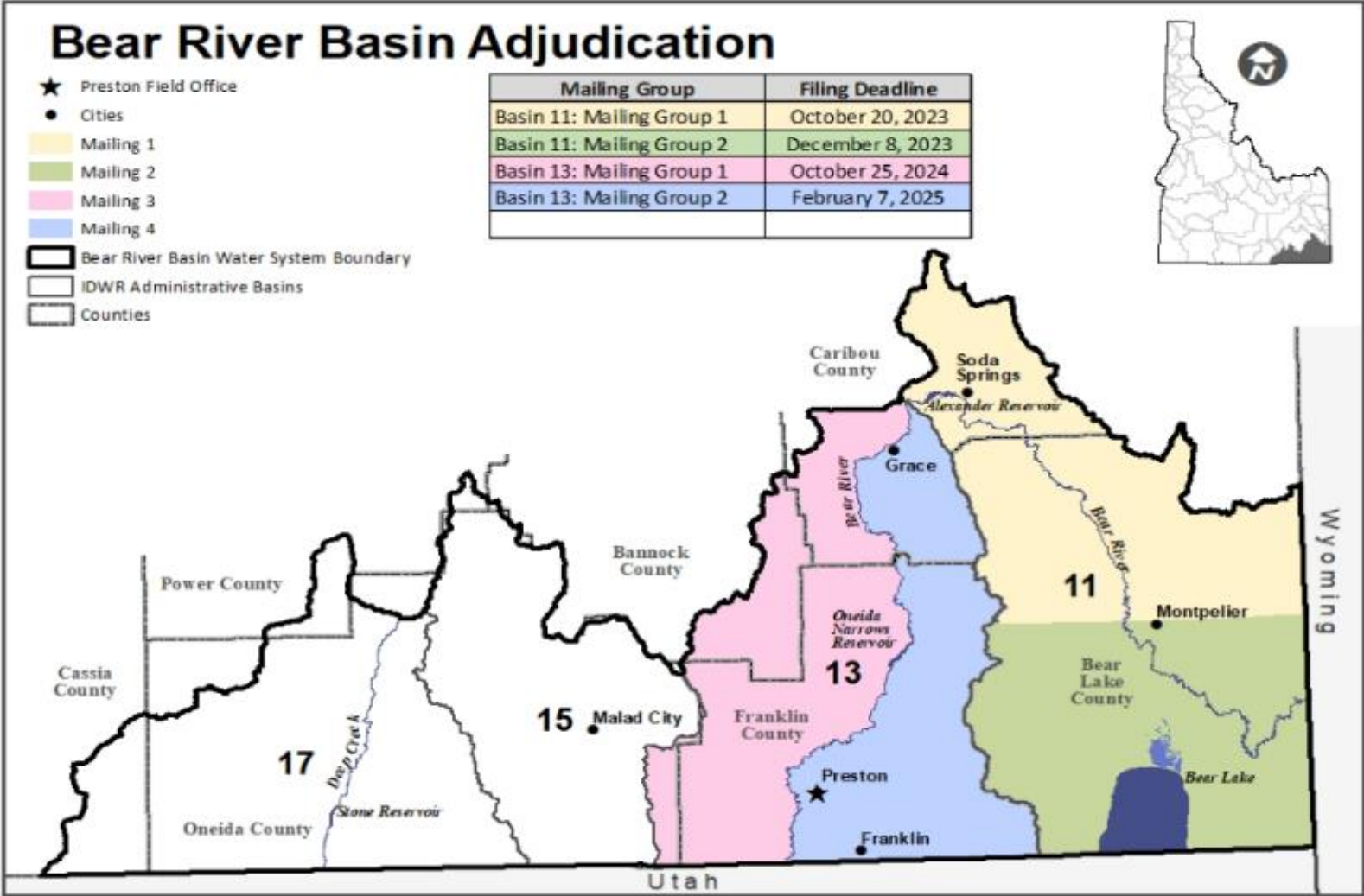
■ B96 Part 1 - Cumulative Total Claims ■ B96 Part 1 - Verified Total Recs (Actual)

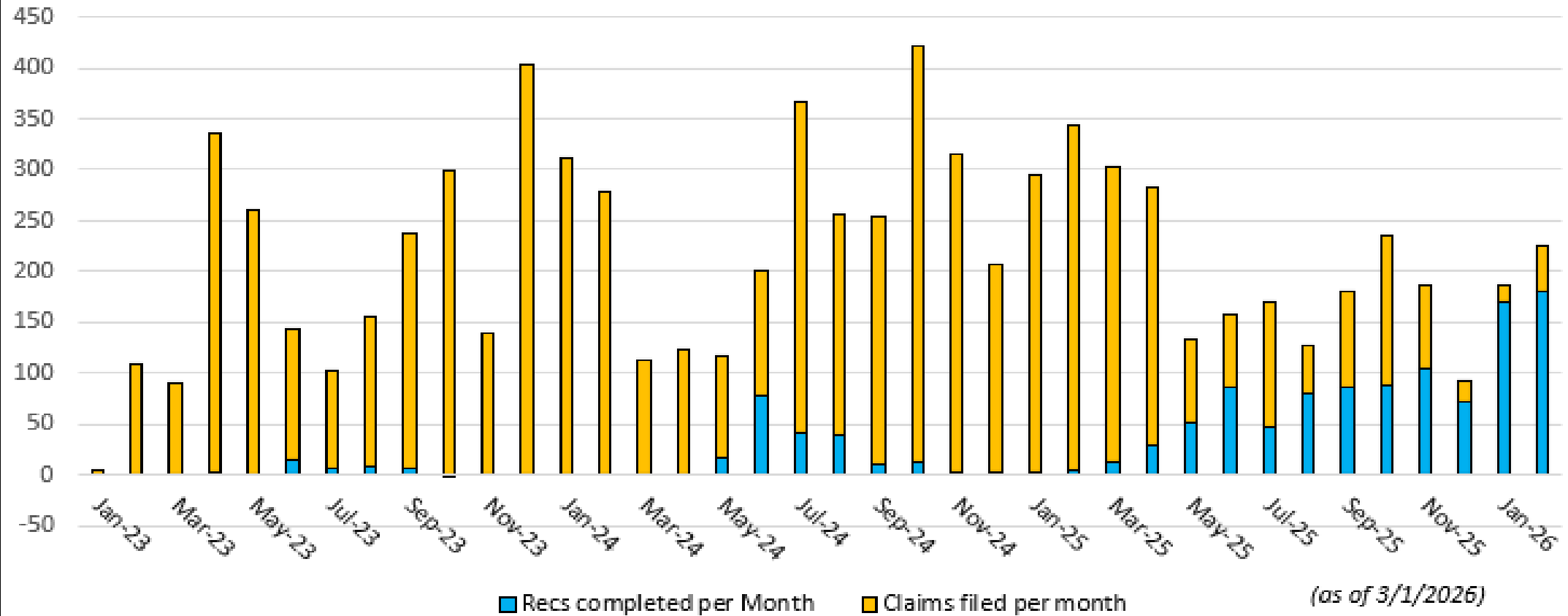

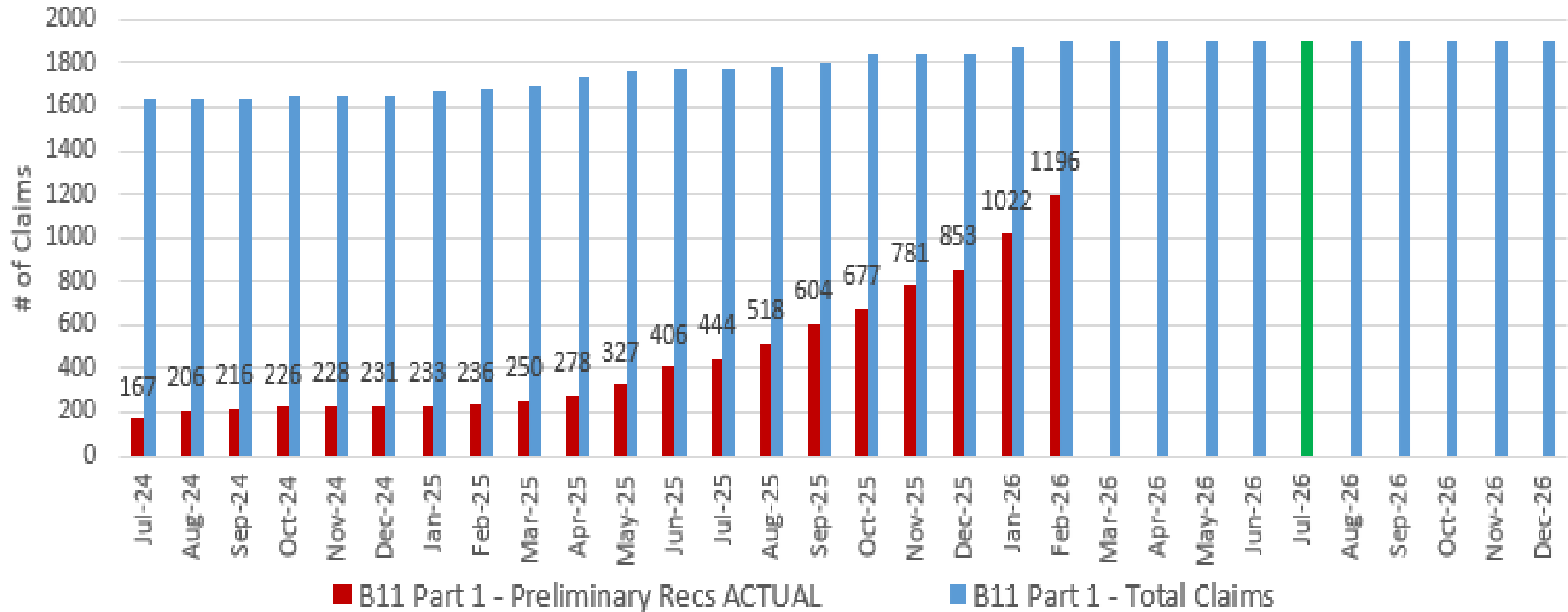

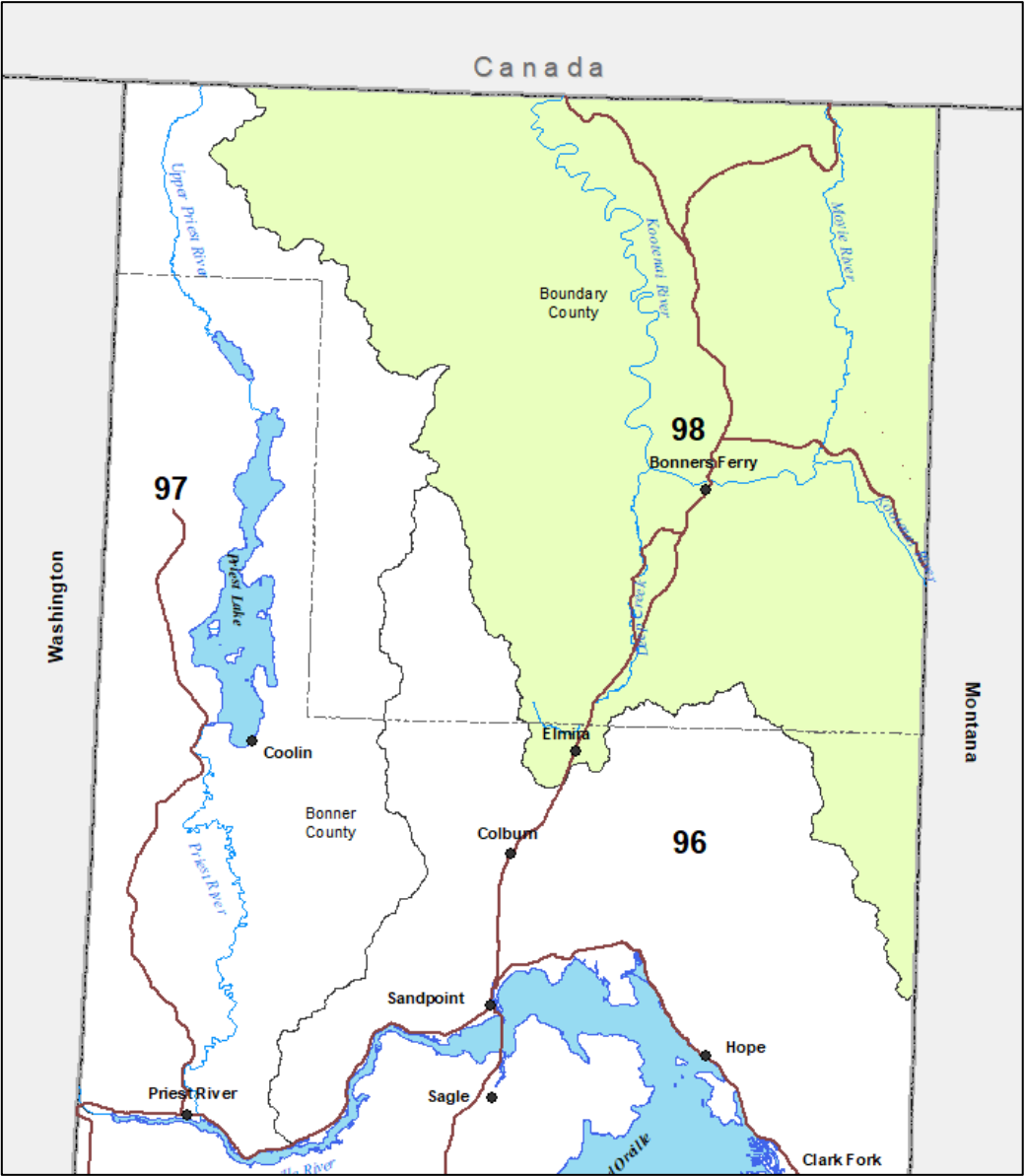

- Commencement Order Issued on March 6, 2026.

UNITED STATES OF AMERICA V. STATE OF IDAHO ET AL., US COURT OF APPEALS FOR THE NINTH CIRCUIT

- The United States challenged the constitutionality of several statutes enacted by the Idaho Legislature following the Idaho Supreme Court's decision in *Joyce Livestock Co. v. US*, 156 P.3d 508 (2007).
- *Memorandum Decision and Order* issued by Chief U.S. District Court Judge, David Nye, on August 28, 2024.
 - The Court concluded §§ 42-222 and 42-224 are constitutional as applied to the US and rejected the US' requests for permanent injunctions under those statutes.
 - The Court granted summary judgment to the US on the following statutes: §§ 42-113(2)(b), 42-502, and 42-504. The Court concluded that the US is entitled to a declaratory judgment that these three statutes violate the Supremacy Clause of the US Constitution. The Court also granted permanent injunction with respect to these three statutes.
- The US District Court issued the Amended Judgment on December 16, 2024 in response to Rule 60(a) Motion.
- Briefing by the parties has been completed.
- Oral argument will be April 14, 2026.



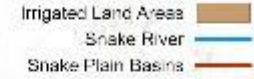

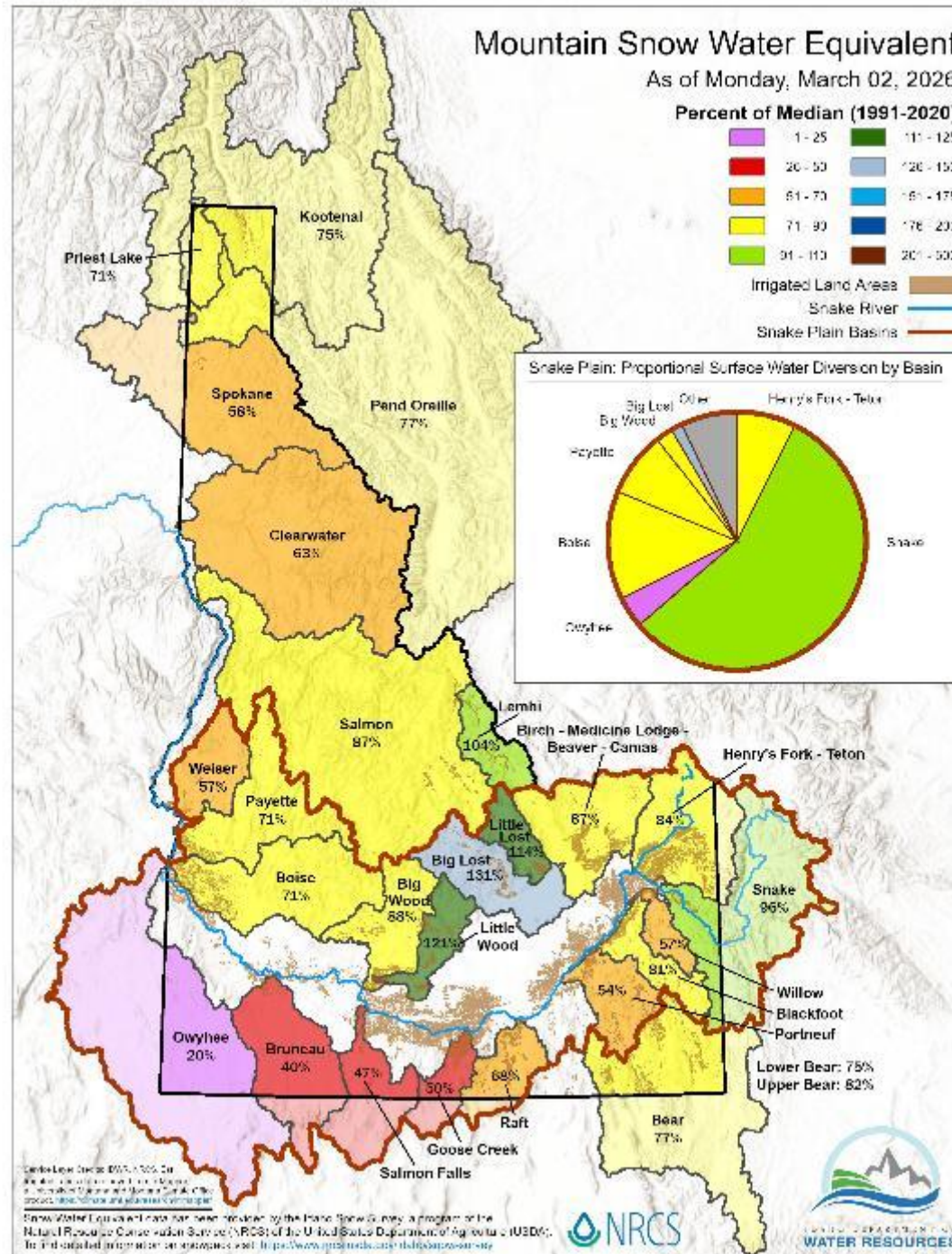
Mountain Snow Water Equivalent
