| Feb. 13, 2026 | Deadline for the parties to complete all depositions |
| Feb. 13, 2026 | Deadline for the parties to complete mediation, if desired. The parties may use any unanimously agreed-upon mediators. |
| Feb. 19, 2026 | Deadline for parties to complete all discovery. |

The remaining deadlines and the hearing date set in the Hearing Officer's November 24, 2025 scheduling order shall remain unchanged and the parties further stipulate to not file any dispositive motions. The parties respectfully request the Hearing Officer to grant this stipulated motion.
