BACKGROUND

On May 28, 2026, Jerry D. Bingham and Valerie H. Bingham (the "Binghams") submitted *Binghams' Fifth Mitigation and Curtailment Plan* ("Mitigation Plan") to the Idaho Department of Water Resources ("Department") pursuant to the Department's Rules for Conjunctive Management of Surface and Ground Water Resources ("CM Rules"), IDAPA 37.03.11.043. Notice of the *Mitigation Plan*, including the June 29, 2026 deadline for filing protests to its approval, was published in accordance with the Department's CM Rules. *See* IDAPA 37.03.11.043.02.

On June 18, 2026, Idaho Ground Water Appropriators, Inc. ("IGWA") filed *IGWA's Notice of Protest* with the Department.

The Director, having determined that informal proceedings are unlikely to resolve this contested case, will set the matter for a prehearing conference and will appoint Roger S. Burdick, former Idaho Supreme Court Chief Justice, to serve as the hearing officer in this matter.

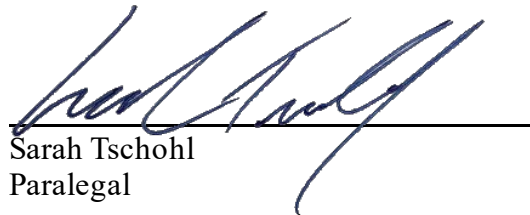
