The parties have fourteen (14) days from the date of this notice to file any objections to the record or transcript. The agency's decision on any objection timely filed along with all evidence, exhibits, and written presentations on the objection shall be determined by the agency within fourteen (14) days and included in the record. If no objections are filed within that time, the record and transcript shall be deemed settled. Subsequently, the agency will lodge the settled record and transcript with the District Court pursuant to I.R.C.P. 84(k), the Court's June 18, 2026 *Procedural Order*, and the Court's July 1, 2026 *Order Granting Extension*.
