**Call to Order:** Meeting was called to order at 11:02 am by Wilder Jones.

**In attendance:** Wilder Jones, Mark Anderson, Paul Batruel, Teresa McCallum, Billy Wolfe, April Wootan and IDWR representatives; Scott King and Izzy Critchton. Greetings and introductions were made by all in attendance.

**Election of Chairperson and Secretary:** 2025 Chairman, Nate Jones, could not be present for today's meeting. Wilder, stepping in for Nate opened up nominations for the 2026 chairperson; Teresa nominated Mark Anderson. Mark voiced his concerns, stating he would help as much as he can but would rather not be the chairman. Mark Anderson nominated, Wilder Jones, 2<sup>nd</sup> by Mark, passed unanimously.

Paul motioned for Teresa to remain as secretary for the current year, Wilder 2<sup>nd</sup>, passed unanimously.

**Reading of 2025 Minutes:** Teresa provided minutes, Mark moved to approve as submitted, 2<sup>nd</sup> by Paul, motion was passed by unanimous consent.

**Watermaster Report:** Wilder provided all members and those also in the meeting a copy of his 2025 report and recap of the past year. Water was ample and abundant for the 2025 year. Both Morrow Reservoir and Blair Trail Reservoir were filled. Water users below the rimrock also enjoyed the robust water year. The replacement of the county bridge on Morrow Reservoir Road over Little Canyon Creek is continuing. Travis Williams is updating irrigation infrastructure on his property. The Anderson Farm has continued using the water bank exchange, pumping from the river. Rusty continues to provide assistant to watermaster when needed. Wilder then expressed he is no longer interested in being the watermaster.

**Treasurer's Report:** Teresa provided a Profit and Loss Statement, December's bank statement, assessment charges and those received page. Stating \$2,457.04 was billed and \$2,133.59 was received. Discussed the amounts of the four individuals that had not paid.

**Proposed Budget:** Teresa proposed a \$2600.00 budget for 2026. Continue with \$1500 for watermaster, \$500 for assistant- watermaster to be used at the watermaster's discretion, \$400 Workmans Comp, and \$200 fuel at \$1.00 per mile. Mark motioned to approve the \$2600 budget, Paul 2<sup>nd</sup>, passed unanimously.

- Teresa made a motion to move bank account from Pioneer Federal Credit Union to Washington Trust Bank in Nampa, Idaho. Teresa explained the frustration of Pioneer closing in Glenns Ferry,

still having issues with moving the signature card and not being able to pay 2025 watermasters. This motion by Teresa was 2<sup>nd</sup> by Mark and passed by unanimous consent.

- Teresa also made a motion for Casa Del Norte to loan Little Canyon Creek Water District 61-D enough funds to pay Wilder and Rusty for their work as watermasters. This loan would 0% interest. Paul 2<sup>nd</sup> this motion made by Teresa and all present passed by unanimous consent.

**Election of Officers:** Watermaster, Assistant Watermaster, Treasurer, and Advisory Committee

Motion by Teresa to have Billy Wolfe serve as watermaster, Jesse Rodriguez as assistant-watermaster, Teresa as Treasurer and Mark, Paul, and Nate serve as the Advisory Committee. 2<sup>nd</sup> by Mark, passed unanimously.

**Adopt Resolutions:** Current Resolutions were provided in packet with agenda, no changes.

**Adjournment:** Wilder motioned to adjourn meeting at 11:29 am. Adjournment to Monday, January 25, 2027 at 11:00 am at the Glens Ferry City Hall, Glens Ferry, Idaho. Paul 2<sup>nd</sup>. Unanimously passed.
