Re: Final Order Requiring Measuring Devices and Controlling Works for Diversions in Water District No. 63, Boise River and Tributaries

Dear Water User,

The Idaho Department of Water Resources ("Department" or "IDWR") has issued the enclosed order requiring installation of measuring devices and controlling works for certain surface water rights within Water District No. 63, Boise River and tributaries. Pursuant to Section 67-5243, Idaho Code, the preliminary order will become a final order without further action of the Department unless a party petitions for reconsideration or files an exception and/or brief as explained in the enclosed information sheet.

Please note that the Final Order contains several important deadlines for the submittal of water measurement plans and installation of measuring devices and controlling works depending on the general location or drainage area of the Boise River water district (see pages 3-4 of the Final Order). Please also note that individual water right diversions from rivers or streams used for irrigation of 5 acres or less and/or a non-irrigation use in which the total rate of diversion is 0.24 cfs or less are exempt from this order unless the water district watermaster determines that such devices are necessary to address water delivery disputes among holders of different priority water rights diverted from the same water source.

Please refer to the enclosed document "*Minimum Acceptable Standards for Open Channel and Closed Conduit Measuring Devices*" for information on types of measuring devices acceptable to IDWR. This document and other information on the topic are available on IDWR's website at the following address:

Owners of surface water diversions who propose to install open channel measuring devices should submit plans that describe the type of device to be installed, including drawings and dimensions. Information must also be included in the plans regarding the type of controlling works that are planned to be installed. Standard screw type head gates or canal gates are the most common type of lockable controlling works installed on open channel or ditch diversions. Pump diversions are commonly controlled through lockable valves or power switches.

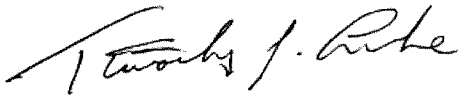
Owners of closed conduit diversion systems (where pipe flows full) are required to install a magnetic flow meter from the list of approved closed conduit flow meters on IDWR's website:

The watermaster plans to contact water right holders and visit individual river/stream diversions to assist water users with development and submittal of measurement plans. The watermaster will begin contacting users on a schedule that is consistent with the measurement plan submittal dates outlined in the attached Final Order. For example, the watermaster will work with users on the South Fork Boise River over the next six to twelve months, the Middle and North Fork Boise River drainages in 12 to 18 months, and the Mores Creek drainage in 18 to 24 months. Adjustments to this general time frame and approach may vary depending on watermaster time and resources, and/or need as expressed by water users from specific water sources. Holders of water rights receiving this Final Order whose diversions are subject to the measurement requirements of the order are encouraged to contact the watermaster, Rex Barrie, and provide him with contact information for each diversion (contact name, address and phone number)

On October 21, 2013, the Idaho Department of Water Resources (“IDWR”) issued a *Preliminary Order* expanding Water District No. 63, the Boise River upstream of Lucky Peak Dam (“Preliminary Order”). Water rights and diversions in the expanded area have not previously been subject to water rights administration or included in a water district for such purposes. Water rights and diversions downstream of Lucky Peak Dam have been administered and measured by Water District 63 for many years.

A primary purpose of a water district is the administration of water rights within the water district by a watermaster. A watermaster administers water rights in part by measuring diversions and adjusting controlling works to deliver the authorized flow rates and/or volumes of water to the holders of water rights in the district.

FINDINGS OF FACT

1. Paragraph five of the Preliminary Order expanding Water District No. 63 stated the following:

The Director shall issue a separate order requiring the installation of measuring devices and controlling works for water right diversions within the expansion area of Water District No. 63. The measuring device order shall be issued some time after the 2014 annual water district meeting to provide some time for the water district advisory committee and other water users to work with IDWR toward developing a reasonable water measurement implementation plan.

2. The annual meeting of the water users of expanded Water District No. 63 was held on January 13, 2014. At the annual meeting, the water users elected a watermaster and selected an advisory committee in accordance with Idaho Code § 42-605.

3. The advisory committee of Water District No. 63 met on May 21, 2014 along with the water district watermaster and IDWR representatives to discuss the issuance and implementation of a measuring device order for diversions in the water district.

5. At the advisory committee meeting on May 21, 2014, the advisory committee recommended a phased approach to compliance with IDWR measurement orders. Specifically, the committee recommended that diversions in the Water District 63 area of expansion be in

compliance over the next several years starting with South Fork Boise River drainage, then proceeding to the Middle and North Fork drainages, and ending with the Mores Creek drainage. The committee further recommended that water right diversions used for irrigation of 5 acres or less and/or for non-irrigation uses in which the total authorized rate of diversion is 0.24 cubic feet per second (cfs) or less should not be subject to measuring device requirements.

CONCLUSIONS OF LAW

1. Idaho Code § 42-701 provides in pertinent part:

42-701 INSTALLATION AND MAINTENANCE OF CONTROLLING WORKS AND MEASURING DEVICES BY WATER APPROPRIATORS – PROCEDURE UPON FAILURE TO INSTALL AND MAINTAIN – MEASURING AND REPORTING OF DIVERSIONS – PENALTY FOR FAILURE TO COMPLY – REPORT FILING FEE.

(1) The appropriators or users of any public waters of the state of Idaho shall maintain to the satisfaction of the director of the department of water resources suitable headgates and controlling works at the point where the water is diverted. Each device shall be of such construction that it can be locked and kept closed by the watermaster or other officer in charge, and shall also be of such construction as to regulate the flow of water at the diversion point. Each such appropriator shall construct and maintain, when required by the director of the department of water resources, a rating flume or other measuring device at such point as is most practical in such canal, ditch, wellhead or pipeline for the purpose of assisting the watermaster or department in determining the amount of water that may be diverted into said canal, ditch, wellhead or pipeline from the stream, well or other source of public water. Plans for such headgates, rating flumes or other measuring devices shall be approved by the department of water resources.

(2) If an appropriator determines that installation and maintenance of a measuring device required by the director would be burdensome for his diversion, the appropriator may, upon approval of the director, execute an agreement with the director and submit to the director such information and technical data concerning the diversion and pumping facilities as the director determines necessary to establish the relationship of power usage to water withdrawal by any pump used to divert public water.

(3) Any appropriator or user of the public waters of the state of Idaho that neglects or refuses to construct or maintain such headgates, controlling works, or measuring devices..., upon receiving ten (10) days' notice from the director of the department of water resources within which to begin and diligently pursue to completion the construction or installation of the required device or devices or to begin and diligently pursue to completion a remedy to such defects as exist in accordance with said notice, then the director of the department of water resources may order the duly qualified and acting watermaster of the water district to shut off and refuse to deliver at the point of diversion, the water owned by such appropriator or user until the user does construct and maintain such headgates, controlling works or measuring devices or remedy the defects which exist or the director may take

action pursuant to section 42-1701B, Idaho Code, to enforce the requirement to construct, install or maintain such devices.

(4) The appropriators or users of the public waters of the state of Idaho shall be given a reasonable time within which to complete construction of such headgates, controlling works or measuring devices, depending upon the size and extent thereof, when due diligence has been used in the prosecution of such work.

2. Measurement and control of diversions is necessary in Water District No. 63 for the proper distribution of water and administration of water rights. Measurement of diversions provides the following administrative benefits:

- i. Provides ability to regulate all diversions within the district to deliver water to the most senior priority rights during times of water scarcity or shortages, thereby protecting senior priority rights.
- ii. Assurance that water rights are used within their authorized diversion limits and provide ability to regulate rights to authorized diversion limits if such limits are exceeded.
- iii. An equitable, defensible and legal means for determining water user assessments since Idaho law requires that the expenses of the water district be based on water delivery.

3. The Director should require the installation of measuring devices and controlling works for diversions of water from the Boise River and tributaries within Water District No. 63.

ORDER

IT IS HEREBY ORDERED AS FOLLOWS:

1. The holders of water rights in Water District No. 63, except those water rights listed in subsection a. below, shall install on each point of diversion from the Boise River or tributaries to the Boise River a measuring device and lockable controlling works or a head gate of a type acceptable to IDWR for the purpose of assisting the water district watermaster in measuring and reporting the amount of water withdrawn from each diversion, and controlling the amount of water at each diversion. Water rights that are exempt from the measuring device requirements of this order are limited to:

- a. Any water right(s) in which the point of diversion¹ is used for irrigation of five (5) acres or less and/or non-irrigation uses in which the total rate of diversion is 0.24 cfs or less, unless the watermaster determines at some future date that measuring devices and controlling works are necessary to address water delivery disputes or conflicts among holders of different priority water rights diverted from the same source of water.

¹ Note: A common point of diversion used for multiple irrigation rights where each individual right is under five acres must be measured and controlled if the sum of the irrigated acres under the rights exceeds five acres. A common point of diversion serving multiple non-irrigation uses must be measured if the total diversion rate is greater than 0.24 cfs.

2. **Prior to the diversion of water for the 2016 irrigation season, acceptable measuring devices shall be installed for all diversions from the South Fork Boise River and tributaries, except those water rights described in Paragraph 1.a. of this Order. Water right holders in the South Fork Boise River drainage shall submit measurement plans to the watermaster for each point of diversion by September 1, 2015.**

3. **Prior to the diversion of water for the 2017 irrigation season, acceptable measuring devices shall be installed for all diversions from the Middle and North Fork Boise Rivers and tributaries, except those water rights described in Paragraph 1.a. of this Order. Water right holders in the Middle and North Fork Boise River drainages shall submit measurement plans to the watermaster for each point of diversion by September 1, 2016.**

4. **Prior to the diversion of water for the 2018 irrigation season, acceptable measuring devices shall be installed for all diversions from Mores Creek and tributaries (Mores Creek drainage), except those water rights described in Paragraph 1.a. of this Order. Water right holders in the Mores Creek drainages shall submit measurement plans to the watermaster for each point of diversion by September 1, 2017.**

5. Diversions in the water district located downstream of Lucky Peak Dam either have acceptable measuring devices and controlling works or are on tributary sources not yet regulated by the watermaster. The watermaster may provide individual notice to other water right holders diverting water from the Boise River or tributaries downstream of Lucky Peak Dam to install or replace measuring devices and controlling works on or before a date specified by the watermaster.

6. Measurement plans required by this order shall be reviewed by the watermaster to determine whether proposed measuring devices and controlling works are of a type acceptable to IDWR, and that the device(s) will be installed according to specifications.

5. Measuring devices that are acceptable to IDWR are listed in IDWR's *Minimum Acceptable Standards for Open Channel and Closed Conduit Measuring Devices* (copy attached). These specifications apply to both irrigation and non-irrigation water uses.

6. Under limited circumstances, a variance of the standard measuring devices listed in IDWR's *Minimum Acceptable Standards for Open Channel and Closed Conduit Measuring Devices* may be considered upon submittal of a written justification and plan to the watermaster. Acceptable variances may include the following methods or devices:

- For diversions from rivers or streams using in-stream electric pumps, development of a Power Consumption Coefficient (PCC), which is a ratio of power usage to water withdrawal. Acceptance of the PCC method may be provided *for qualifying irrigation diversions only*;
- Use of an hour meter (time clock), *for qualifying diversions only, usually in-stream electric pumps*;
- For closed conduit diversions, use of an acceptable non-standard flow meter that was installed *prior to the date of this order*;
- *For irrigation diversions only*, use of an acceptable non-standard flow meter where it can be shown that installation of a standard flow meter would be burdensome.

Requests for variance of the measurement method must be received no later than the applicable Plan Due Date shown in Paragraphs 2 through 4 of this Order, and will be considered by the water district watermaster and IDWR on a case-by-case basis. Variances proposing use of an existing flow meter must meet IDWR criteria and accuracy tests. Existing meters which do not meet standards, or which fail, will be required to be replaced with a magnetic flow meter unless another variance is obtained. The suitability of any pumping plant for approval of an hour meter or the PCC method of measurement will be based on criteria found in the *IDWR ESPA Water Measurement and Reporting Guidelines* (copy available upon request or online at http://www.idwr.idaho.gov/WaterManagement/WaterMeasurement/water_measurement.htm.) The Department may provide guidance to the water district watermaster with respect to variance requests and approvals.

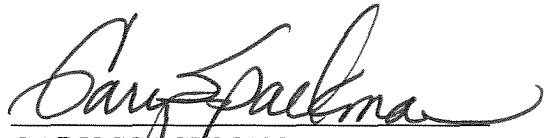
7. In some situations, IDWR may exempt a diversion from the requirements of this order or may allow deferred compliance for a diversion. IDWR will consider each request for exemption or deferral on a case-by-case basis. Conditions that may result in exemption or deferral include, but are not limited to, the following:

- Abandonment, non-use, or consolidation of diversions that results in a diversion being unused, or reduces the total diversion rate to 0.24 cfs or less and/or irrigation of five acres or less.
- Delays caused by requirements of other government entities.

8. This Order shall be effective immediately on any new diversion(s) authorized after the date of this Order, except water right diversions used for irrigation of 5 acres or less and/or for non-irrigation uses in which the total authorized rate of diversion is 0.24 cfs or less unless the watermaster determines at some future date that measuring devices and controlling works are necessary to address water delivery disputes or conflicts among different water right holders from the same water source.

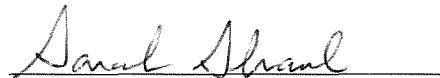
9. The watermaster shall shut off and refuse to deliver water to any diversion that does not have, or who fails to maintain, an adequate measuring device at any and all times following the required installation dates established in this order unless an exemption or deferral has been provided by IDWR.

EXPLANATORY INFORMATION TO ACCOMPANY A FINAL ORDER

(To be used in connection with actions when a hearing was **not** held)

(Required by Rule of Procedure 740.02)

The accompanying order is a "Final Order" issued by the department pursuant to section 67-5246, Idaho Code.

PETITION FOR RECONSIDERATION

Any party may file a petition for reconsideration of a final order within fourteen (14) days of the service date of this order as shown on the certificate of service. **Note: The petition must be received by the Department within this fourteen (14) day period.** The department will act on a petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. See section 67-5246(4), Idaho Code.

REQUEST FOR HEARING

Unless the right to a hearing before the director or the water resource board is otherwise provided by statute, any person who is aggrieved by the action of the director, and who has not previously been afforded an opportunity for a hearing on the matter shall be entitled to a hearing before the director to contest the action. The person shall file with the director, within fifteen (15) days after receipt of written notice of the action issued by the director, or receipt of actual notice, a written petition stating the grounds for contesting the action by the director and requesting a hearing. See section 42-1701A(3), Idaho Code. **Note: The request must be received by the Department within this fifteen (15) day period.**

APPEAL OF FINAL ORDER TO DISTRICT COURT

Pursuant to sections 67-5270 and 67-5272, Idaho Code, any party aggrieved by a final order or orders previously issued in a matter before the department may appeal the final order and all previously issued orders in the matter to district court by filing a petition in the district court of the county in which:

- i. A hearing was held,
- ii. The final agency action was taken,
- iii. The party seeking review of the order resides, or
- iv. The real property or personal property that was the subject of the agency action is located.

The appeal must be filed within twenty-eight (28) days of: a) the service date of the final order, b) the service date of an order denying petition for reconsideration, or c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration, whichever is later. See section 67-5273, Idaho Code. The filing of an appeal to district court does not in itself stay the effectiveness or enforcement of the order under appeal.

**MINIMUM ACCEPTABLE STANDARDS
FOR OPEN CHANNEL AND CLOSED CONDUIT
MEASURING DEVICES**

The source and means of diversion of water, whether surface or ground water, generally affects the selection of a measuring device. Surface water sources such as streams, springs and waste channels are normally diverted into open channels (ditches or canals), but closed conduits (pipes or culverts) are also used. Ground water is usually diverted into pipes (which may also discharge into open channels).

Measuring devices when required by IDWR are to be installed at or near the point of diversion from the public water source.

I. MEASUREMENTS IN OPEN CHANNELS

The following discussion is applicable only to diversions from surface water sources. Measurement of a ground water diversion with an open channel measuring device must be pre-approved by the IDWR.

A. Standard Open Channel Measuring Devices

All open channel surface water diversions should be measured using one of the following standard open channel flow measuring devices commonly used in Idaho:

- **Weirs:** contracted or suppressed rectangular weirs, Cipolletti weir, 90 degree V-notch weir
- **Flumes:** Parshall flume, trapezoidal flume, ramped flume (ramped, broad-crested weir)
- **Submerged Orifices:** submerged rectangular orifice, constant head orifice
- **Acoustic:** acoustic Doppler flow meter (ADFM), acoustic Doppler current profiler

The installed flow rate accuracy of open channel measurement devices must be +/- 10.0% as compared to an acceptable open channel current meter or other standard portable measuring devices such as an acoustic Doppler flow meter or acoustic Doppler current profiler.

Construction, installation and operation of these devices should follow published guidelines, such as those published by the United States Bureau of Reclamation¹

B. Non-standard open channel devices: Rated Structures or Rated Sections

Any weir, flume, or other measuring device that has not been constructed, installed, or maintained correctly and therefore does not measure flow in the standard manner consistent with standard rating tables or curves is considered to be a non-standard device. IDWR may authorize the use of non-standard devices and rated sections provided the device or section is rated or calibrated against a set of flow measurements using an acceptable open channel current meter or standard portable open channel measuring device. Examples of standard portable open channel measuring devices include the acoustic Doppler flow meter, the acoustic Doppler current profiler, or a portable flume. These devices are acceptable provided they are installed and operated according to all relevant manufacturer recommendations.

Further information and requirements are available from IDWR upon request.

II. CLOSED CONDUIT MEASURING DEVICES

The following discussion is applicable to measurement of diversions from any water source that diverts via a full-flowing, closed conduit.

A. Standard Closed Conduit Measuring Devices

A certified meter is required on new installations of measuring devices for closed conduit or pipe line diversions. A certified meter is a model of flow meter that has participated in independent third party testing and has been approved by IDWR for use. IDWR has published a list of meters that have participated in independent third party testing² and have been certified for use where the installation configuration and application meet manufacturer's requirements. Tests were conducted for both accuracy and repeatability on all submitted models, and a pass/fail rating awarded. A list of these meters may be found at:

Owners or operators who install a certified meter without the minimum manufacturer spacing requirements, or otherwise inconsistent with manufacturer's specifications, may need to provide an adequate testing section of straight pipe located somewhere on the diversion system either upstream or downstream of the installed flow meter. This testing section can be excavated pipeline as long as the section of pipe carries all water being measured through the installed flow meter. Water users choosing to expose pipe will be required to excavate the pipe at their expense at the request of the district hydrographer, watermaster and/or IDWR staff.

B. Non-standard Closed Conduit Measuring Devices: Requests for Variance

In some cases, site conditions preclude use of a certified meter, and another meter or method of measurement will produce similarly accurate results. In cases where the user can show that a proposed alternative meter or method would be as accurate as, or otherwise is better suited to an application than any of the meters on the approved list, a user can propose using an alternative meter or method by submitting a Request for Variance Form, available from IDWR. If a request is submitted and granted, the water user bears the risk that the alternative meter or method will perform as expected.

The following alternate measurement methods may be considered:

- Development of a Power Consumption Coefficient (PCC), which is a ratio of power usage to water withdrawal. Acceptance of the PCC method may be provided *for qualifying irrigation diversions only*;
- Use of an hour meter (time clock) *for qualifying diversions only*;
- Use of an acceptable flow meter that was installed *prior to the date of the measurement order*;
- *For irrigation diversions only*, use of an acceptable non-certified flow meter where it can be shown that installation of a certified flow meter would be burdensome or ineffective.

If a meter is already installed, that meter may be used if the meter is field-tested by IDWR staff, the water district watermaster, or a district hydrographer using a portable standard flow meter and upon a determination that the meter is installed properly and accurate to within $\pm 10\%$ of actual rate of flow and volume. If a non-certified meter is approved and installed but does not pass a field check, IDWR may require the water user to replace the meter with a certified meter at the water user's expense.

If an alternative method is approved and that method is later found to be insufficient, the variance will be withdrawn and a certified meter will be required to be installed. The suitability of any pumping station for an hour meter or the PCC method of measurement will be based on criteria found in this document and in the document entitled *IDWR ESPA Water Measurement and Reporting Guidelines*³.

List of Approved Closed Conduit Flow meters

The table below lists flow meters **that have been tested and approved by IDWR for use in closed conduit measurement applications where the installation configuration and application meet manufacturer's requirements for the selected model.** These approved flow meters were subject to testing requirements outlined by IDWR and conducted by staff from Utah State's NIST¹ traceable lab in Logan Utah and performed at or above IDWR minimum acceptable standards for accuracy when installed in piping distances that met or exceeded minimum straight run piping requirements specified by IDWR. The approved list is current as of this printing, but may change as additional models and manufacturers undergo testing and approval. The current version of these standards, including this list, is posted on the IDWR Internet site at the following URL:

Note that not all models are appropriate for every application. Pipe size, available straight pipe lengths, water chemistry, pressure, velocity, environmental exposure, and power requirements are among the factors affecting whether a given meter will perform for a given application. Prior to selecting a meter, consult the manufacturer's installation requirements to assure they can be met.
