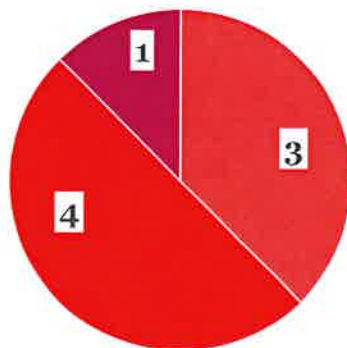

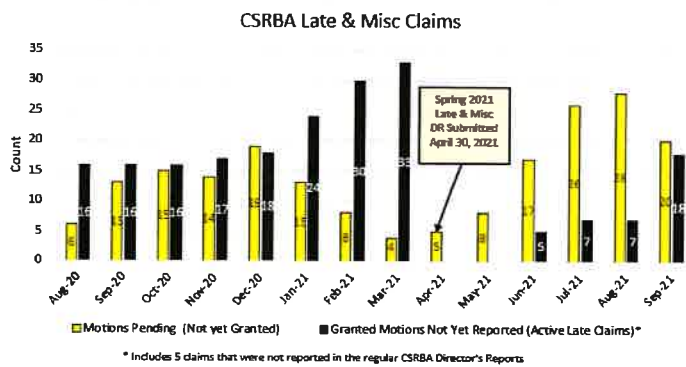

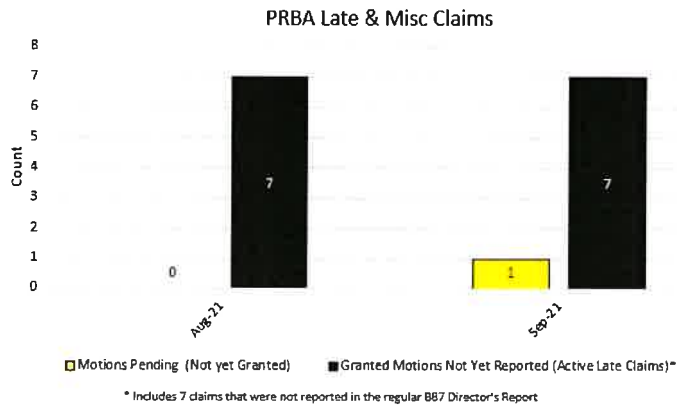
## Summary of Current CSRBA Late Claims

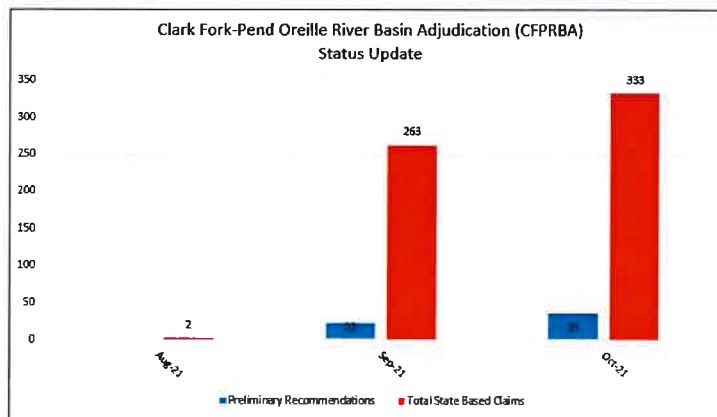
