

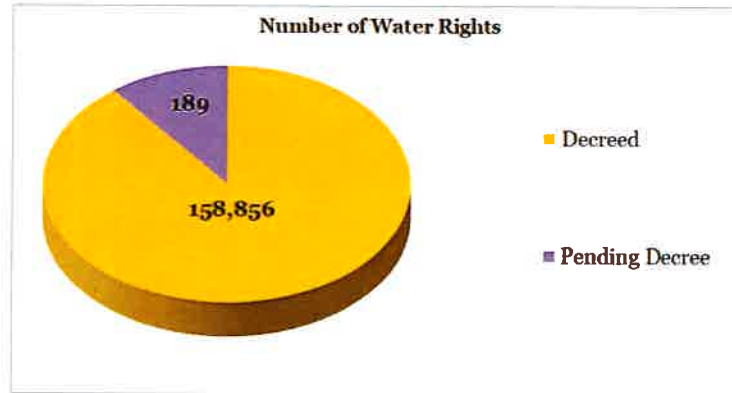

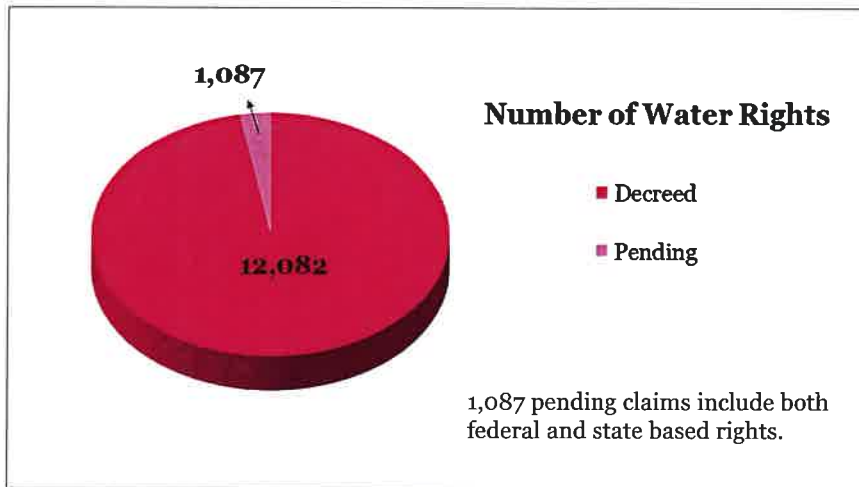

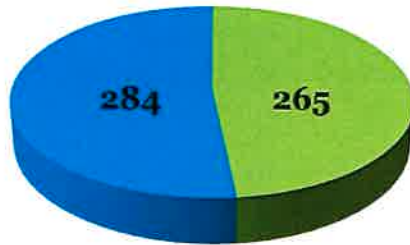

Basins 91-95

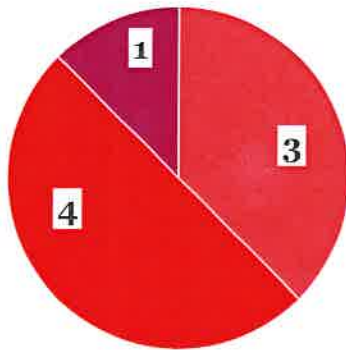

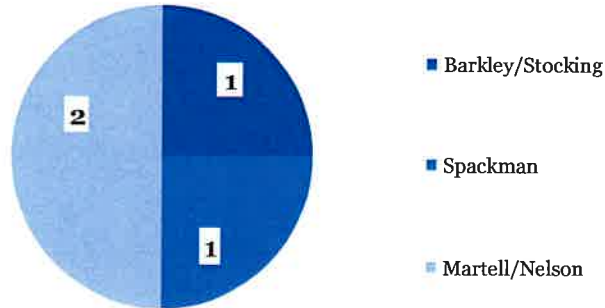

Basin 95 Part 2 – Subcases for Which Objections are Unresolved 8 Objections to 4 Contested Subcases

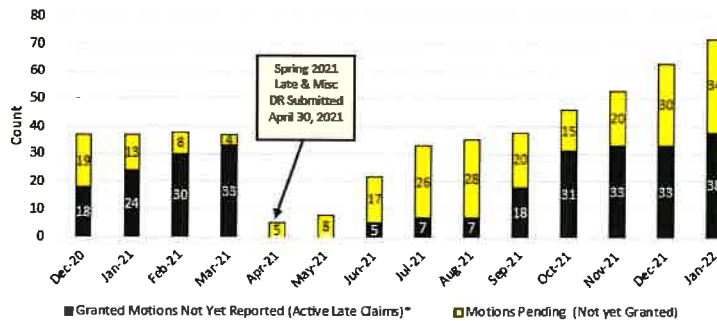

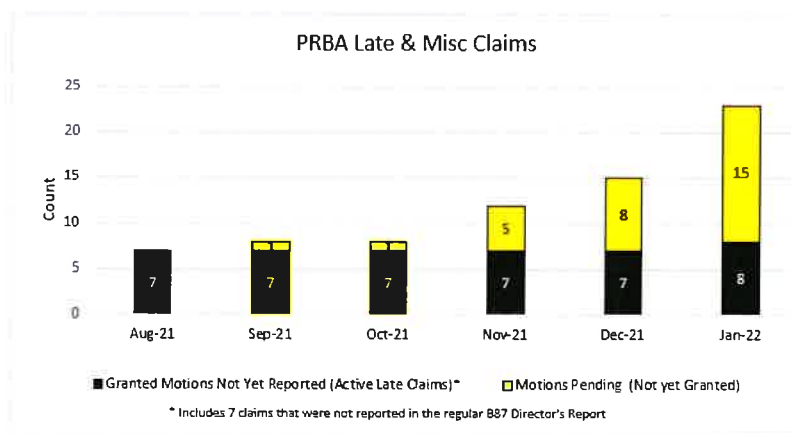
Palouse River Basin Adjudication

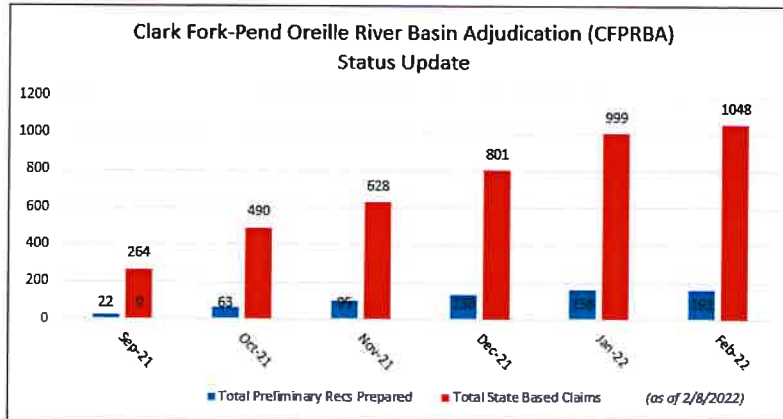
Palouse River Basin Adjudication
