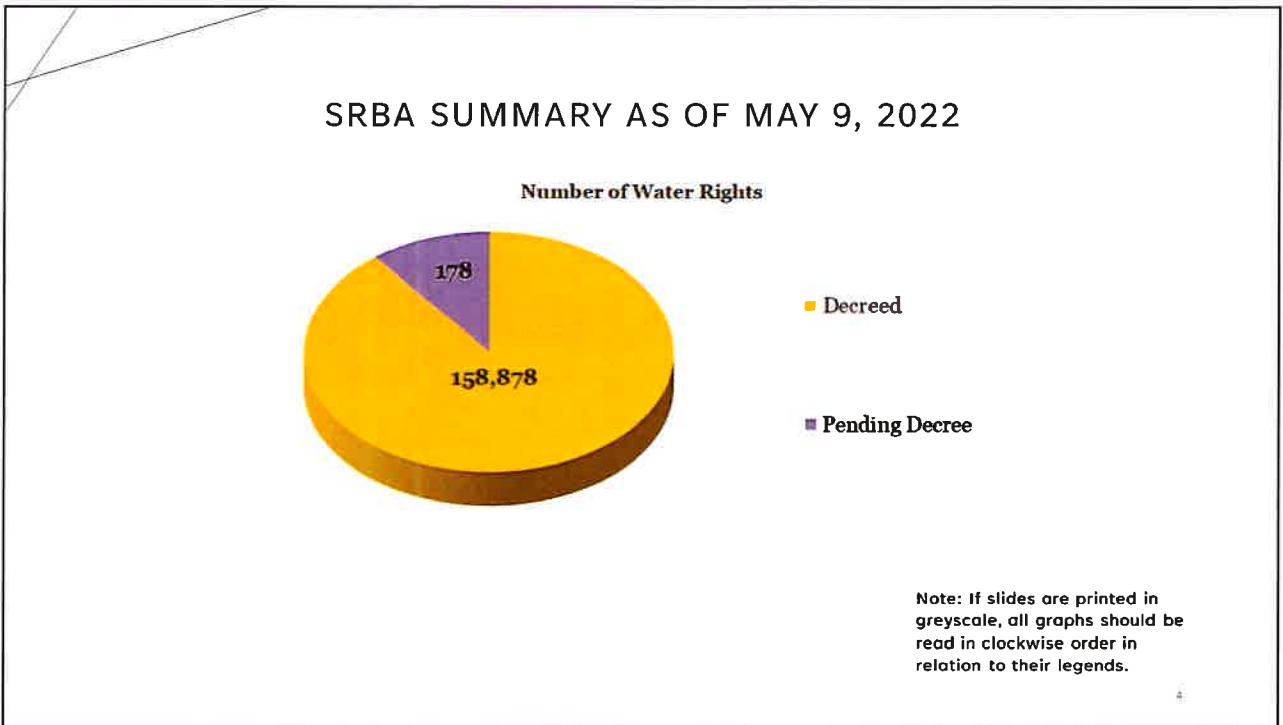

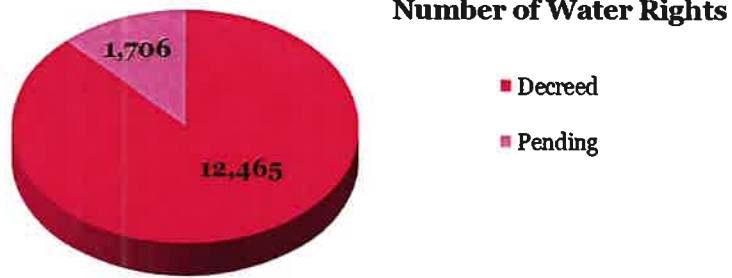

CSRBA SUMMARY AS OF MAY 9, 2022

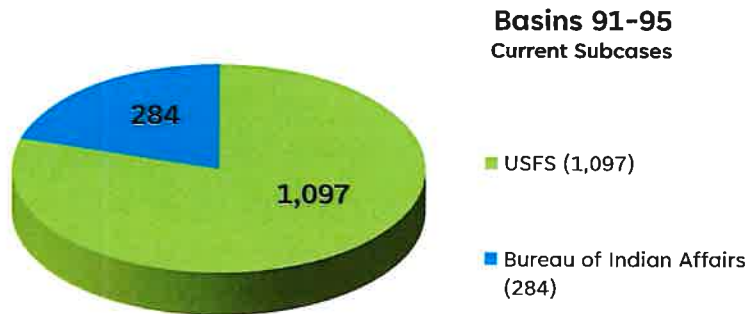
