

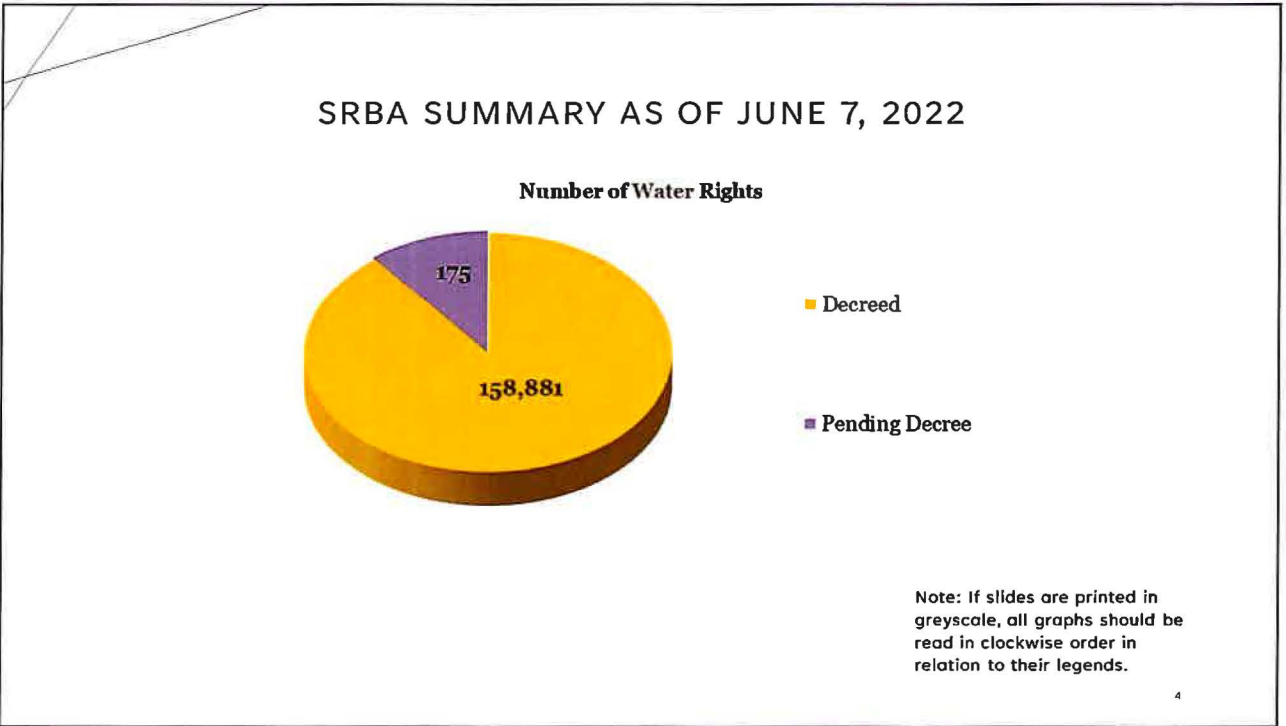

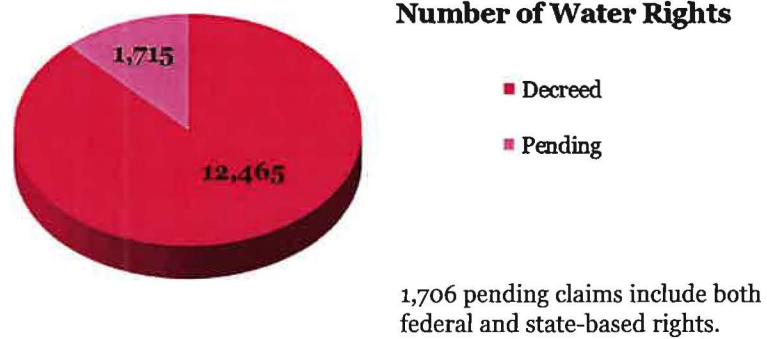

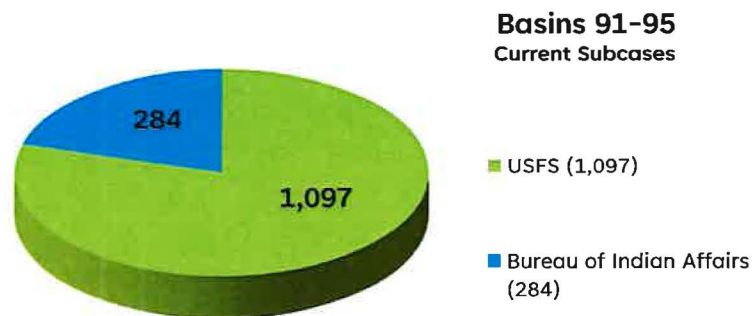
CSRBA SUMMARY AS OF JUNE 7, 2022

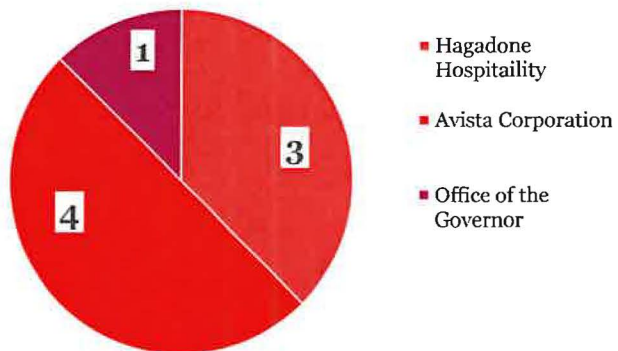

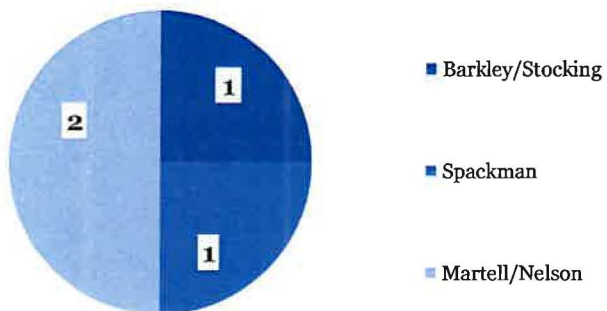

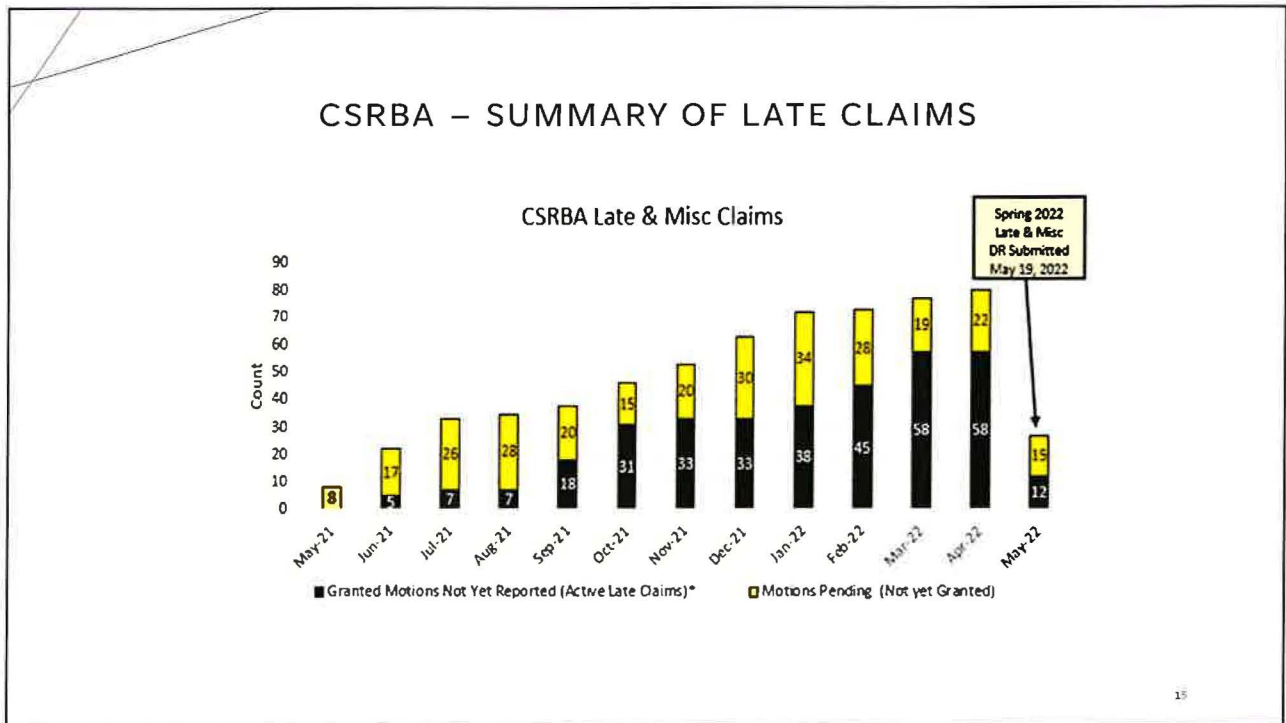
BASIN 95 PART 2
