CSRBA SUMMARY AS OF AUGUST 8, 2022

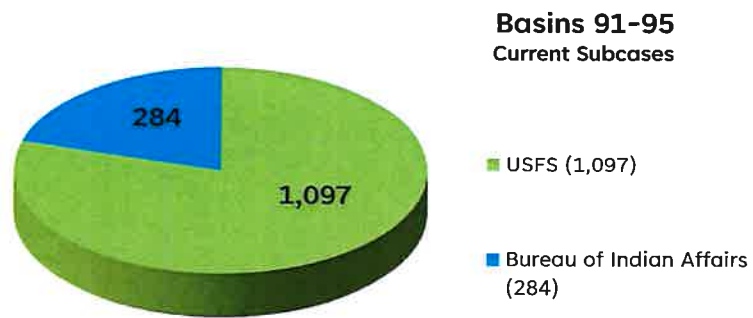

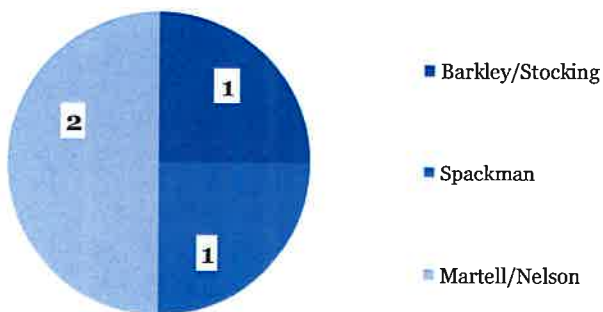
