#### CSRBA FEDERAL RESERVED CLAIMS











#### CFPRBA SUMMARY AS OF FEBRUARY 8, 2023






#### BRBA SUMMARY AS OF FEBRUARY 8, 2023







#### **BRBA UPDATES**

- Claim Taking Workshop tentatively scheduled for midto-late April in Montpelier


