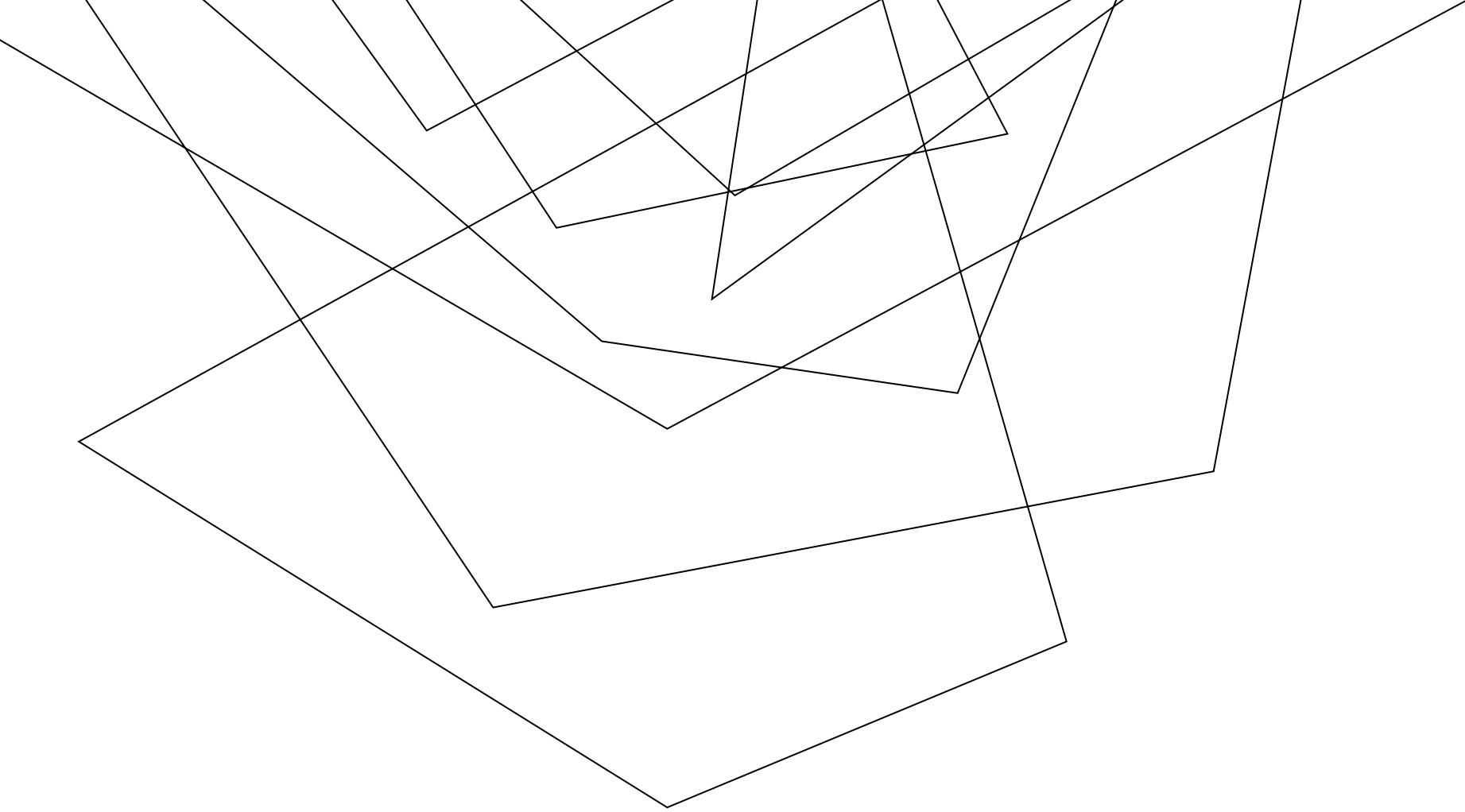






## BRBA UPDATES
