

Avista and the Governor's Office filed their SF5s with the Court on September 1, 2023. The related Hagadone SF5s were filed on September 8, 2023.







PRBA-- BASIN 87 UNRESOLVED OBJECTIONS 159 OBJECTIONS TO 81 CONTESTED SUBCASES




CFPRBA UPDATES

- Claim filing deadline is November 17, 2023










CFPRBA FEDERAL RESERVED CLAIMS

CASES OF INTEREST UPDATES

- Whittaker v. McConnell (transfer application no. 84441 in the name of Bruce and Glenda McConnell),
 Docket No. 50000-2022
 - Oral Argument was held before the Idaho Supreme Court for August 23, 2023
- South Valley Ground Water District v. IDWR (Basin 37), Docket No. 49632-2022
 - Oral Argument was held before the Idaho Supreme Court on August 25, 2023

BASIN 98 UPDATES

- The Kootenai River Basin, or Administrative Basin 98, is now the only basin that has not been adjudicated or authorized by the Legislature to be adjudicated
- IDWR is exploring local interest and level of support for commencing an adjudication in Basin 98
