Director's Report filed August 2, 2018, Response July 1, 2019.

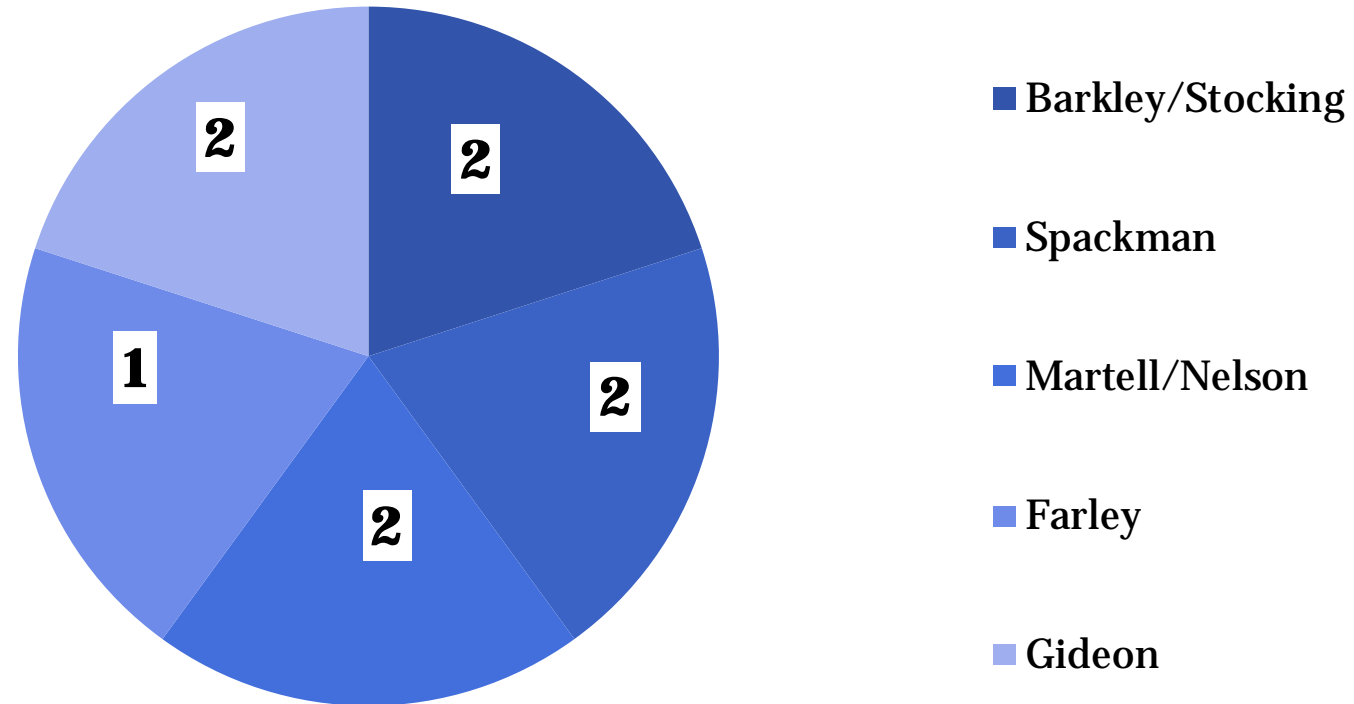

- Claim filing deadline is November 17, 2023

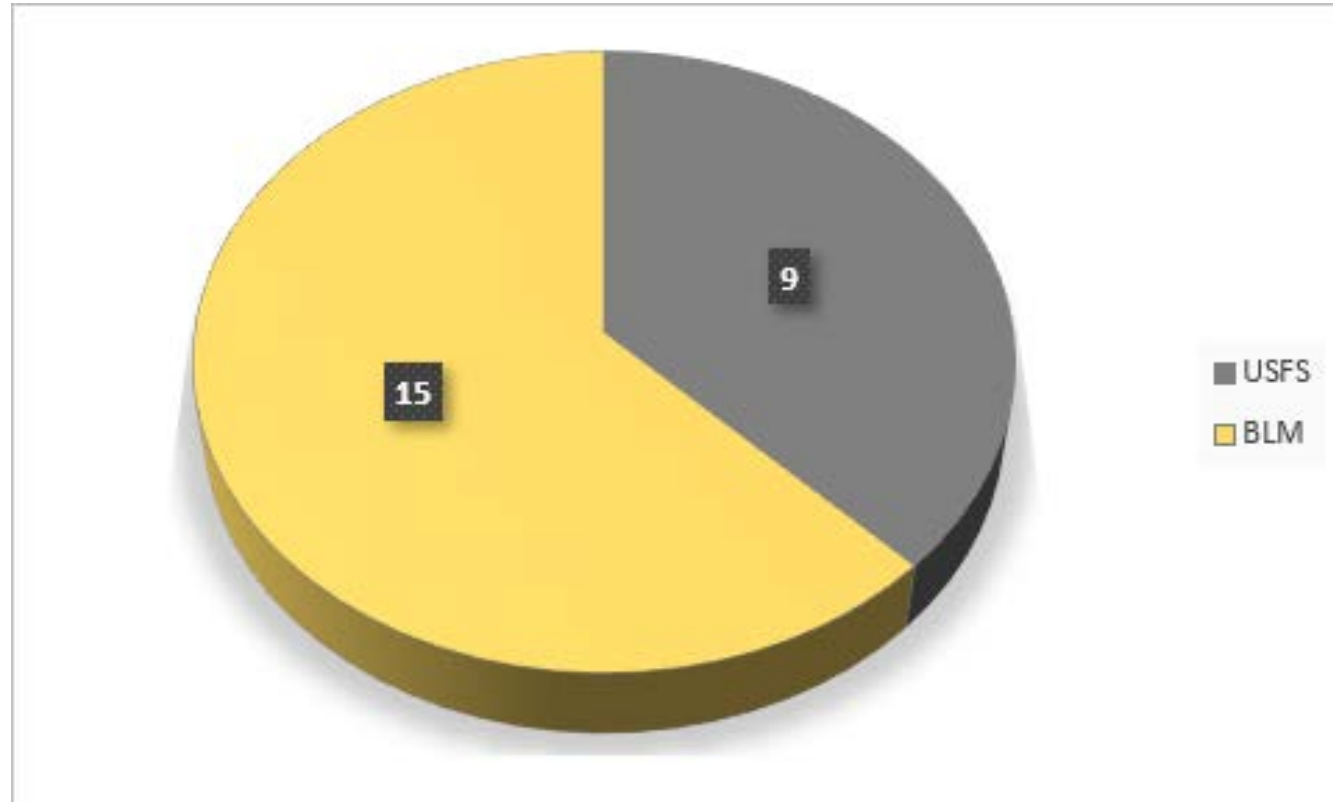
