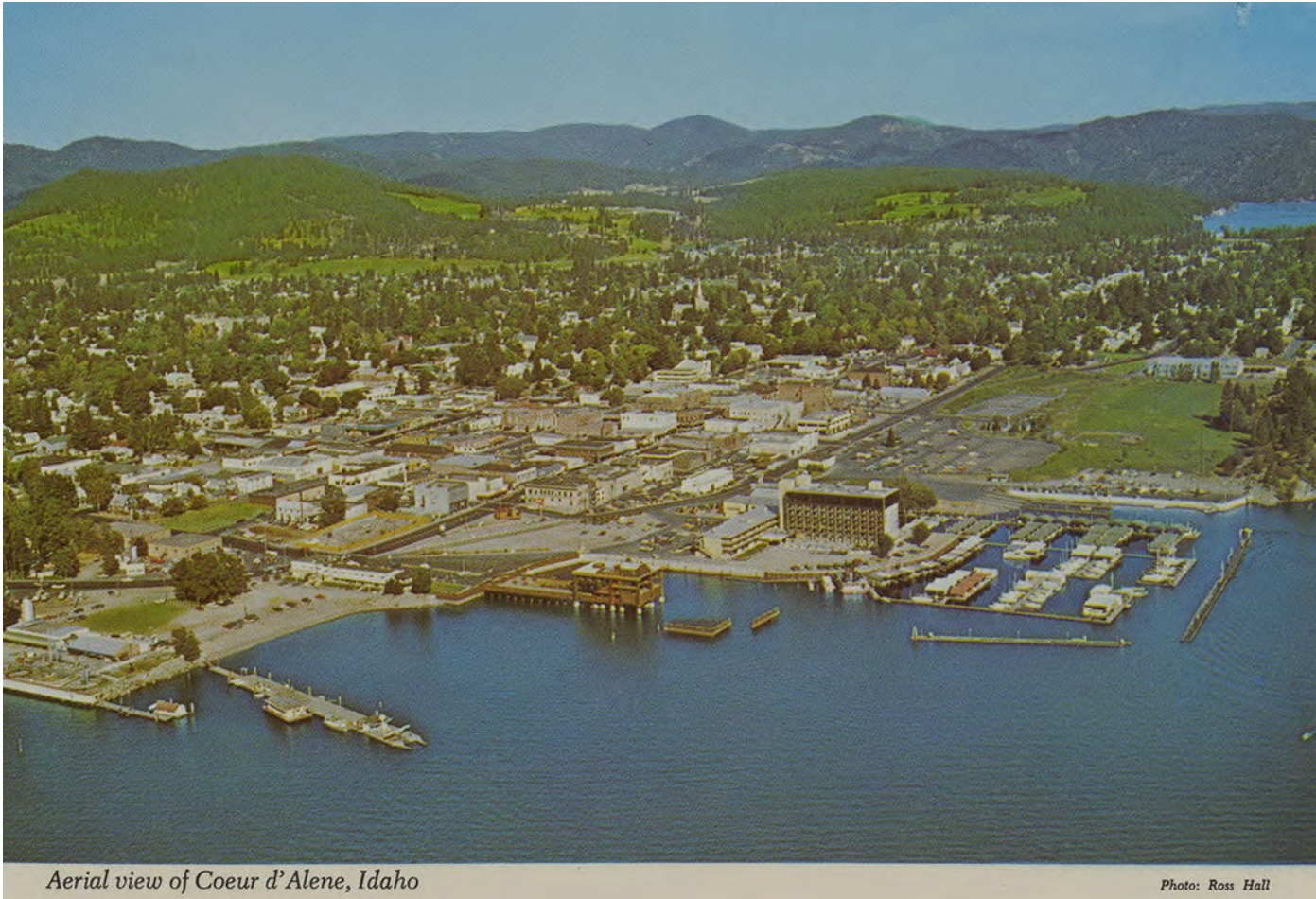
Basins 91-95 Current Subcases

Director's Report filed August 2, 2018, Response July 1, 2019.

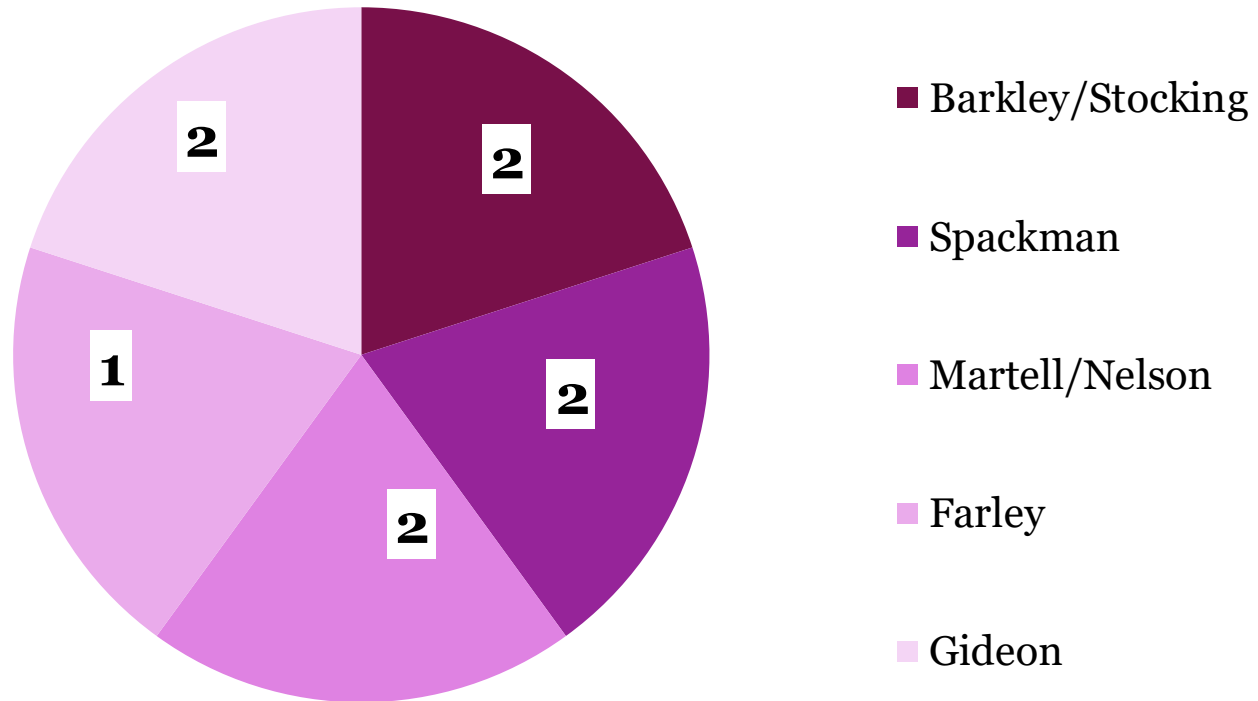

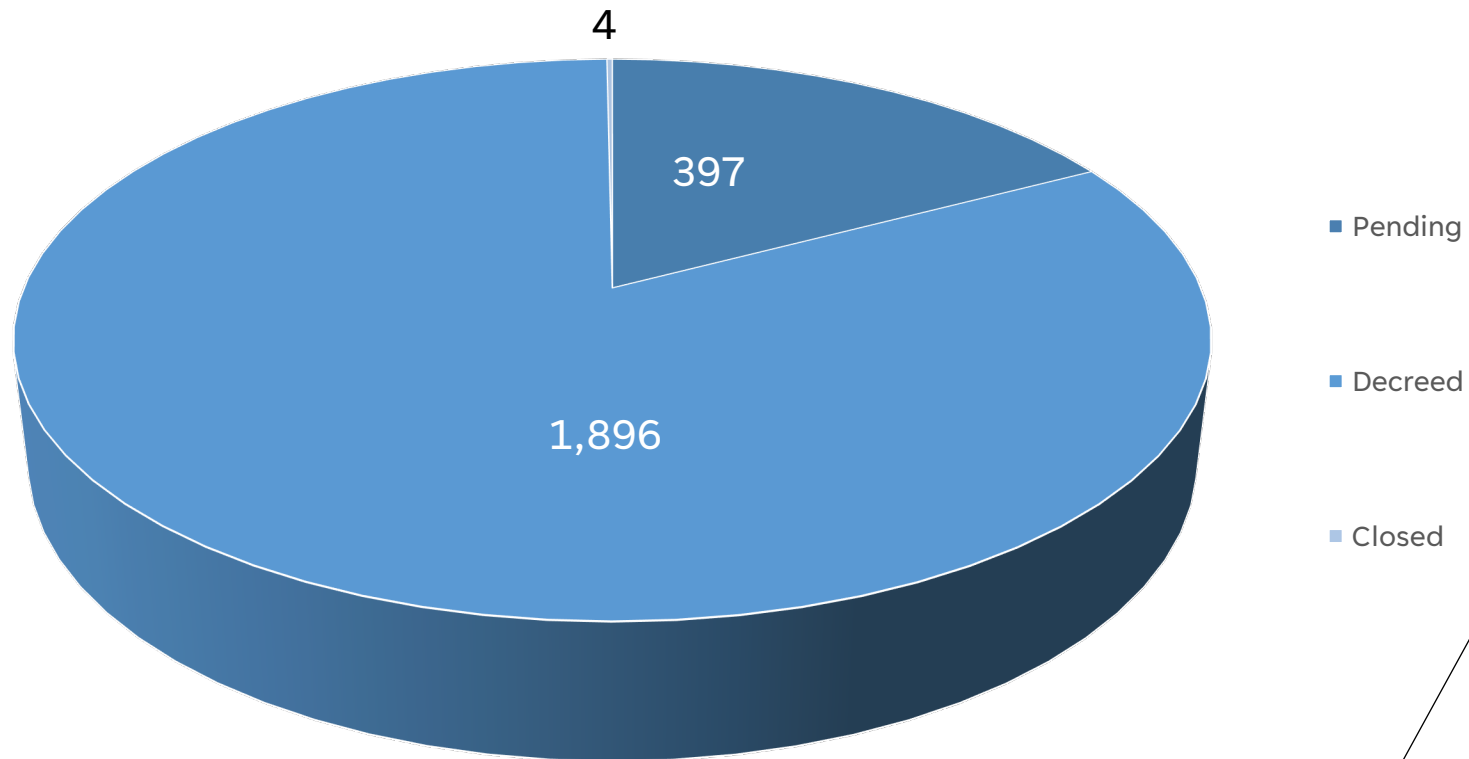
CSRBA – SUMMARY OF LATE CLAIMS



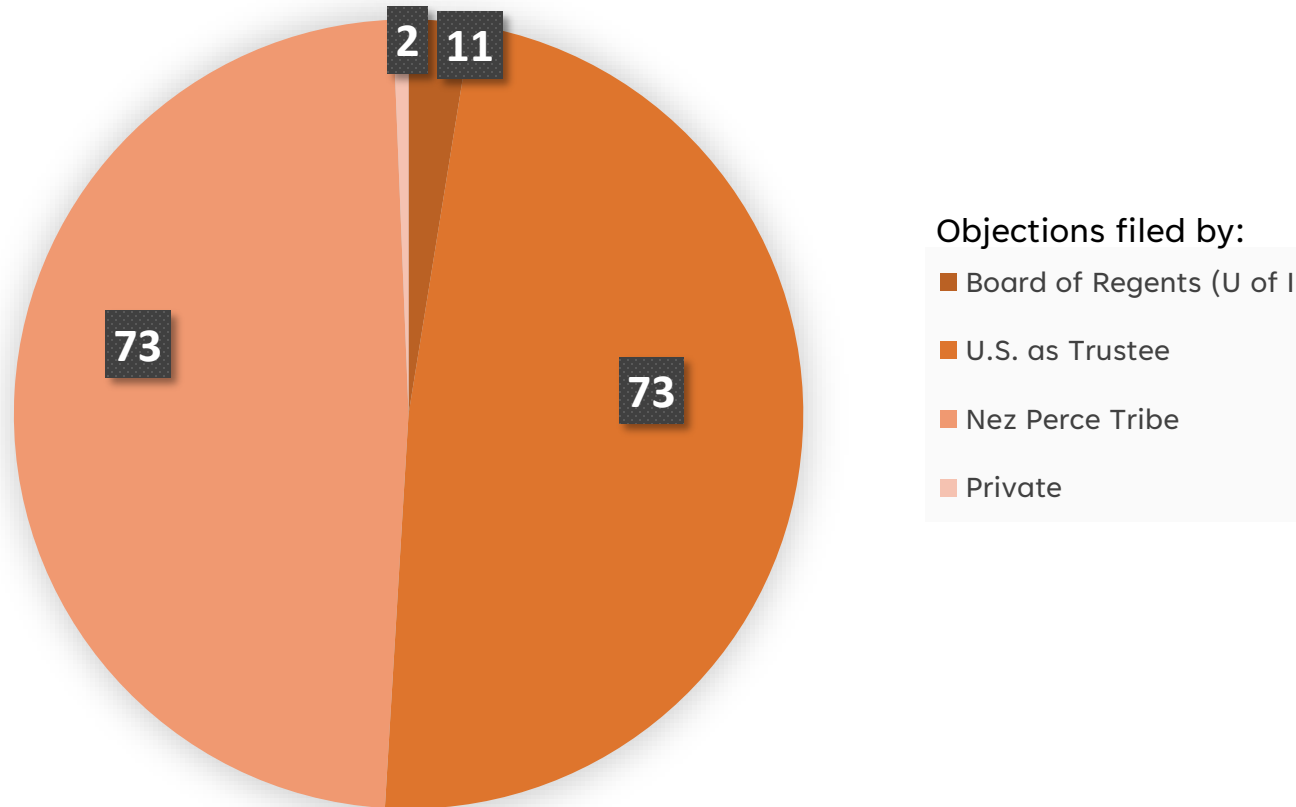

- Claim filing deadline was November 17, 2023



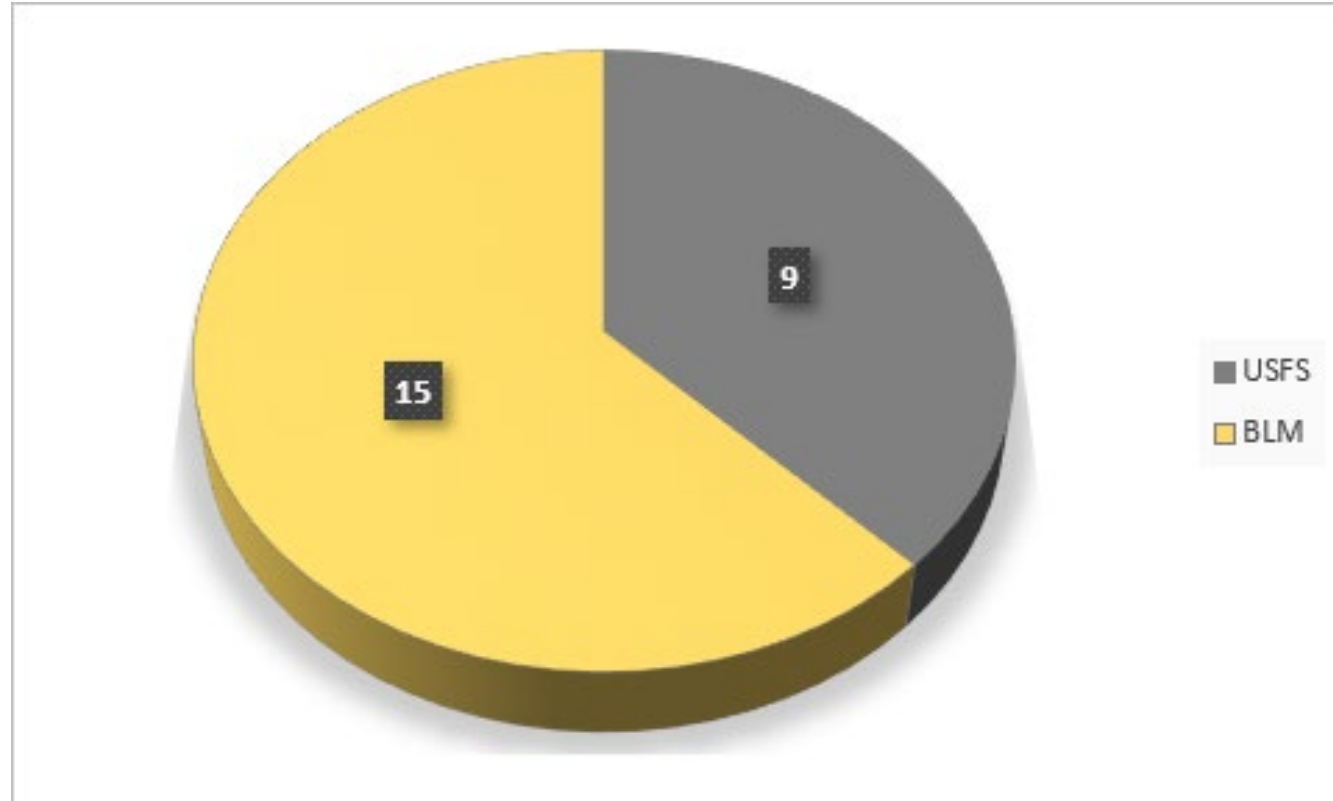

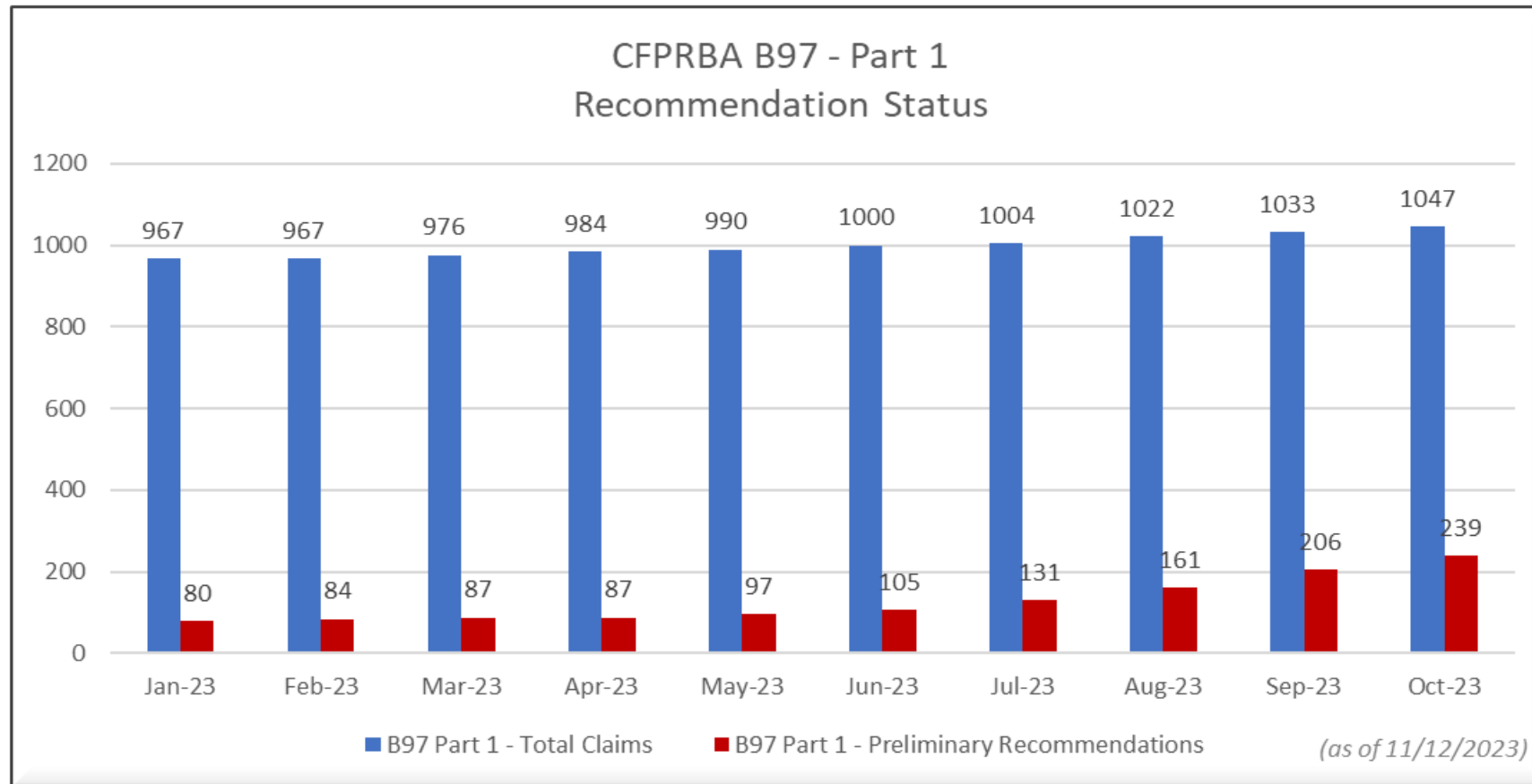
CFPRBA SUMMARY AS OF NOVEMBER 13, 2023

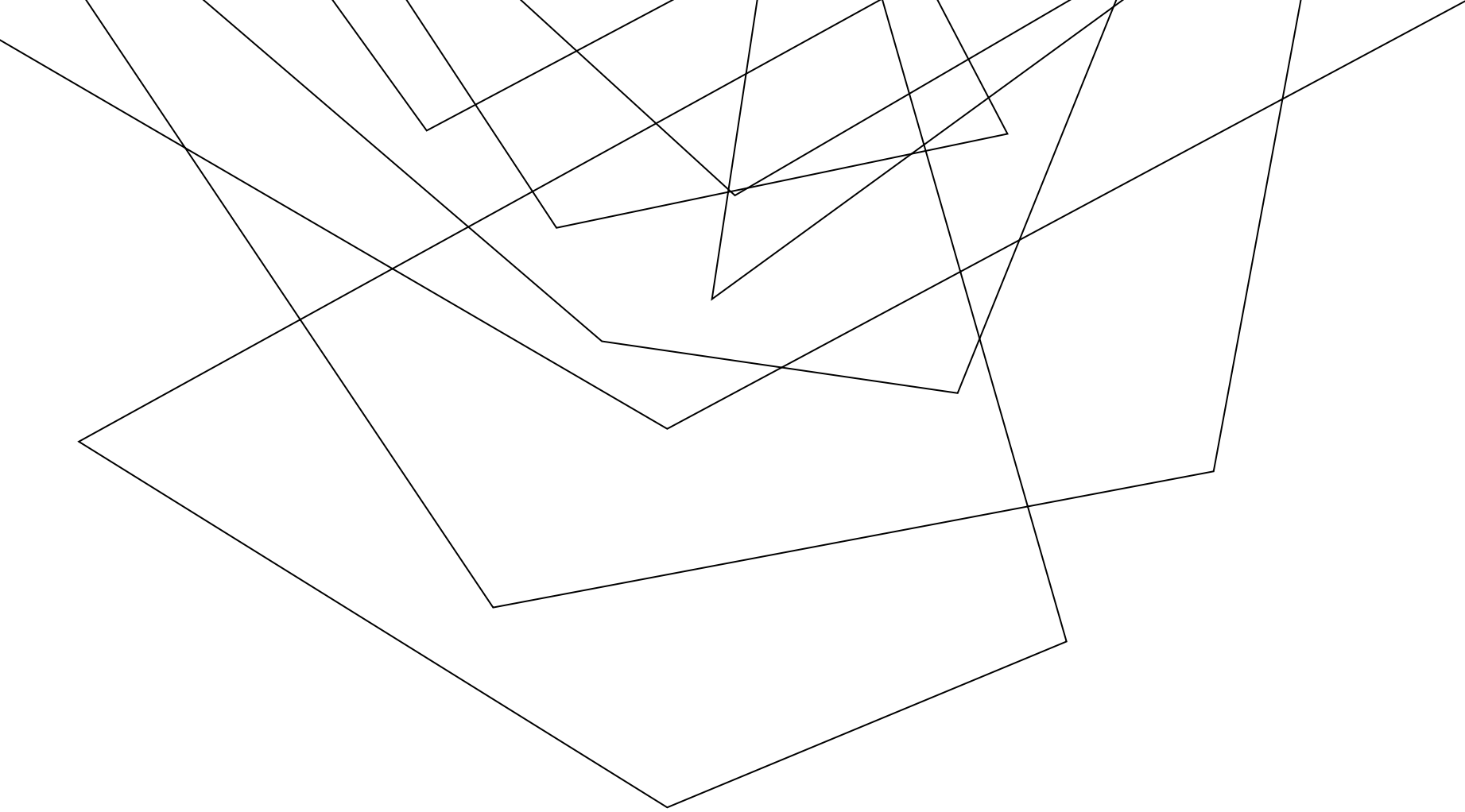


CFPRBA FEDERAL RESERVED CLAIMS



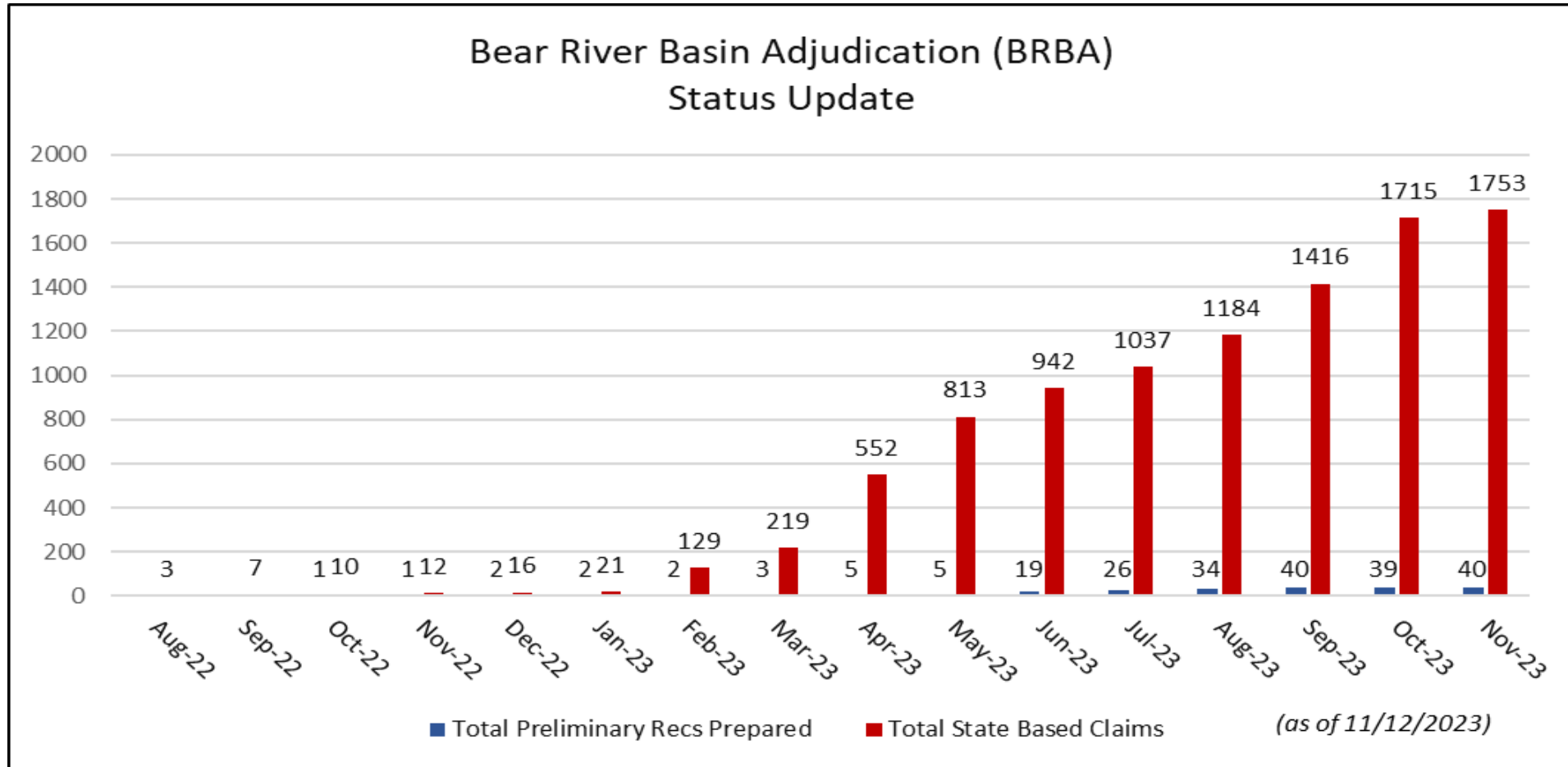

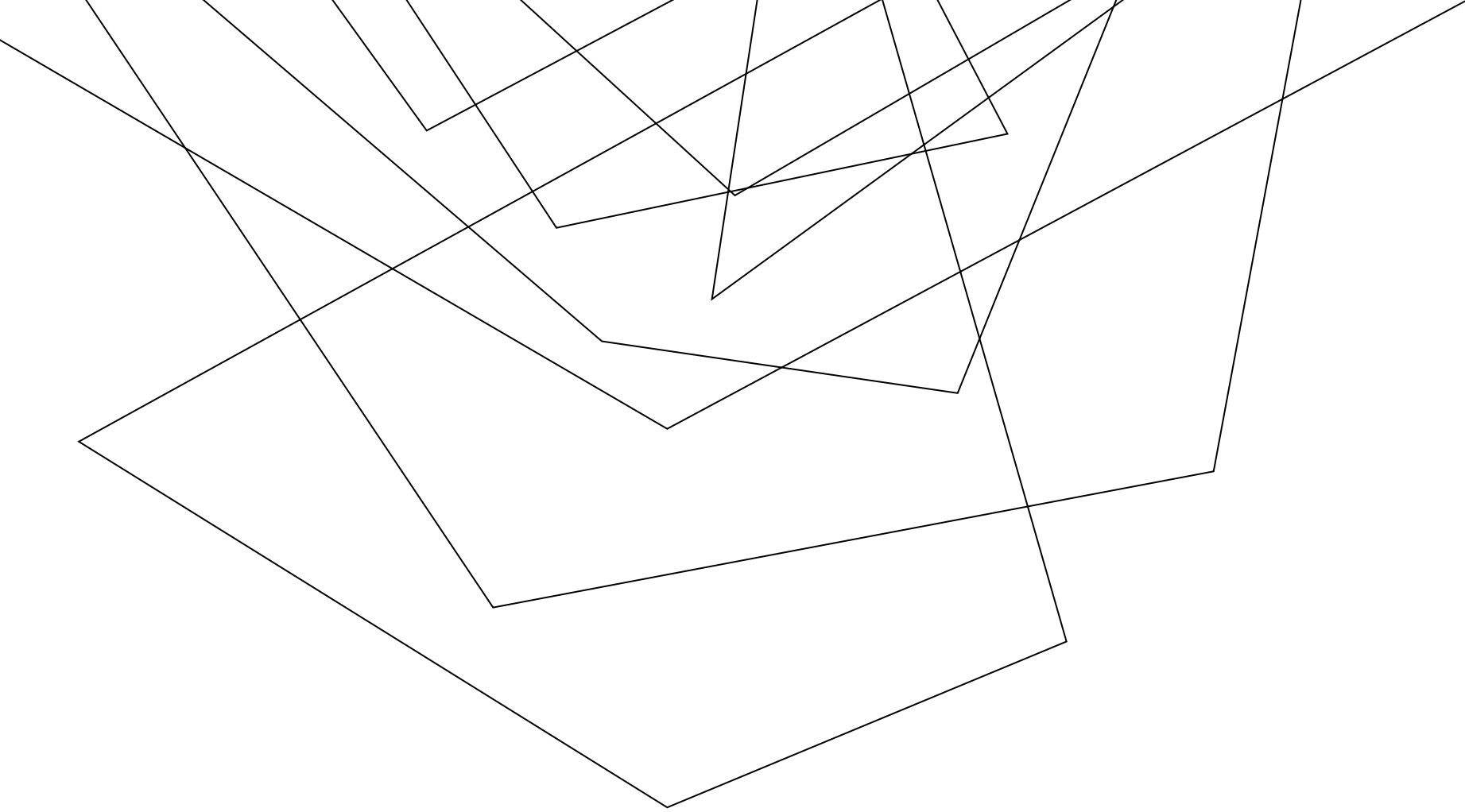




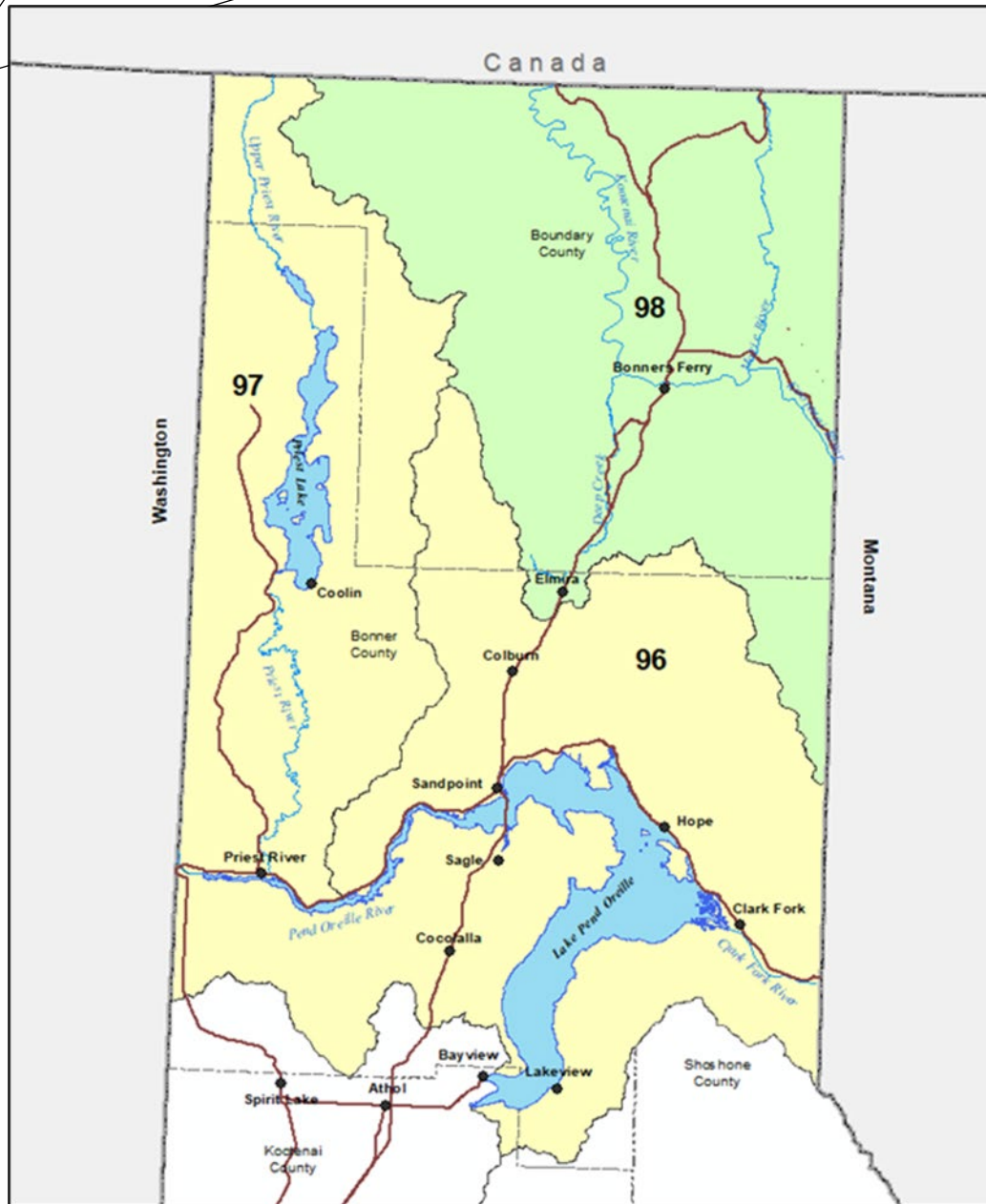

BASIN 98 UPDATE

- The Kootenai River Basin, or Administrative Basin 98, is now the only basin that has not been adjudicated or authorized by the Legislature to be adjudicated
- IDWR is exploring local interest and level of support for commencing an adjudication in Basin 98

CASES OF INTEREST UPDATES

- Whittaker v. McConnell (transfer application no. 84441 in the name of Bruce and Glenda McConnell), Docket No. 50000-2022
 - Oral Argument was held before the Idaho Supreme Court for August 23, 2023
- South Valley Ground Water District v. IDWR (Basin 37), Docket No. 49632-2022
 - Oral Argument was held before the Idaho Supreme Court on August 25, 2023
