



# ADJUDICATION OF DEFERRED DE MINIMIS DOMESTIC AND STOCKWATER CLAIMS

• A hearing on the United States' *Motion to Adjudicate Deferred De Minimis Domestic and Stockwater Claims* was held on January 16, 2024. The Court issued a *Stay Order* to be in effect until 60 days after the resolution of *U.S. v. State of Idaho*, Case No. 1:22-cv-00236-DKG, currently pending in the United States District Court for the District of Idaho.


Avista and the Governor's Office filed their SF5s with the Court on September 1, 2023. The related Hagadone SF5s were filed on September 8, 2023.

The United States and Coeur d'Alene Tribe filed a Joint Motion to Participate and for an Order Construing SF5s as Amended Claims/Director's Report on September 7, 2023.

On January 30, 2024, an Order on Standard Form 5s was issued by Special Master Bilyeu. The Court found that some of the elements of Avista's and the Governor's SF5s contain expansions beyond the Claims and Director's Reports and require Docket Sheet notice. Avista has filed a Motion for Clarification. A hearing was held on February 28, 2024, and the parties await a decision.


A Status/Scheduling Conference has been scheduled for April 17, 2024.




#### CSRBA - SUMMARY OF LATE CLAIMS





## PRBA-- BASIN 87 UNRESOLVED OBJECTIONS 159 OBJECTIONS TO 81 CONTESTED SUBCASES



- Claim filing deadline is May 17, 2024








#### CFPRBA FEDERAL RESERVED CLAIMS





#### BASIN 13 PUBLIC INFORMATION MEETINGS




- IDWR and the Court hosted two public information meetings in late January. Staff spoke about topics relevant to Basin 13 and the Adjudication.
- There were many interesting questions and attendees expressed gratitude for the event.



OTHER GENERAL MATTERS

#### **BASIN 98 UPDATE**

- The Kootenai River Basin, or Administrative Basin 98, is now the only basin that has not been adjudicated or authorized by the Legislature to be adjudicated
- On February 12, 2024, IDWR and the Court met with the Kootenai Valley Resource Initiative (KVRI) to discuss stakeholder concerns about and interest in commencing an adjudication
- H0687 was introduced on February 29 and has passed both the House and Senate committees. On March 12 it was added to the Senate Calendar.
