



ADJUDICATION OF DEFERRED DE MINIMIS DOMESTIC AND STOCKWATER CLAIMS

• A hearing on the United States' *Motion to Adjudicate Deferred De Minimis Domestic and Stockwater Claims* was held on January 16, 2024. The Court issued a *Stay Order* to be in effect until 60 days after the resolution of *U.S. v. State of Idaho*, Case No. 1:22-cv-00236-DKG, currently pending in the United States District Court for the District of Idaho.


Avista and the Governor's Office filed their SF5s with the Court on September 1, 2023. The related Hagadone SF5s were filed on September 8, 2023.

The United States and Coeur d'Alene Tribe filed a Joint Motion to Participate and for an Order Construing SF5s as Amended Claims/Director's Report on September 7, 2023.

On January 30, 2024, an Order on Standard Form 5s was issued by Special Master Bilyeu. The Court found that some of the elements of Avista's and the Governor's SF5s contain expansions beyond the Claims and Director's Reports and require Docket Sheet notice. Avista has filed a Motion for Clarification. A hearing was held on February 28, 2024, and the parties await a decision.


A Status/Scheduling Conference has been scheduled for April 17, 2024.









PRBA SUMMARY AS OF APRIL 8, 2024




PRBA FEDERAL RESERVED CLAIMS



PRBA – POST DIRECTOR'S REPORT CLAIM COUNT (LATE AND MISCELLANEOUS CLAIMS)










CFPRBA FEDERAL RESERVED CLAIMS




BASIN 97 - PART 1





Water Agent Joe Pacheco walking across Stewart Dam in Basin 11. This dam diverts the entire flow of the Bear River into Bear Lake.



OTHER GENERAL MATTERS

BASIN 98 UPDATE

- The Kootenai River Basin, or Administrative Basin 98, is now the only basin that has not been adjudicated or authorized by the Legislature to be adjudicated
- February 12, 2024 IDWR and the Court met with the Kootenai Valley Resource Initiative (KVRI) to discuss stakeholder concerns about and interest in commencing an adjudication
- February 29, 2024 H0687 was introduced and has passed both the House and Senate committees
- March 13, 2024 the bill was reported out of committee with Do Pass Recommendation
- March 20, 2024 Passed Senate
- March 28, 2024 Signed by Governor
