





ADJUDICATION OF DEFERRED DE MINIMIS DOMESTIC AND STOCKWATER CLAIMS







BASIN 95 PART 1 SUBCASES FOR WHICH OBJECTIONS ARE UNRESOLVED



An Order on Motion to Clarify was issued on April 16, 2024, concluding that when Avista's rights were claimed, Coeur d'Alene Lake was included in the Source element, the Source element did not include the Lake in the Director's Report, but then was included in the SF5. By applying Rule AO1 4.d(4)(e), Special Master Bilyeu ruled that it appears that describing Lake Coeur d'Alene in the Source Element in the SF5 is not an expansion.




PRBA SUMMARY AS OF MAY 8, 2024




CFPRBA FEDERAL RESERVED CLAIMS




BASIN 97 - PART 1








