ADJUDICATION OF DEFERRED DE MINIMIS DOMESTIC AND STOCKWATER CLAIMS

 A hearing on the United States' Motion to Adjudicate Deferred De Minimis Domestic and Stockwater Claims was held on January 16, 2024. The Court issued a Stay Order to be in effect until 60 days after the resolution of U.S. v. State of Idaho, Case No. 1:22cv-00236-DKG, currently pending in the United States District Court for the District of Idaho.







BASIN 95 PART 1 SUBCASES FOR WHICH OBJECTIONS ARE UNRESOLVED




PRBA SUMMARY AS OF JUNE 10, 2024






CFPRBA FEDERAL RESERVED CLAIMS




