

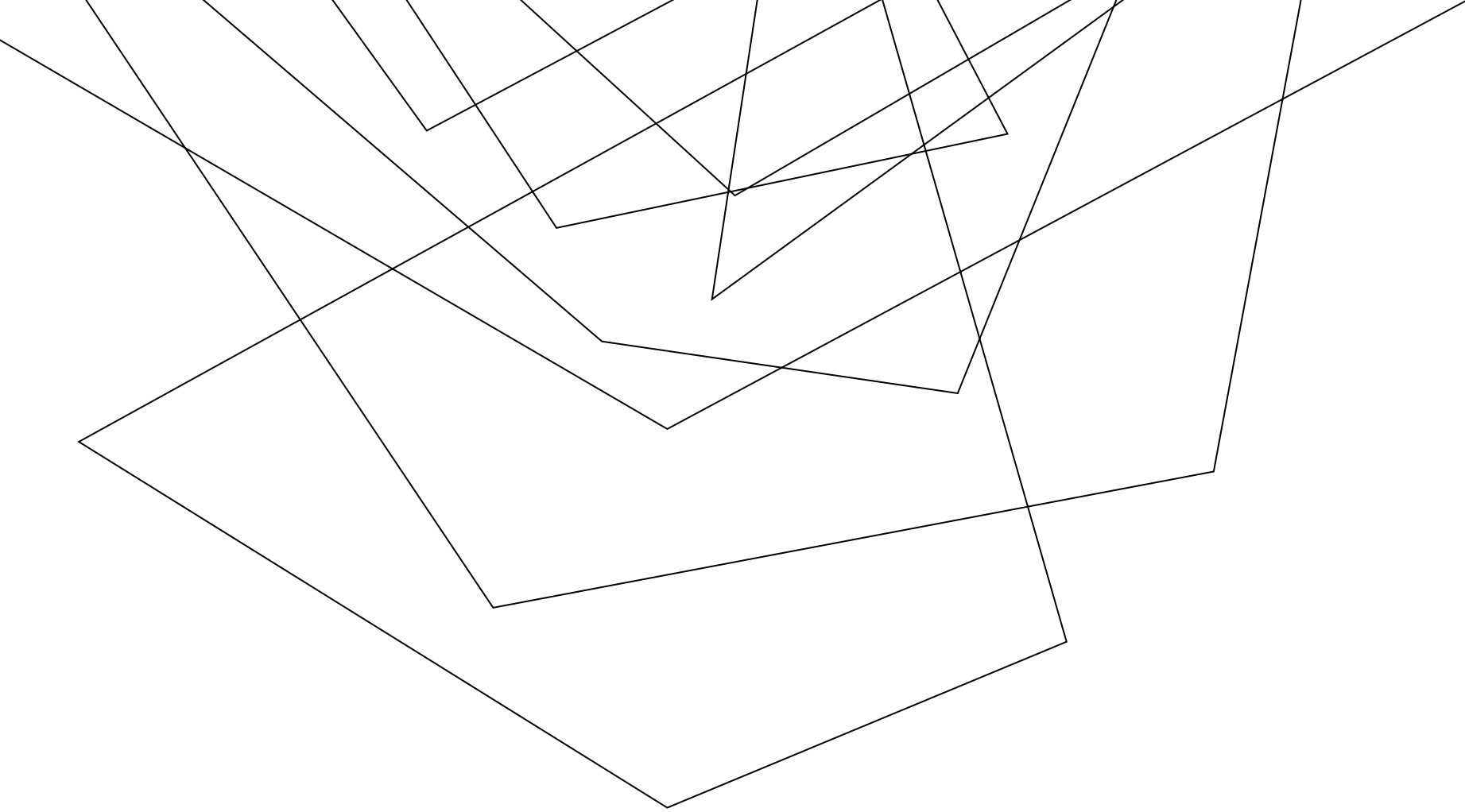

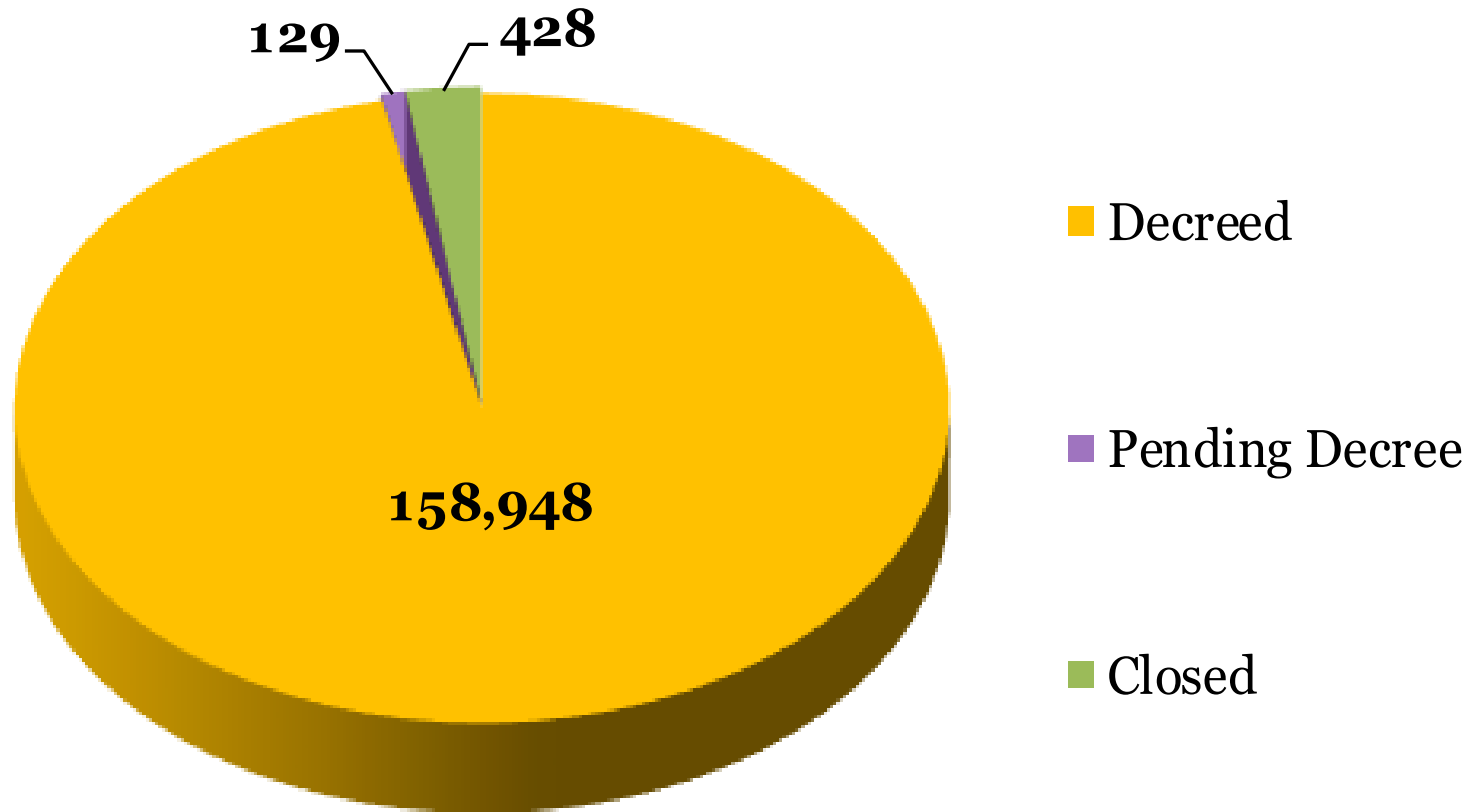

ADJUDICATION OF DEFERRED DE MINIMIS DOMESTIC AND STOCKWATER CLAIMS

- A hearing on the United States' *Motion to Adjudicate Deferred De Minimis Domestic and Stockwater Claims* was held on January 16, 2024. The Court issued a *Stay Order* to be in effect until 60 days after the resolution of *U.S. v. State of Idaho*, Case No. 1:22-cv-00236-DKG, currently pending in the United States District Court for the District of Idaho.

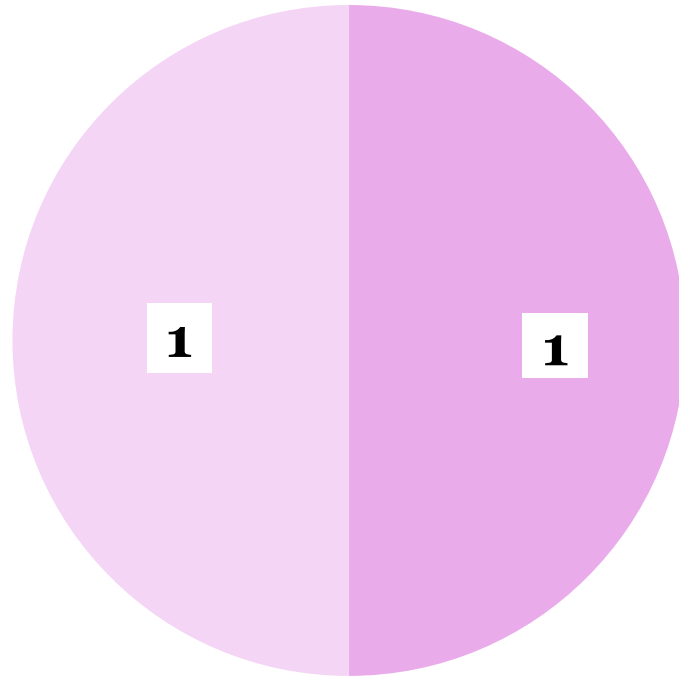
In-person settlement conferences held June 24-27, 2024. Part 2 of the mediated settlement conferences is scheduled for July 29-30, 2024.

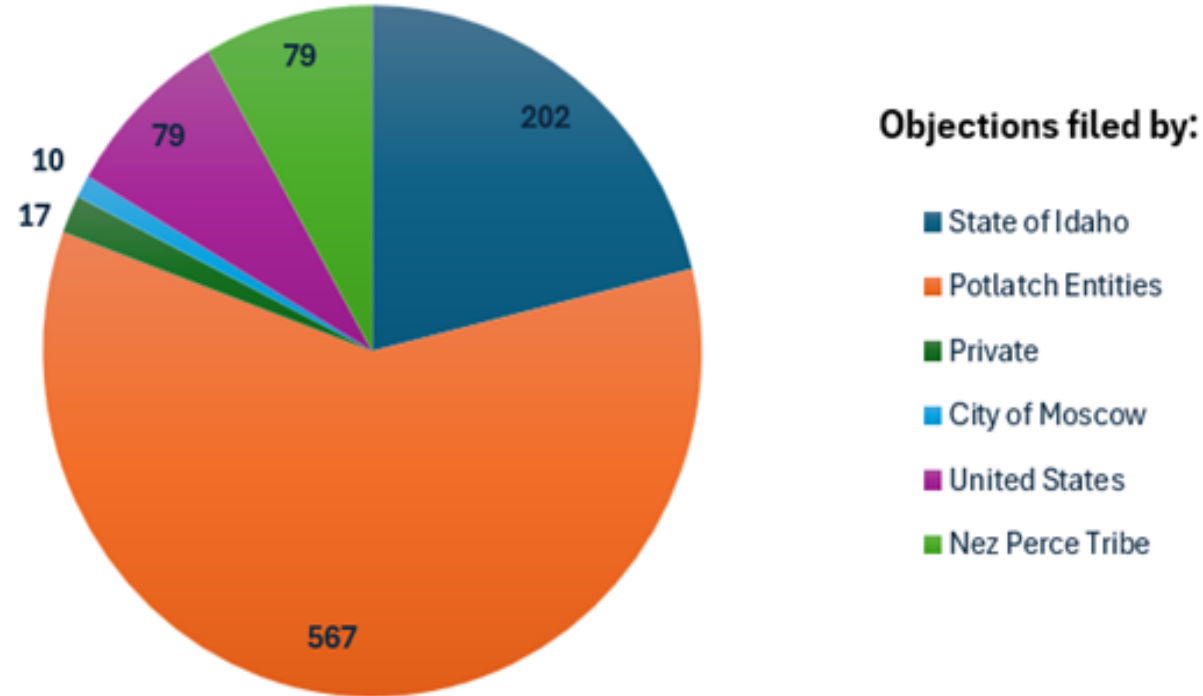
PRBA SUMMARY AS OF JULY 9, 2024



PRBA FEDERAL RESERVED CLAIMS

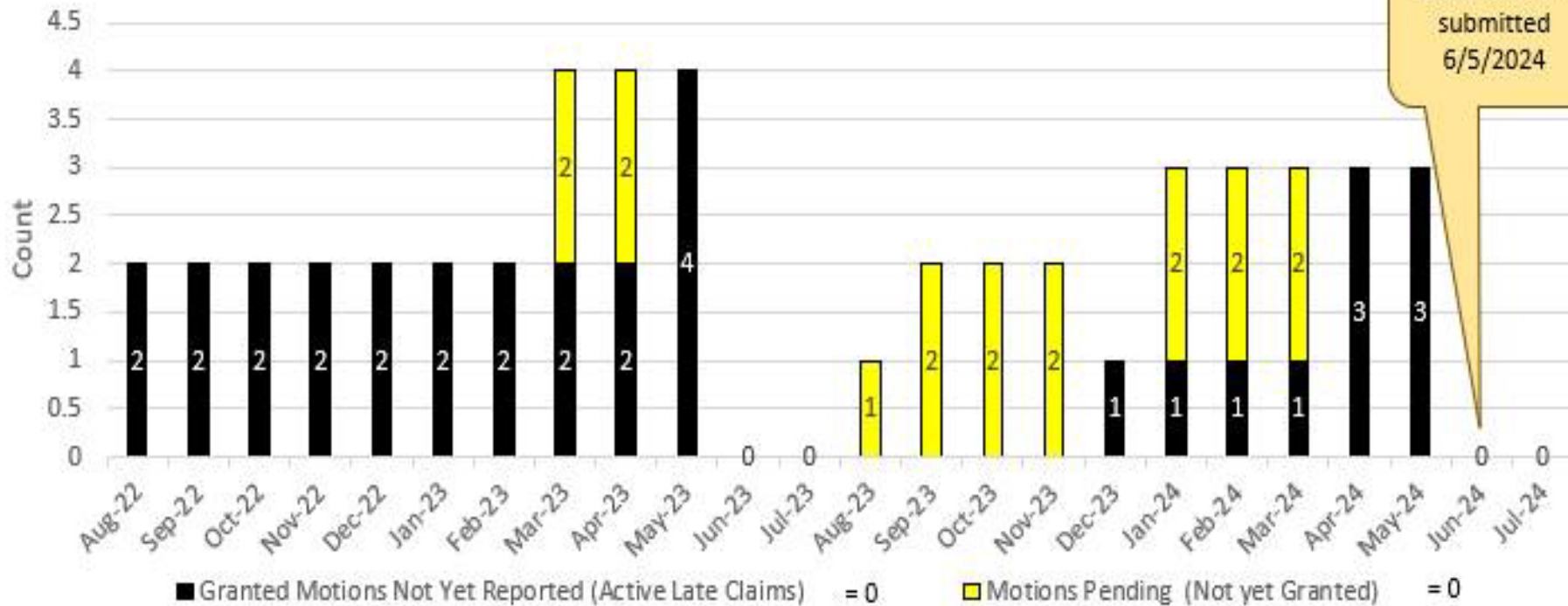

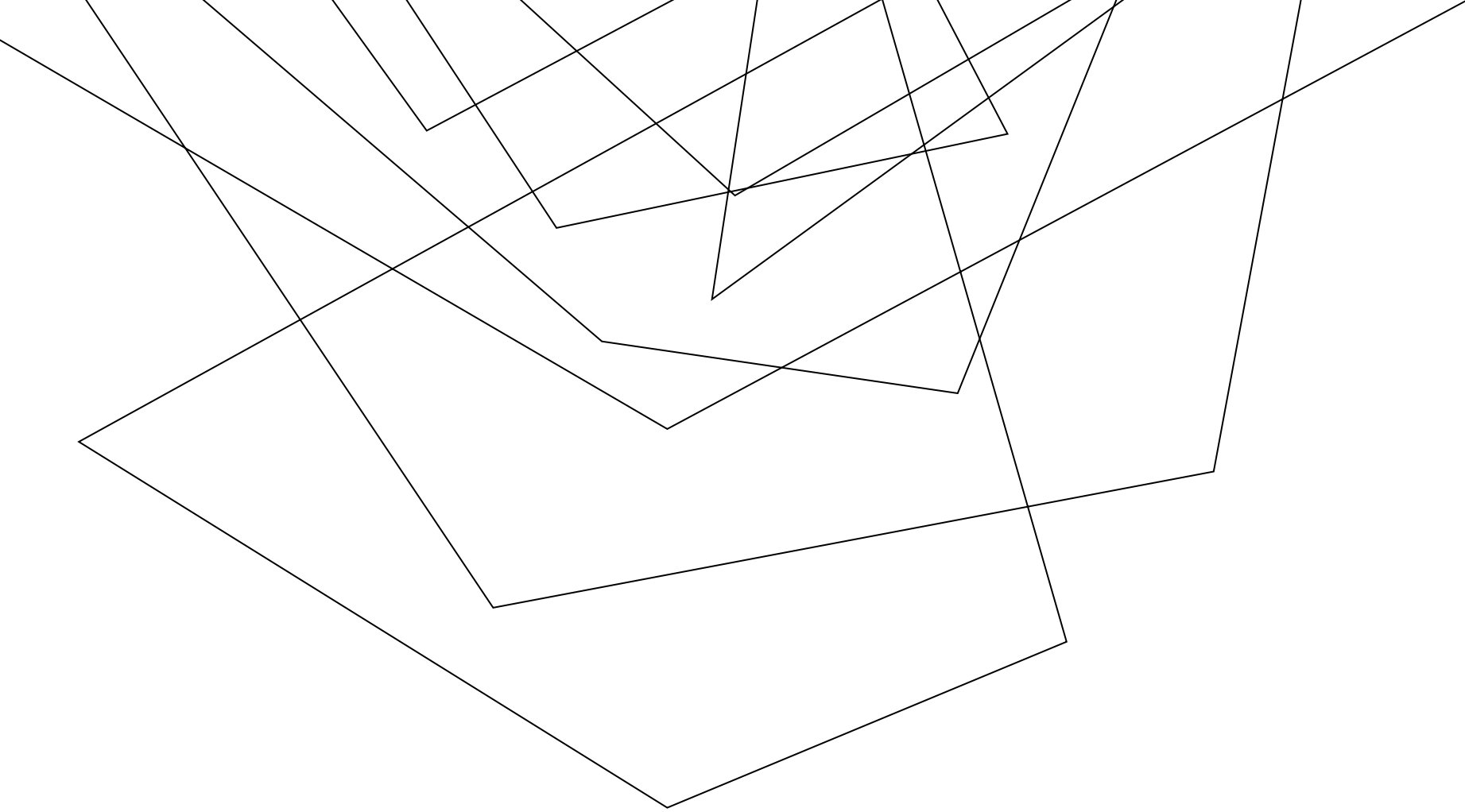

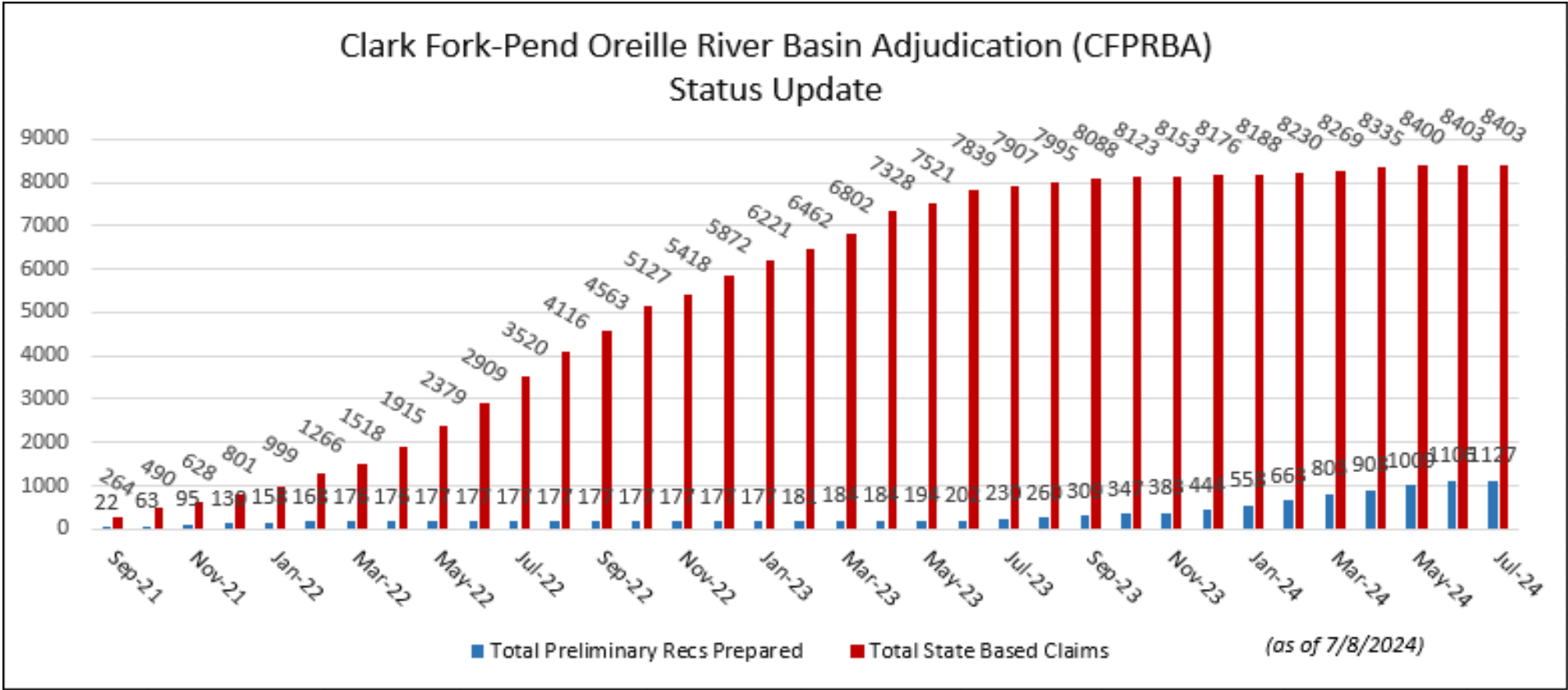
CFPRBA UPDATES

- Adjudication staff are continuing to work on recommendations for the Basin 97 Part 1 Preliminary Director's Report.

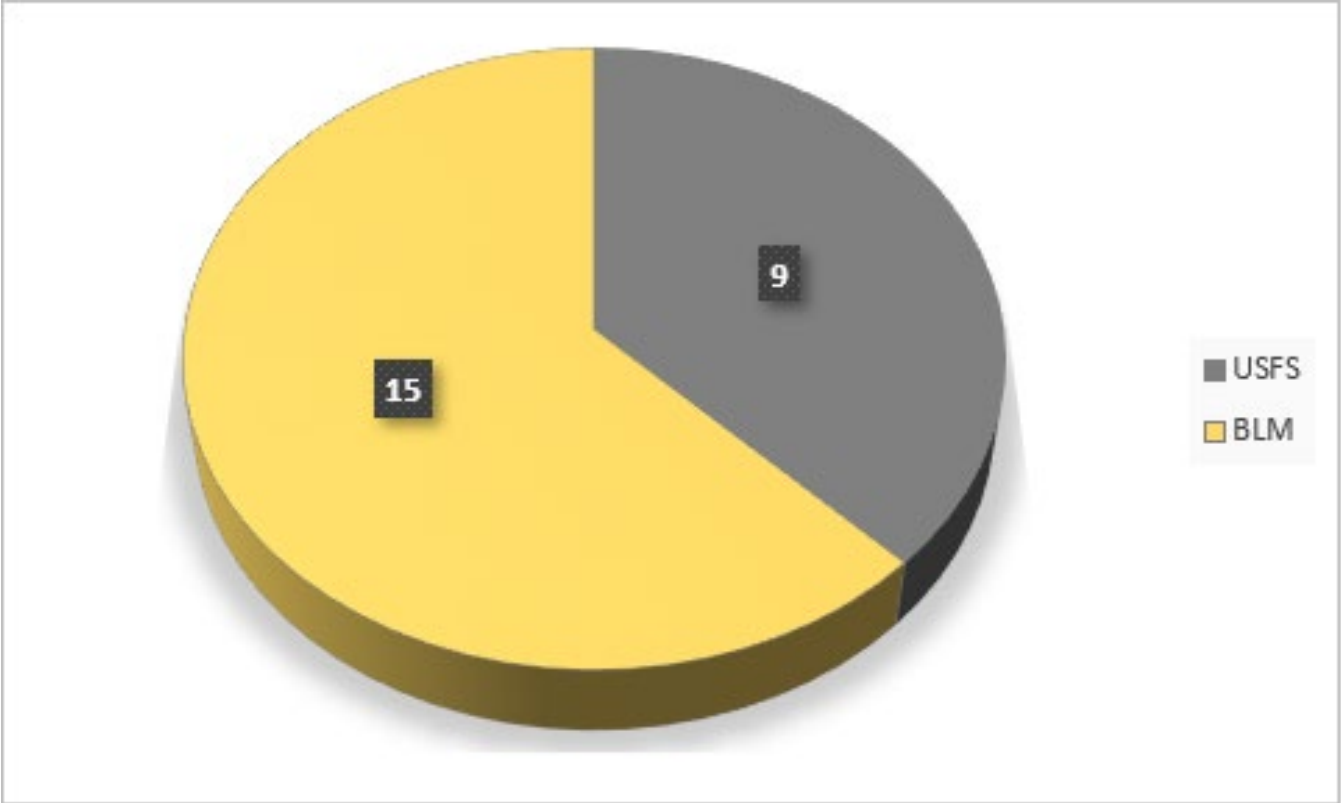

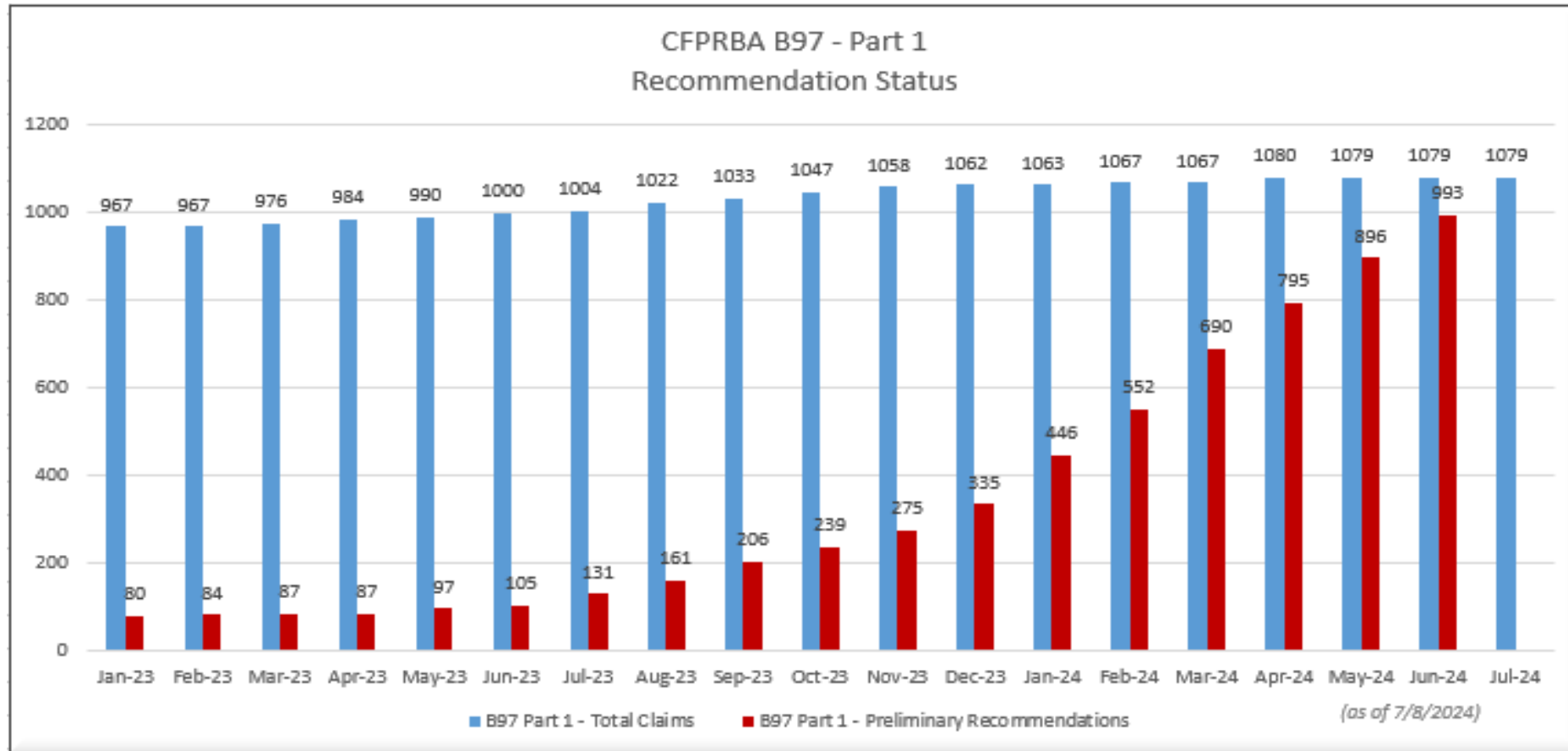

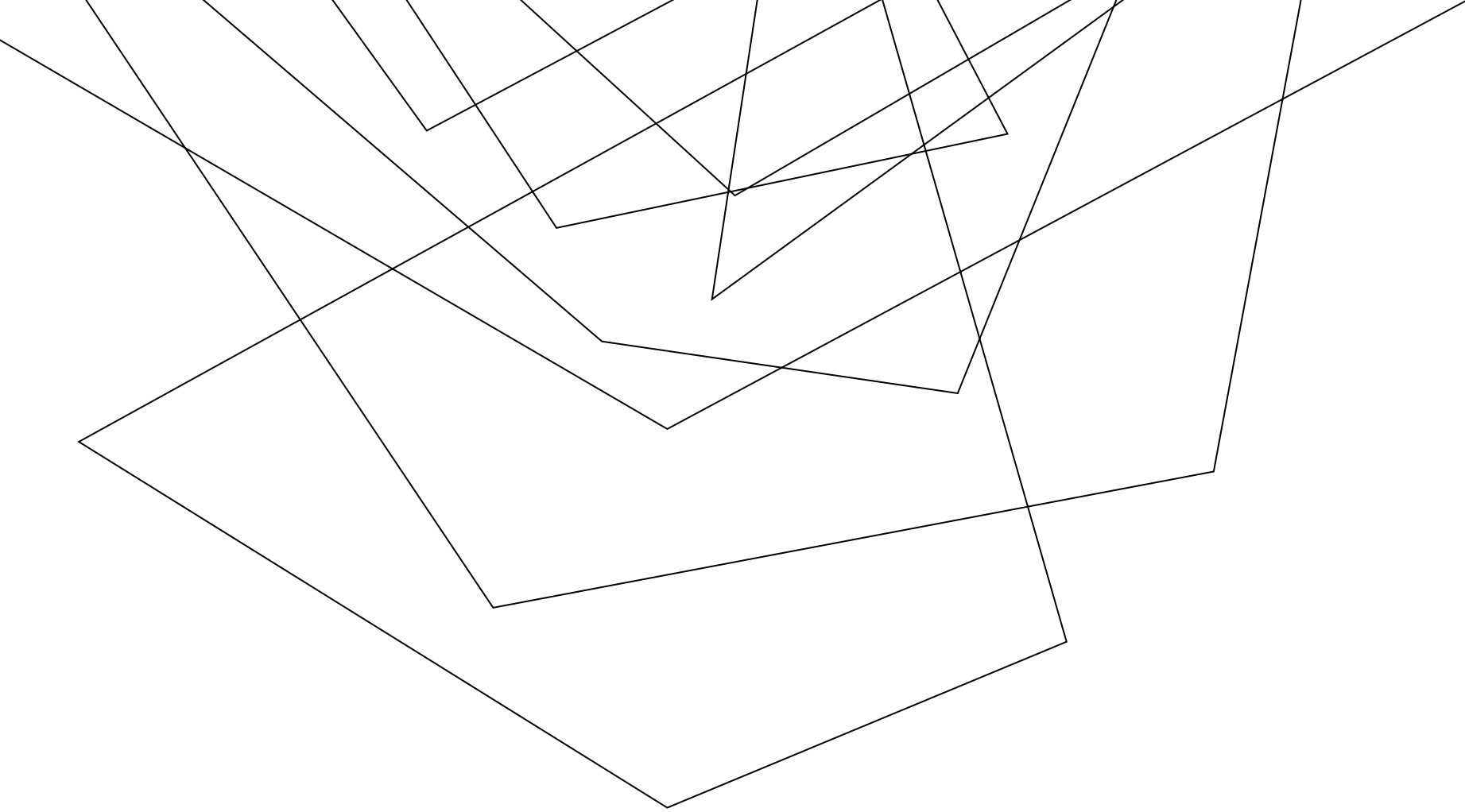


CFPRBA FEDERAL RESERVED CLAIMS



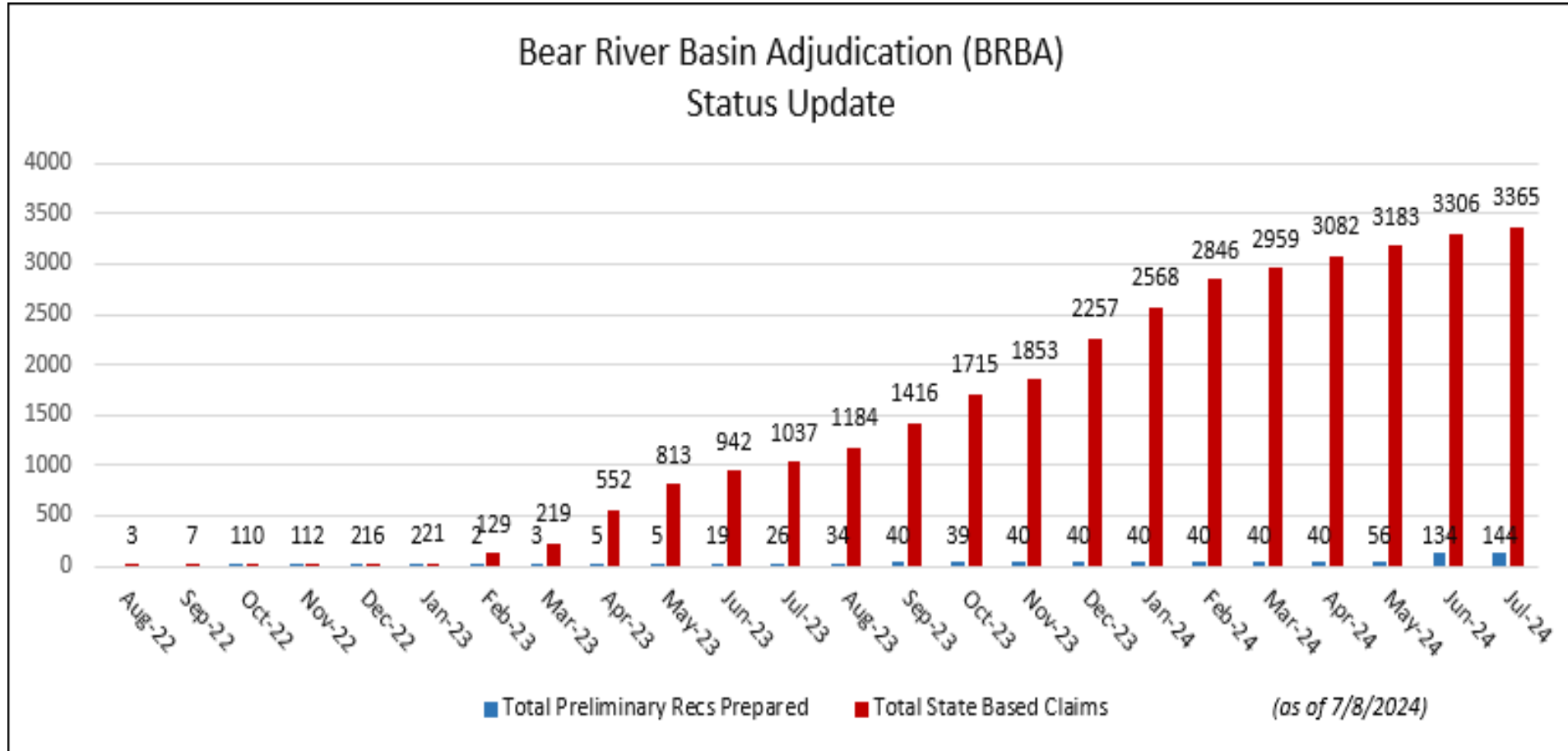
BASIN 97 – PART 1



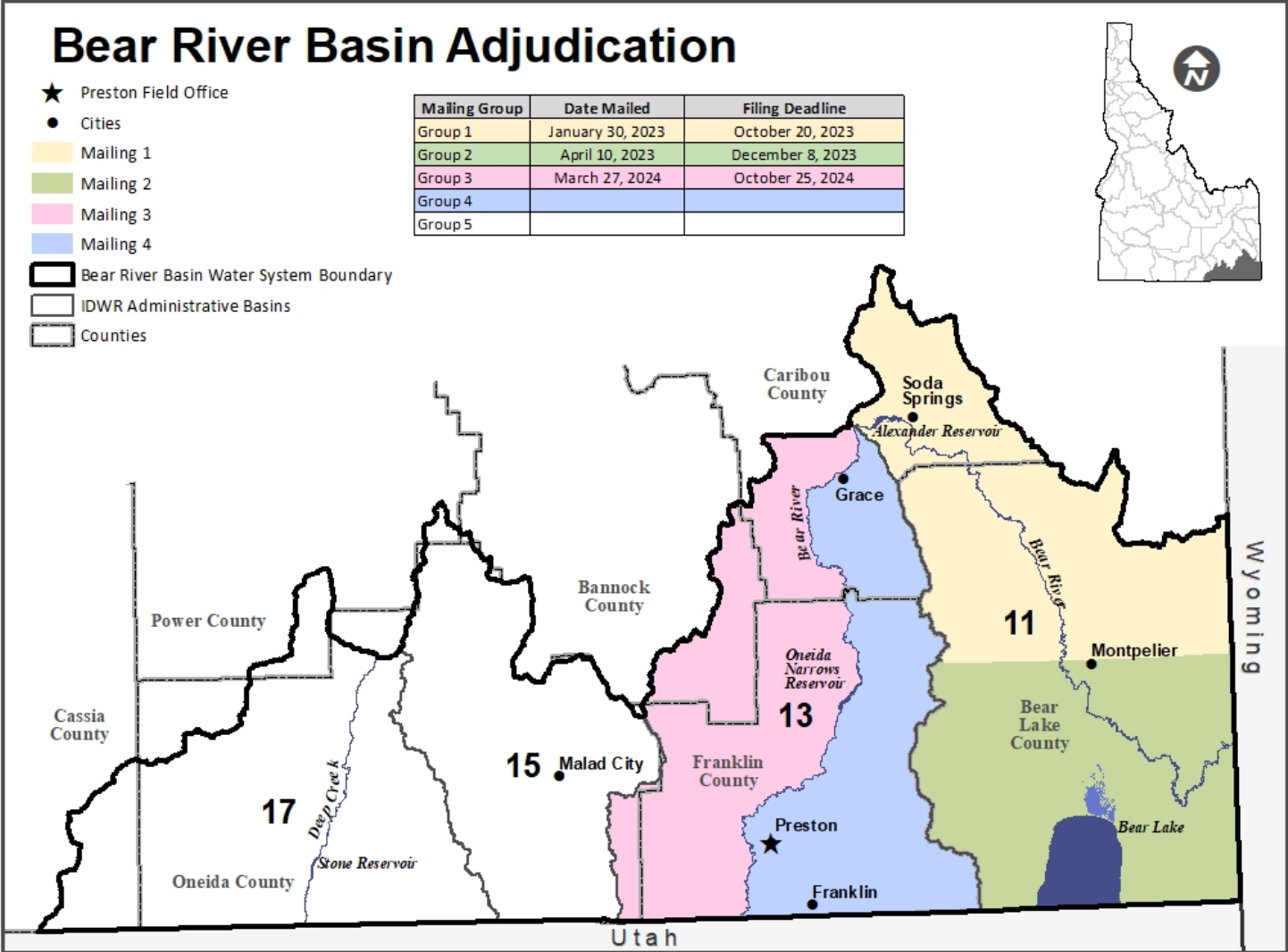

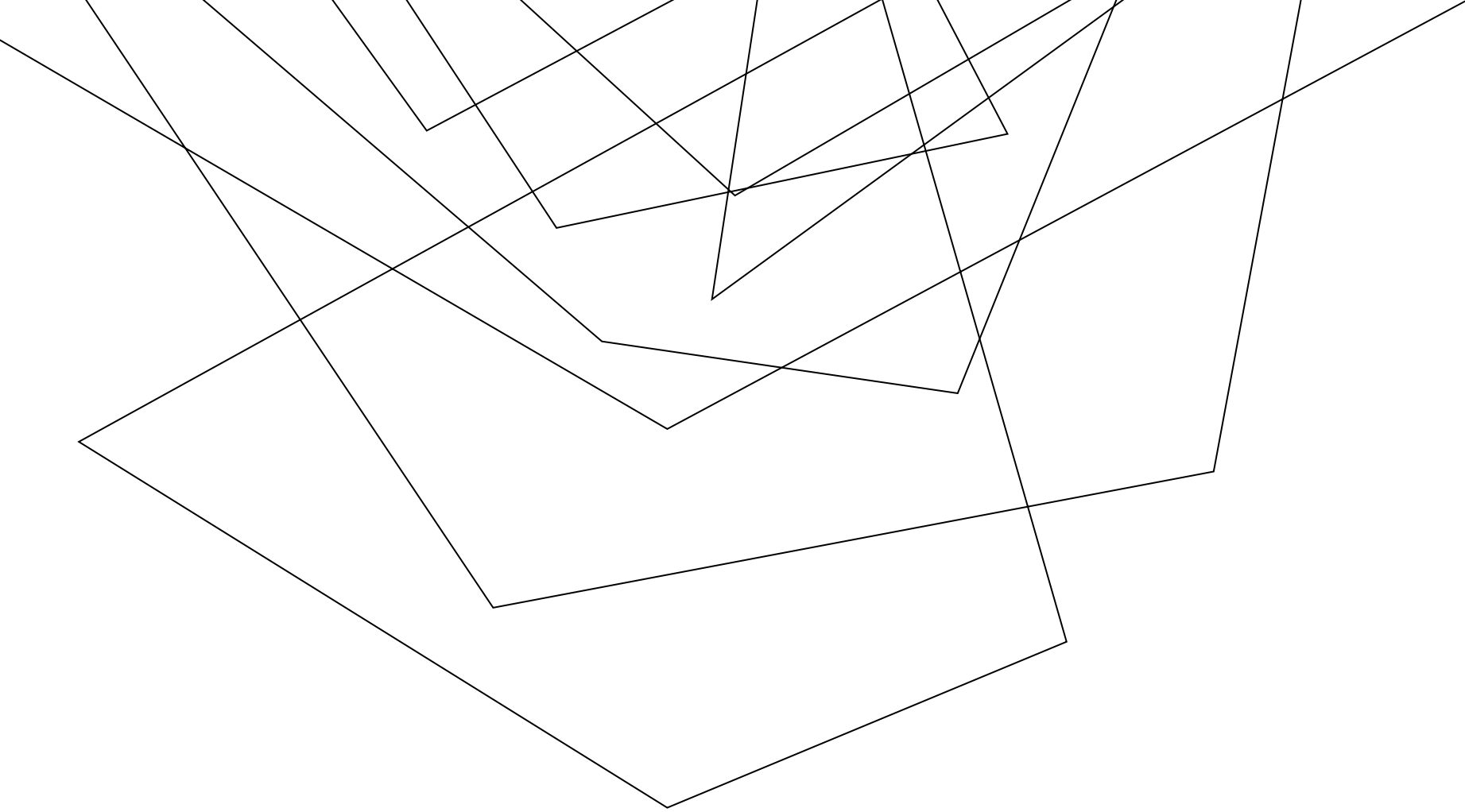

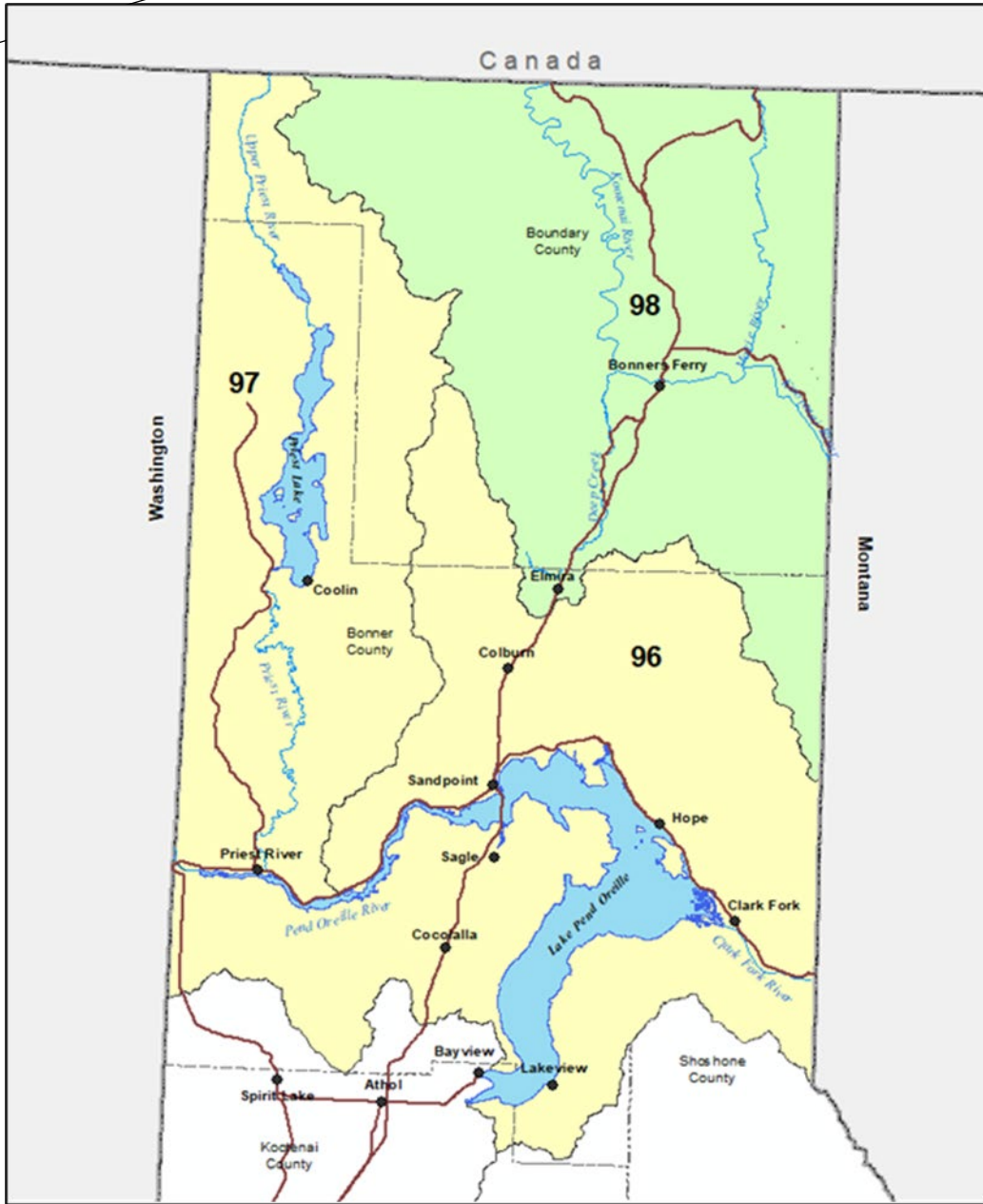

BASIN 98 UPDATES

- The Kootenai River Basin, or Administrative Basin 98, is the only basin that has not yet been adjudicated.
- Idaho Code § 42-1406D, the statute authorizing the Department to petition the district court to commence the Kootenai River Basin Adjudication, went into effect July 1, 2024.
