

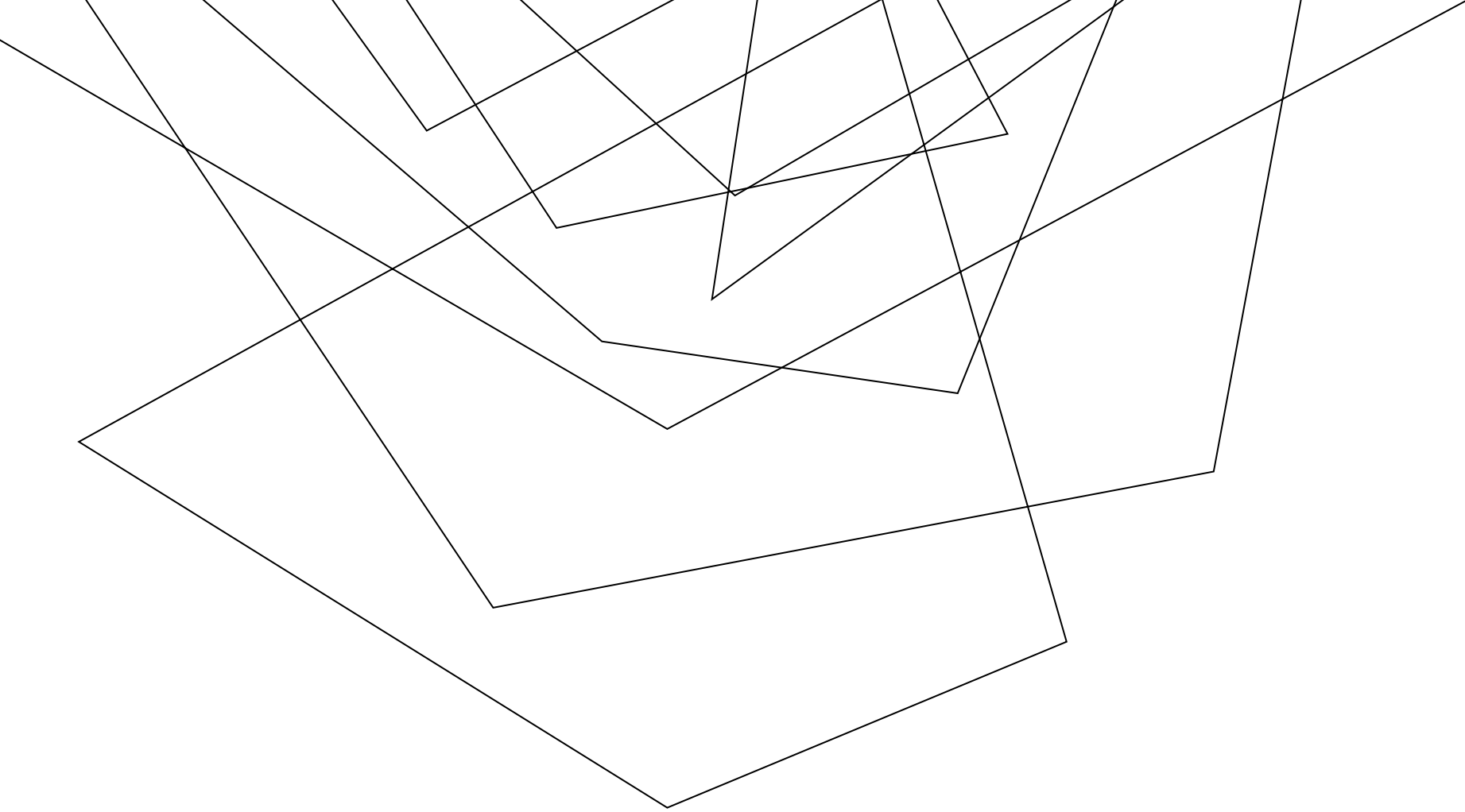

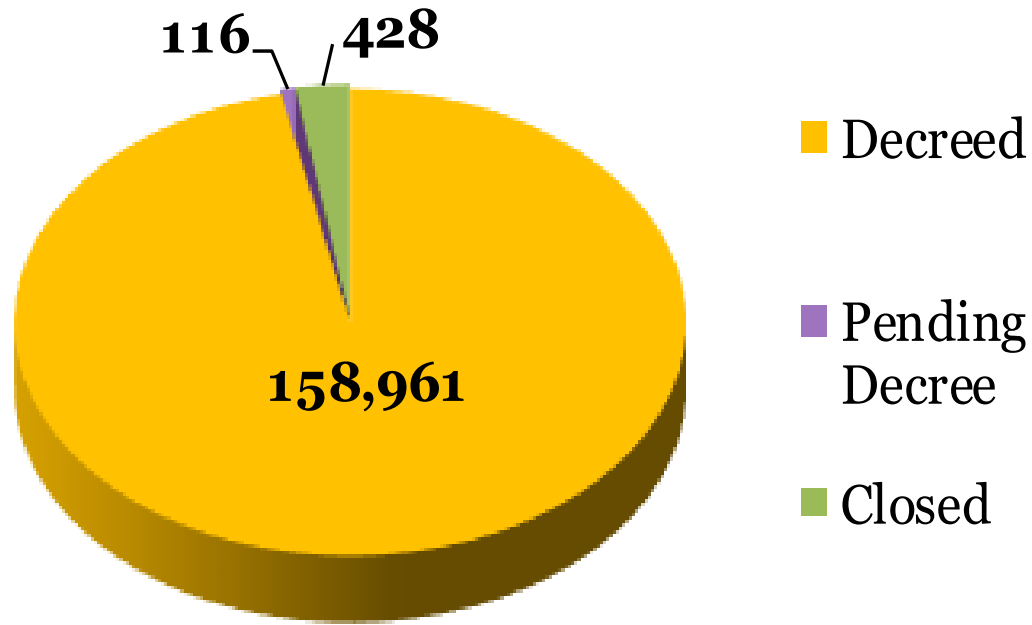

ADJUDICATION OF DEFERRED DE MINIMIS DOMESTIC AND STOCKWATER CLAIMS

- A hearing on the United States' *Motion to Adjudicate Deferred De Minimis Domestic and Stockwater Claims* was held on January 16, 2024. The Court issued a *Stay Order* to be in effect until 60 days after the resolution of *U.S. v. State of Idaho*, Case No. 1:22-cv-00236-DKG, currently pending in the United States District Court for the District of Idaho.

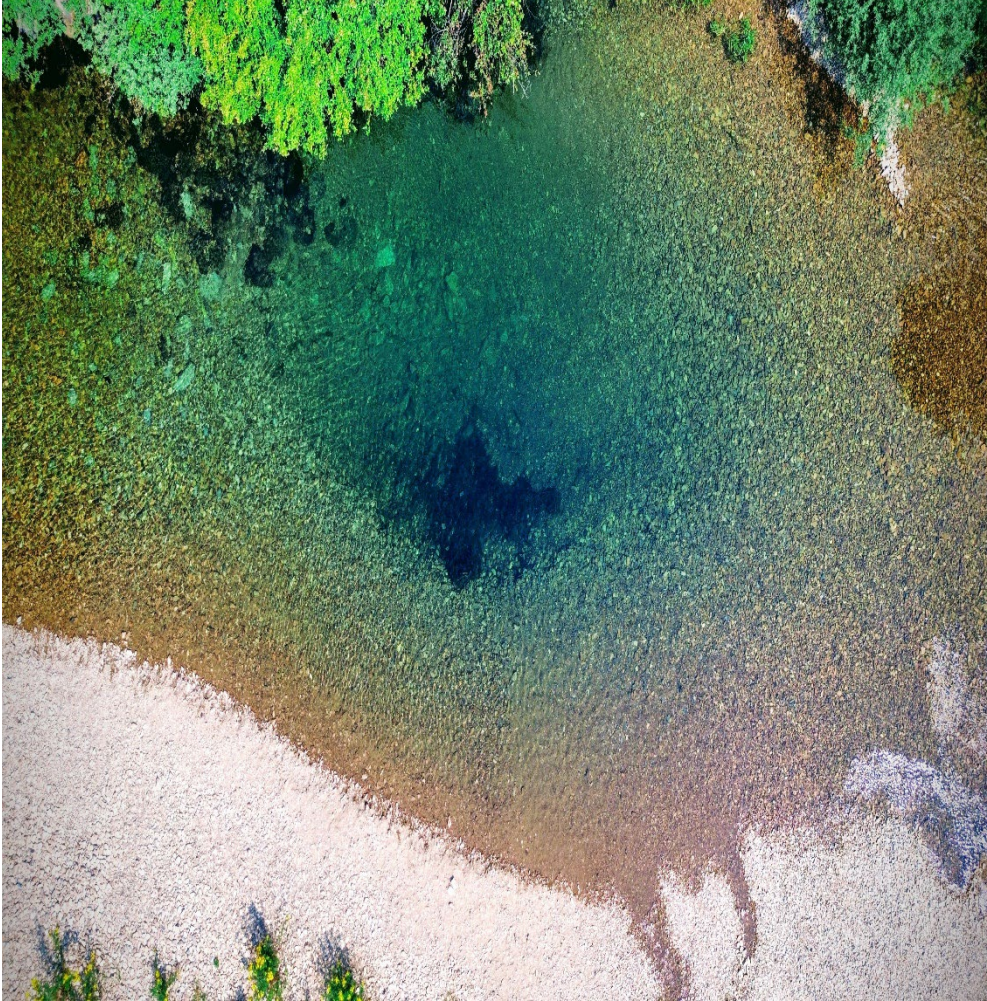

Deadline to file SF5s in the Avista and Governor's water rights set for October 30, 2024.

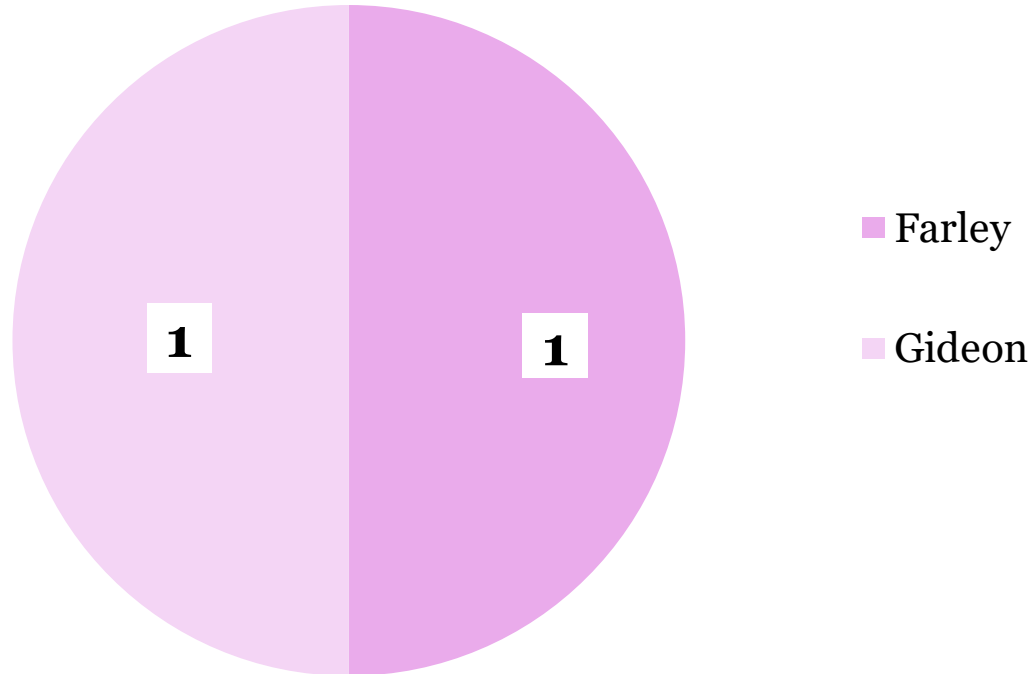

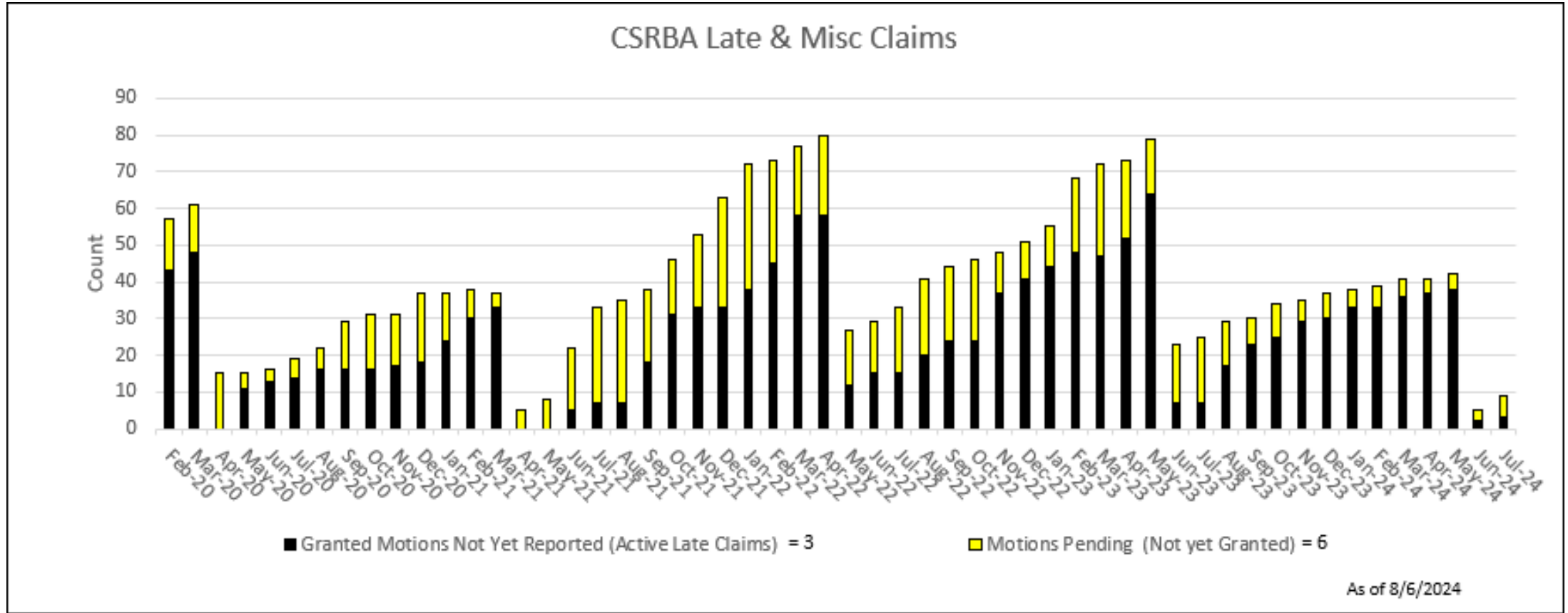

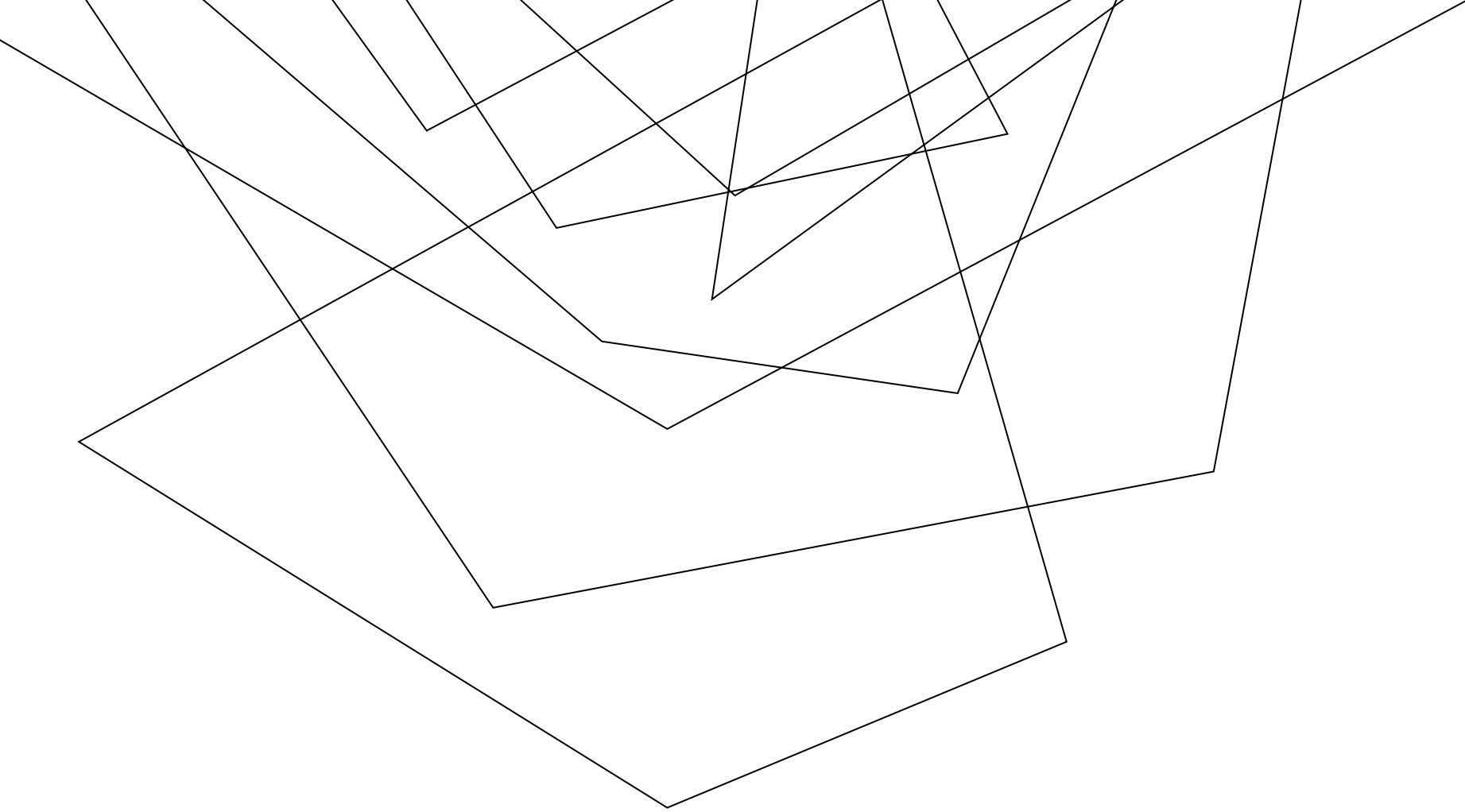
3 OBJECTIONS TO 2 CONTESTED SUBCASES

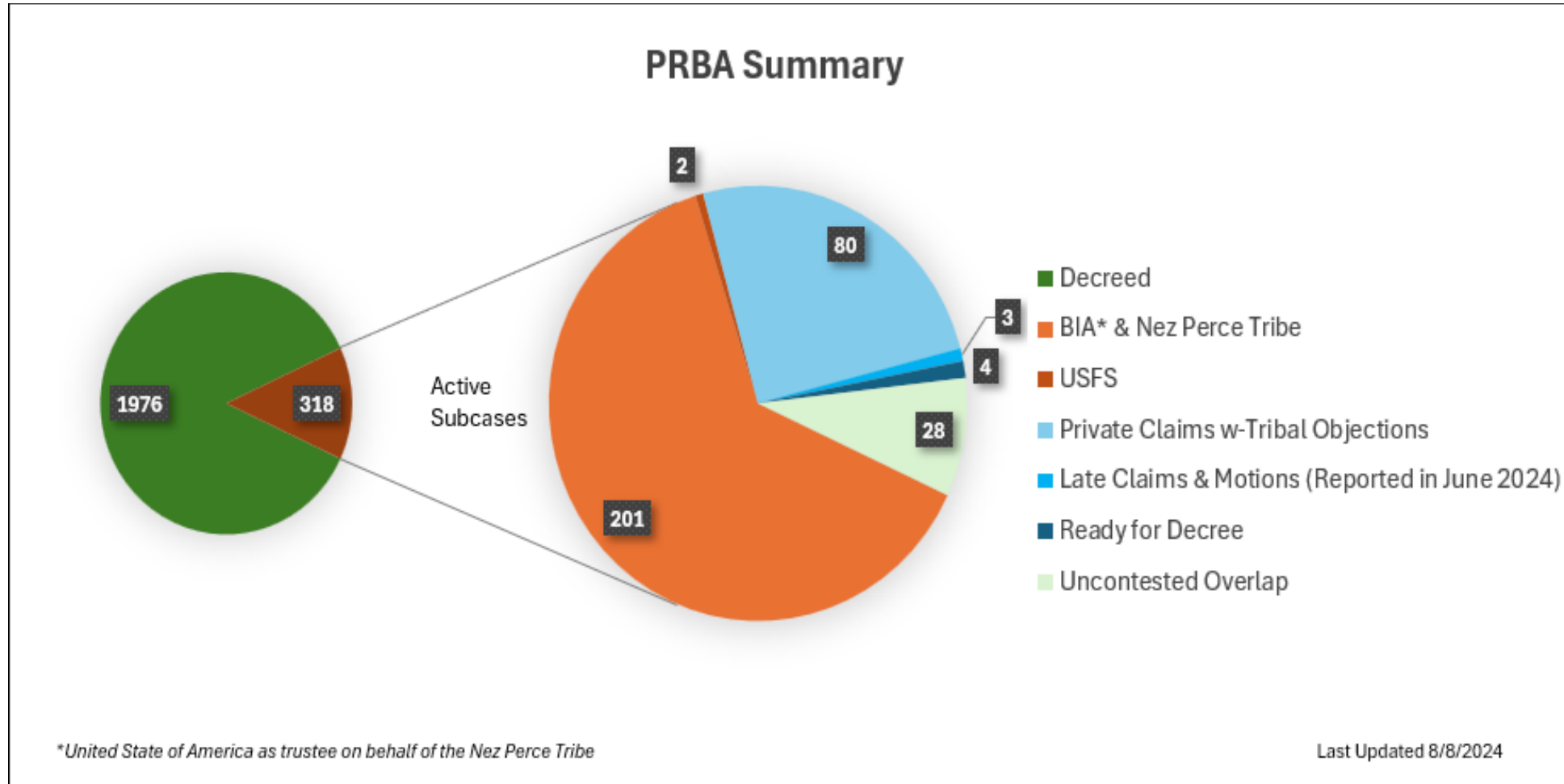

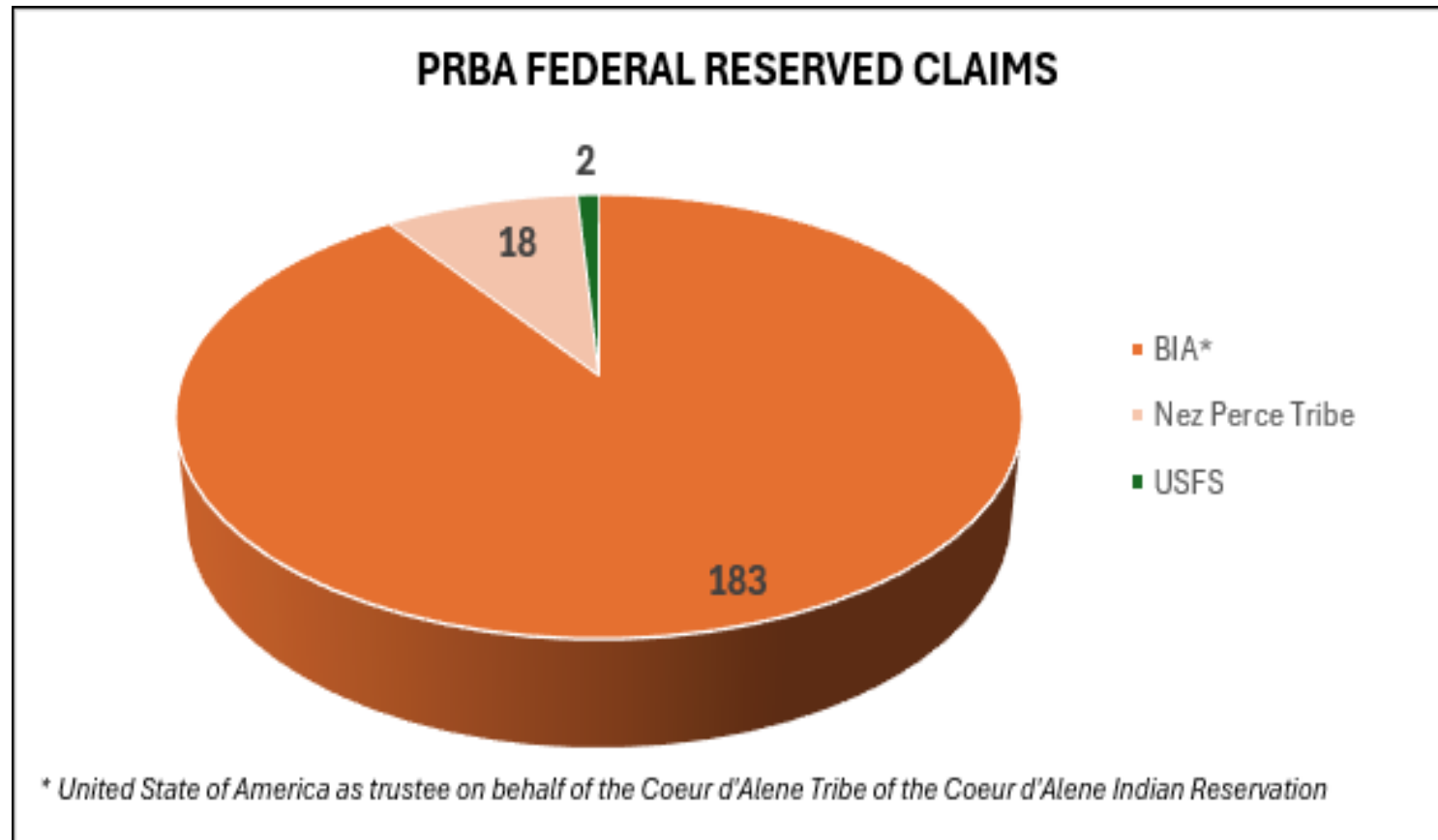

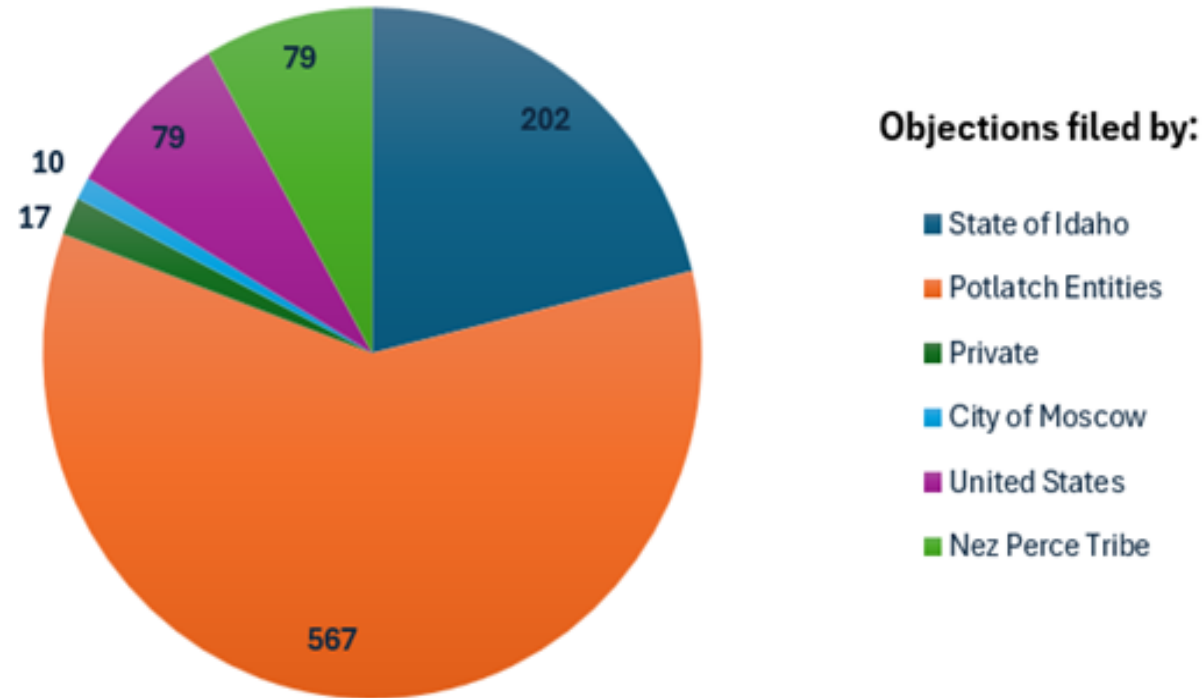
PRBA SUMMARY AS OF AUGUST 8, 2024



PRBA FEDERAL RESERVED CLAIMS

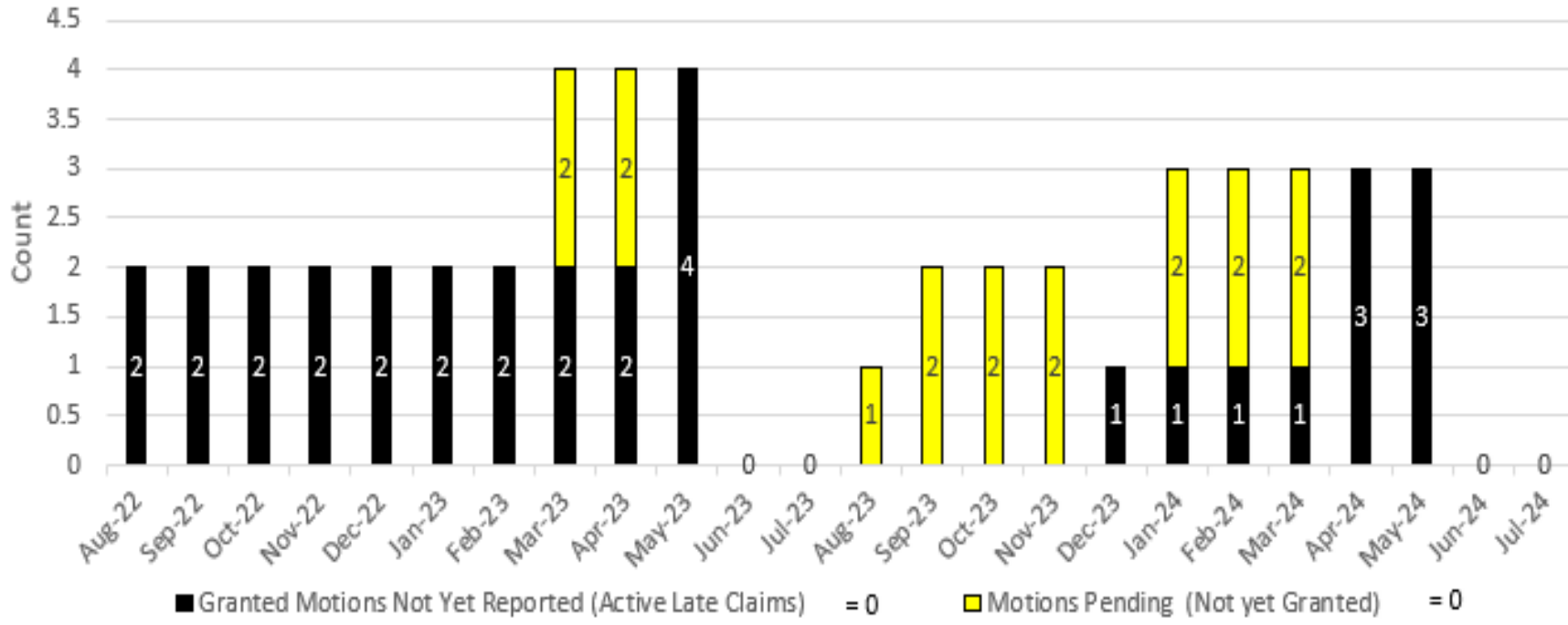

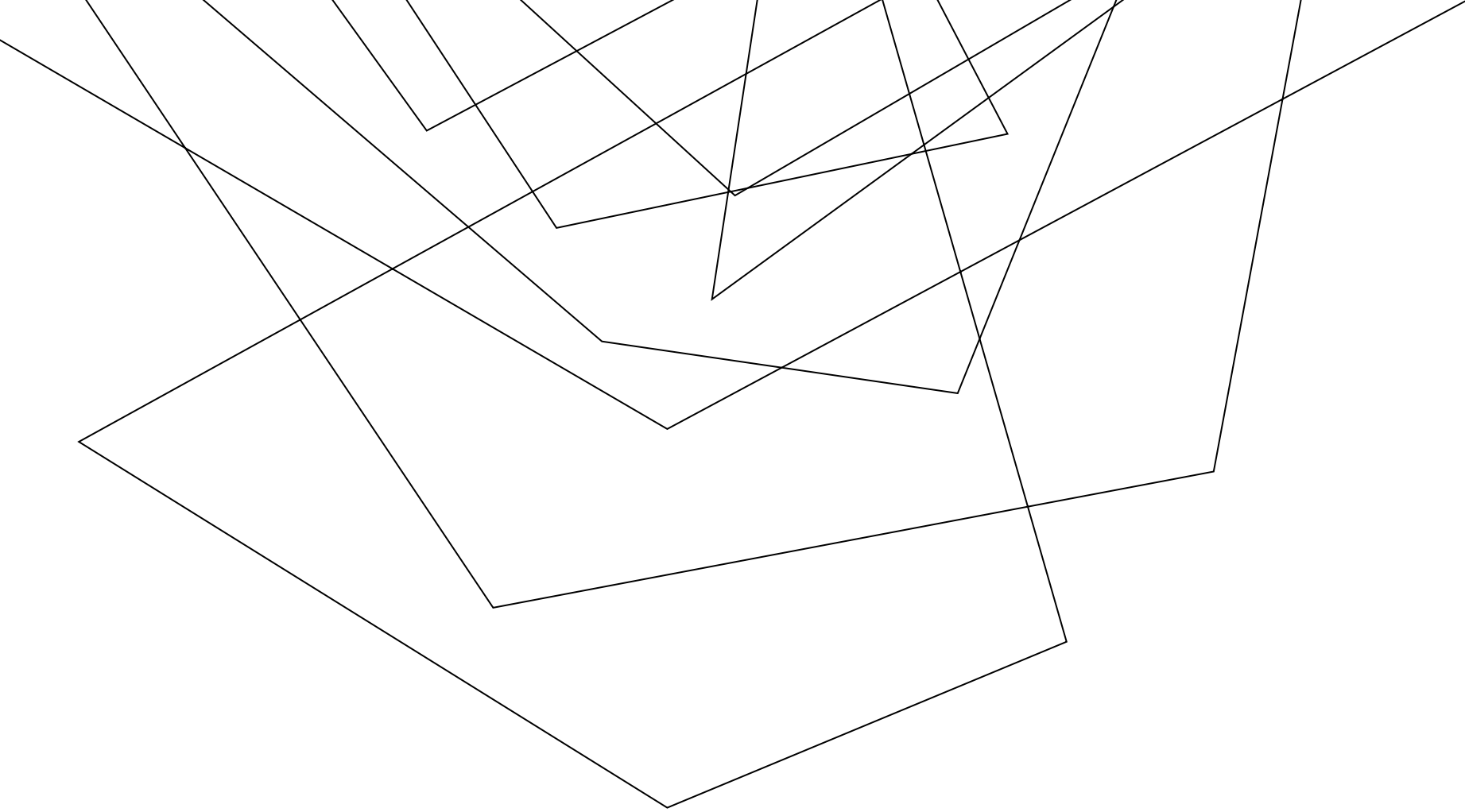

PRBA Late & Misc Claims



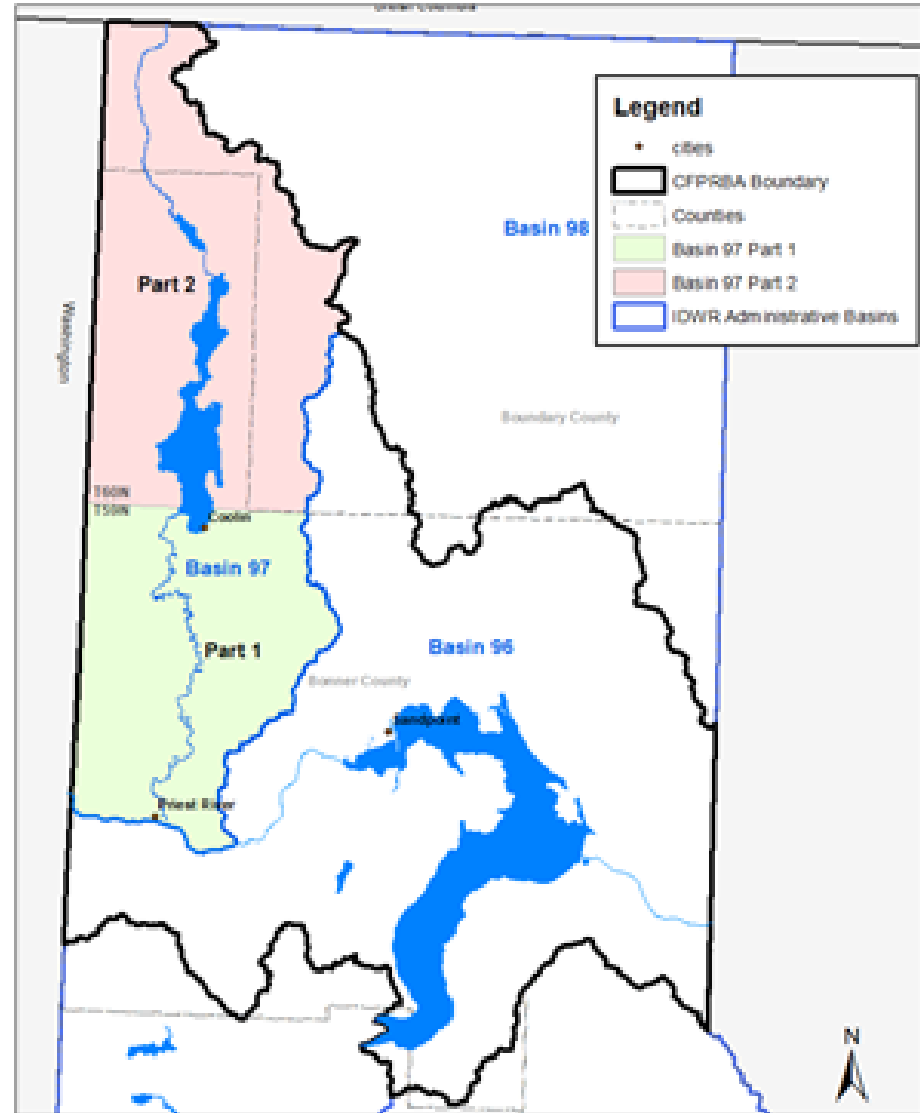

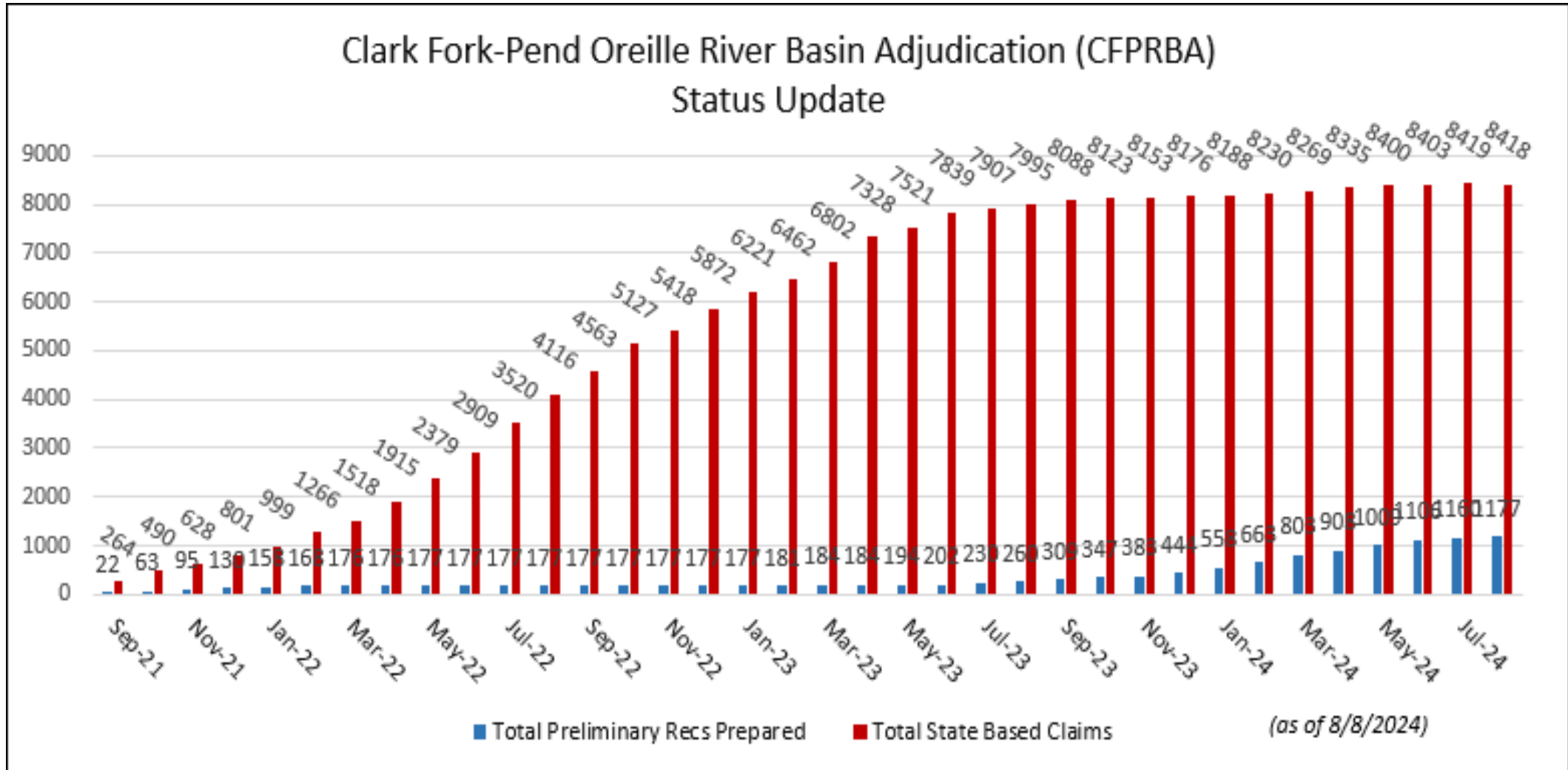

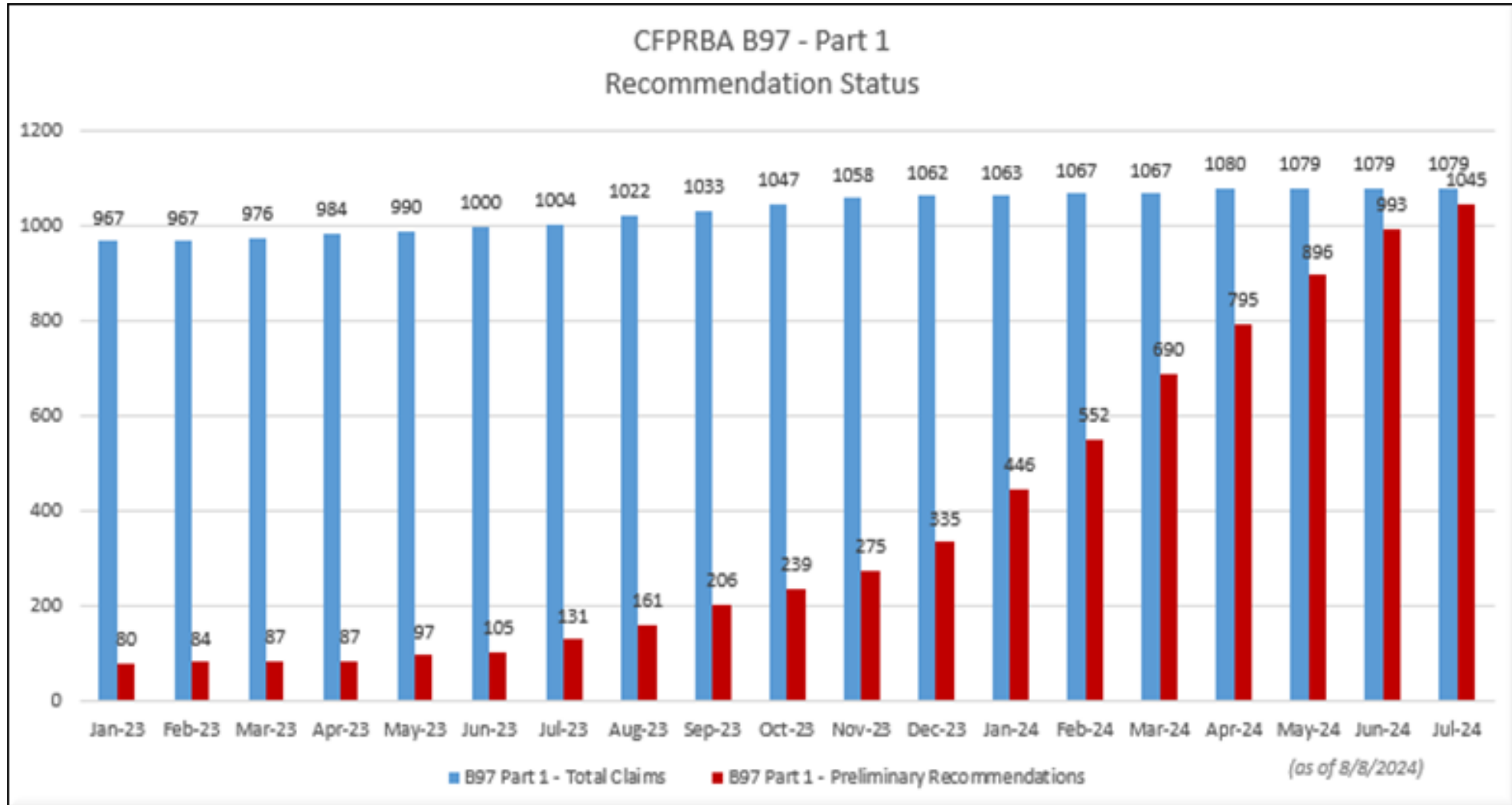
- 1,049 preliminary recommendations with Notice of Error reports were mailed on August 7, 2024.

- Adjudication staff are working on recommendations for the Basin 97 Part 2 Preliminary Director's Report.



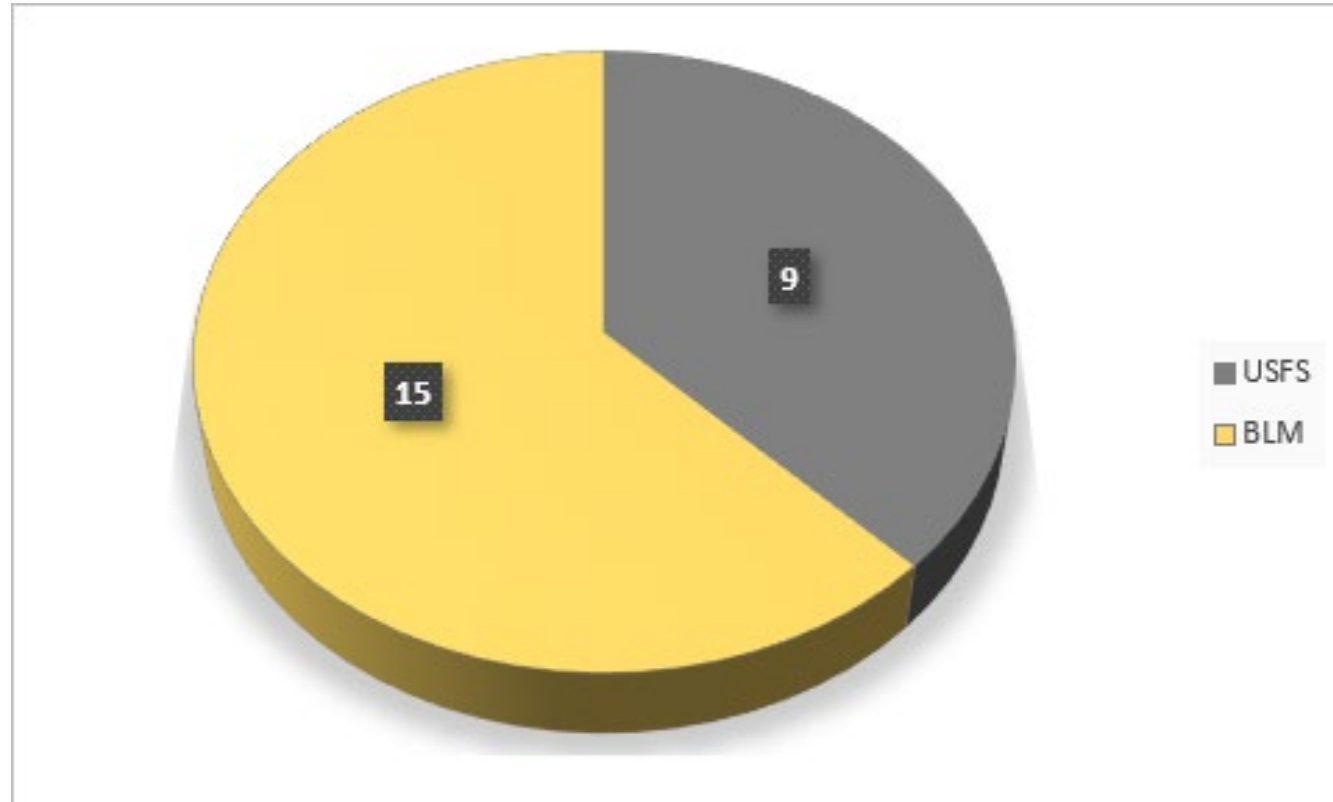

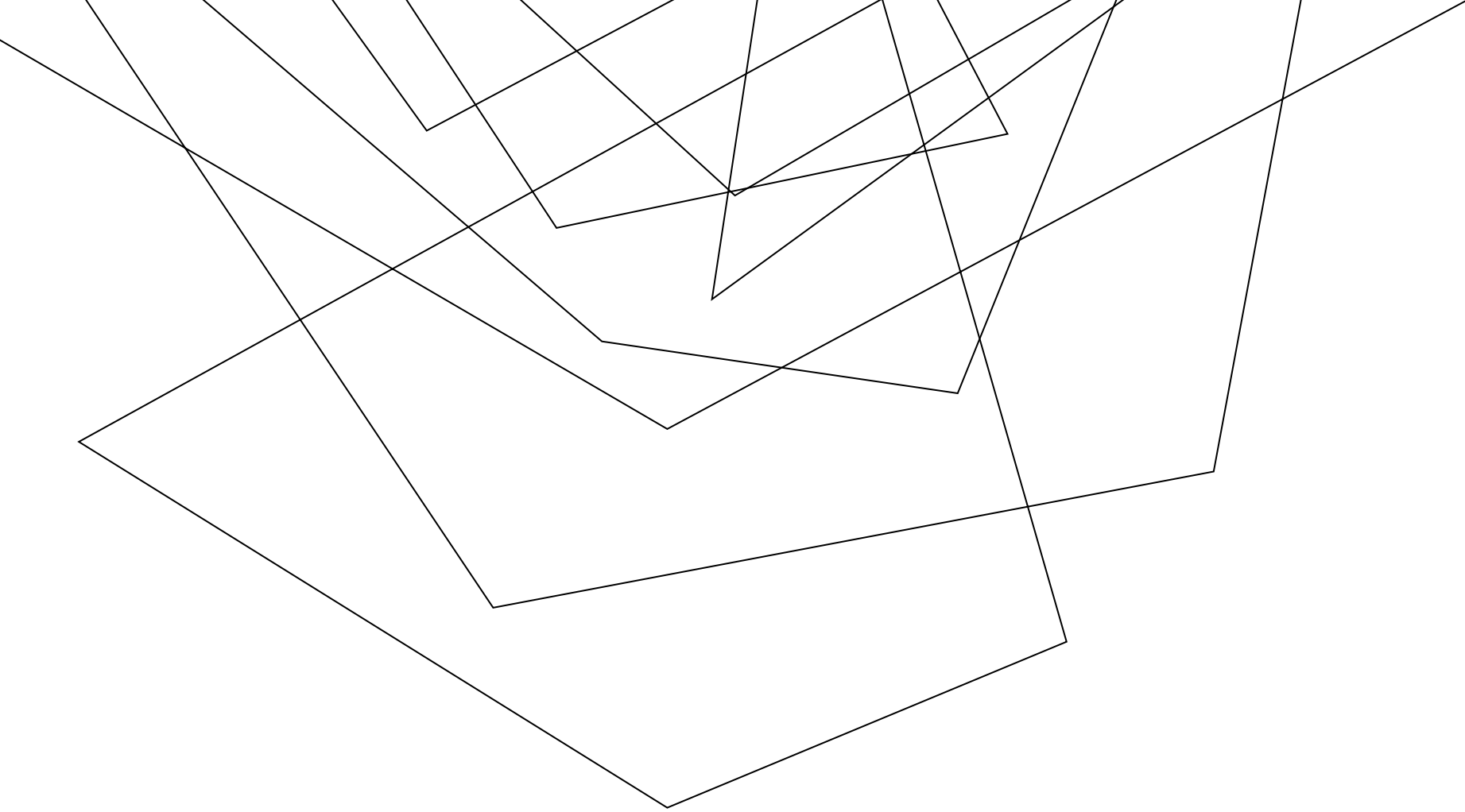


BASIN 97 – PART 1



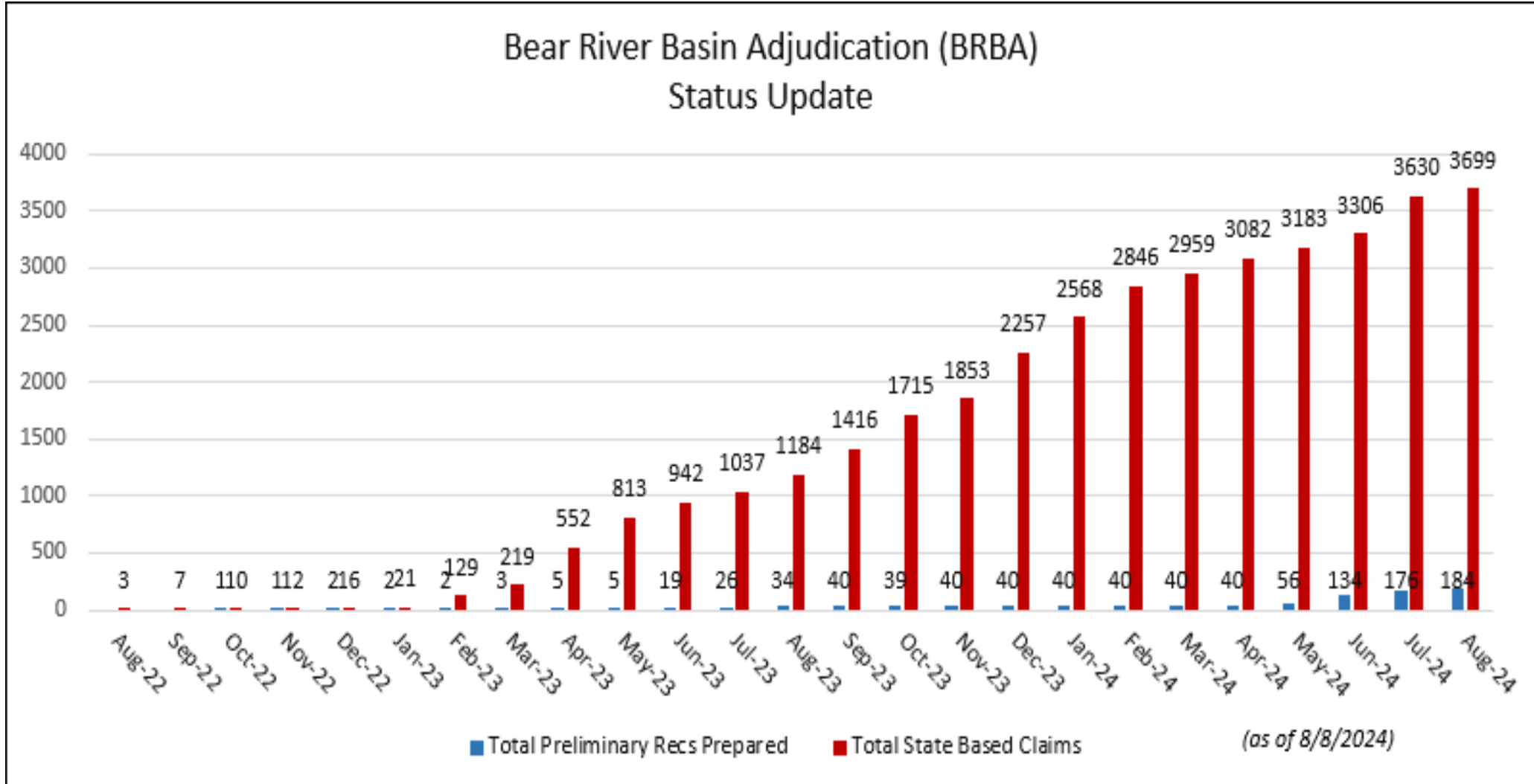
CFPRBA FEDERAL RESERVED CLAIMS



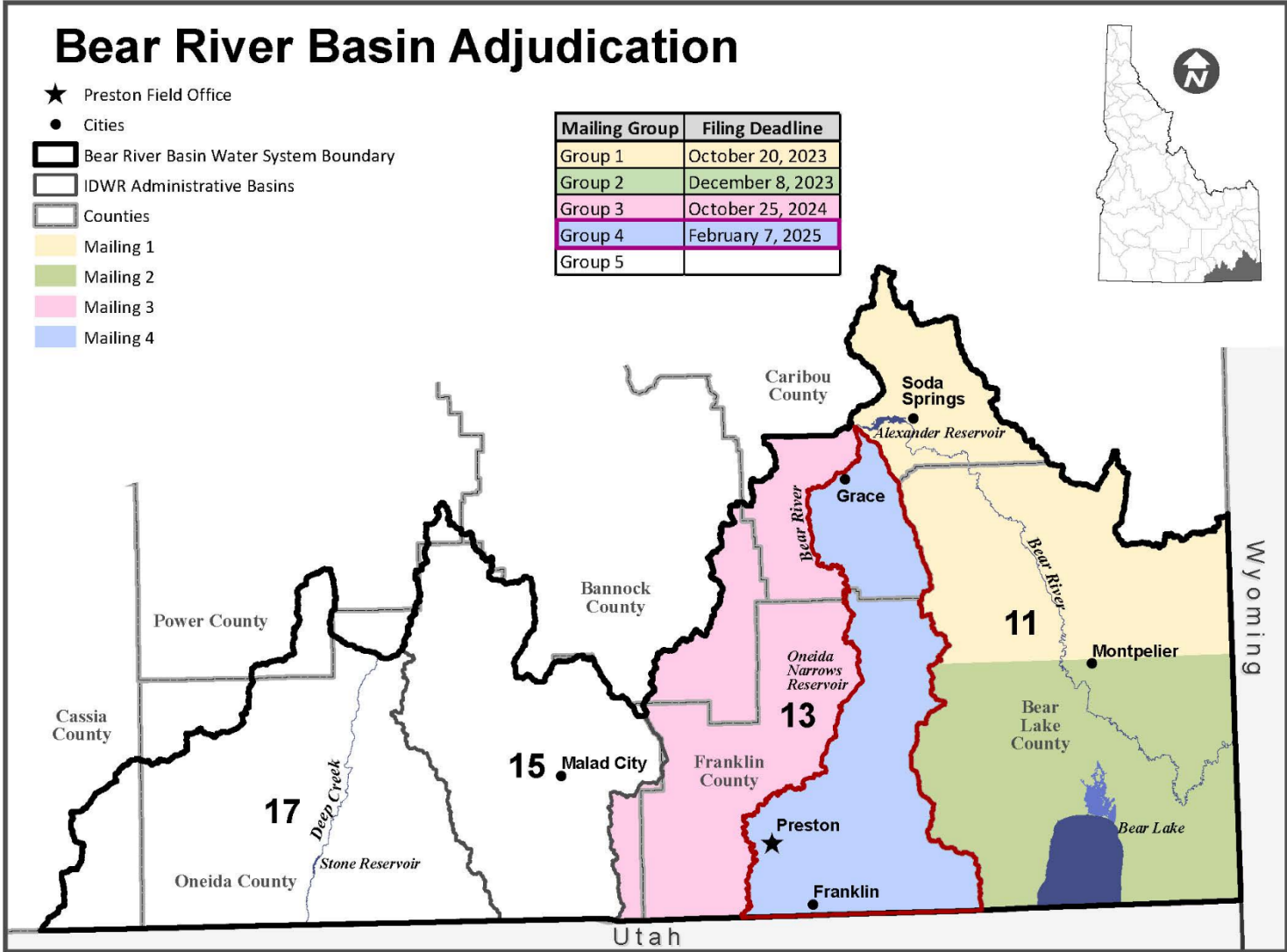

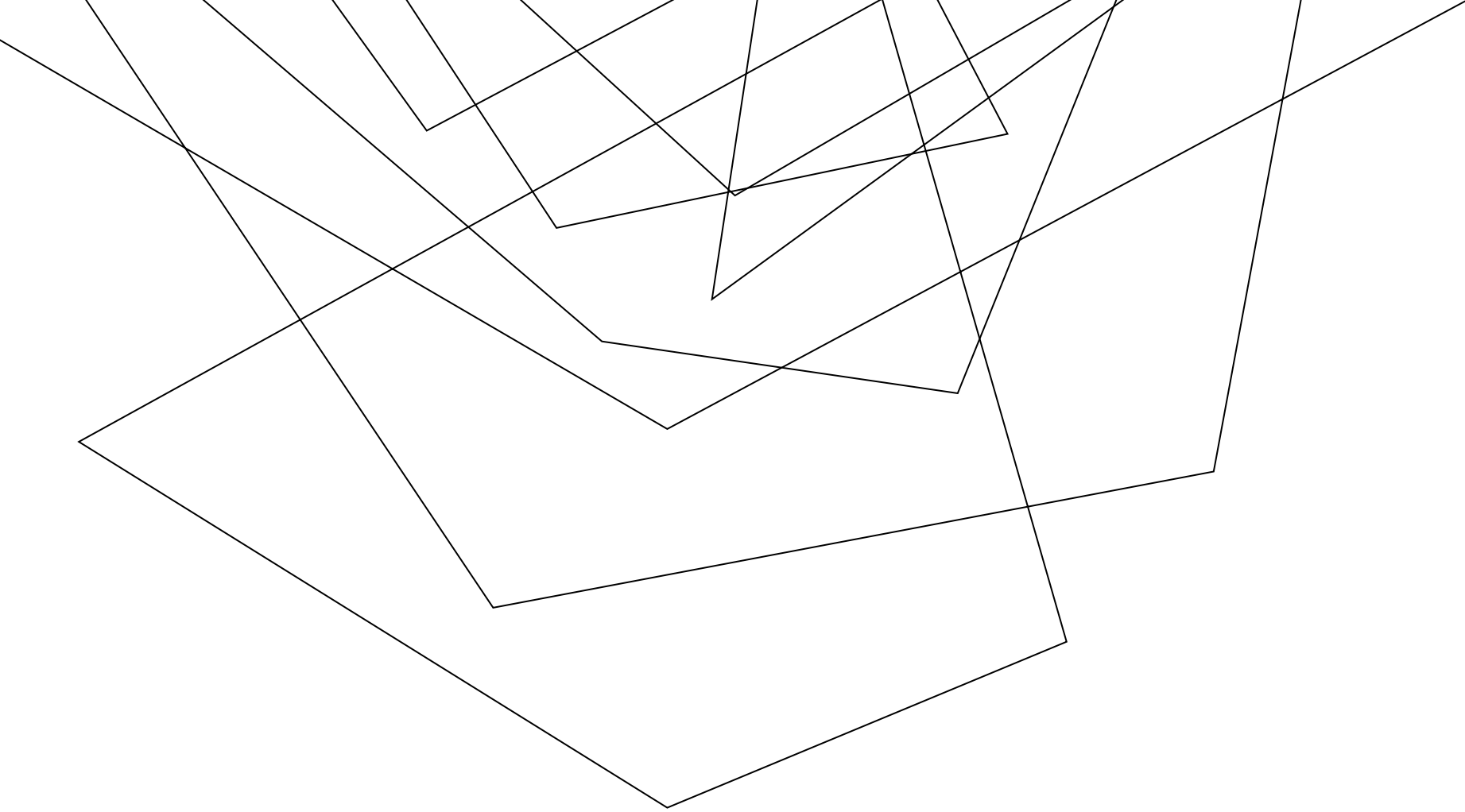

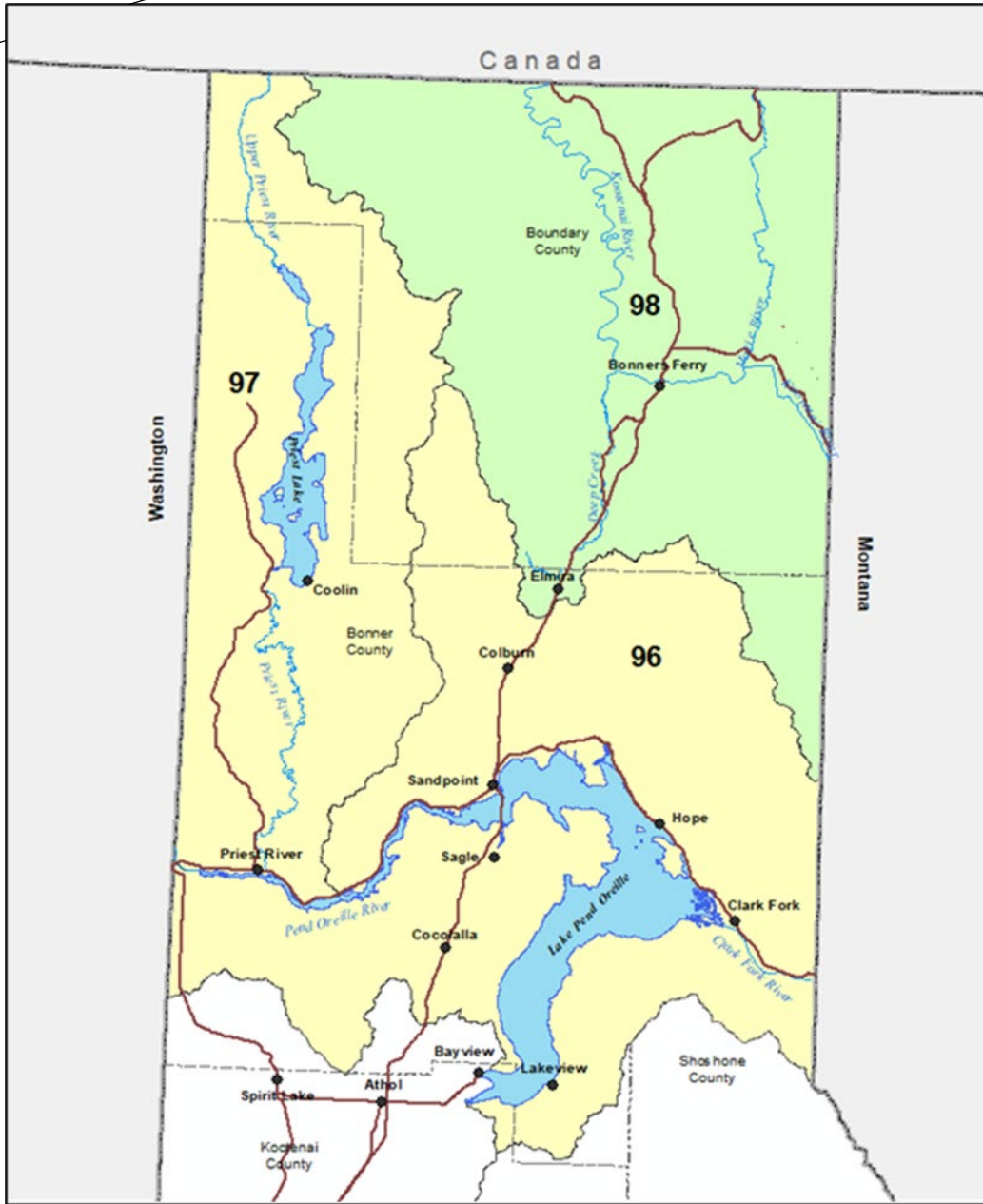

BASIN 98 UPDATES

- The Kootenai River Basin, or Administrative Basin 98, is the only basin that has not yet been adjudicated.
- Idaho Code § 42-1406D, the statute authorizing the Department to petition the district court to commence the Kootenai River Basin Adjudication, went into effect July 1, 2024.

 - Notice of Appeal filed July 12, 2024
 - Record is being compiled
- Idaho Ground Water Appropriators Inc. v. Idaho Department of Water Resources
 - CM-MP-2016-001; Ada County Case CV01-23-7893
 - Notice of Appeal filed April 5, 2024
 - Matter stayed until October 1, 2024
