



## SUBCASE 00-92095 ADJUDICATION OF DEFERRED DE MINIMIS DOMESTIC AND STOCKWATER CLAIMS


• Pursuant to Judge Wildman's January 22, 2024 Stay Order, this subcase is stayed pending resolution of *U.S. v. Idaho* in the Federal Courts.

## UNITED STATES OF AMERICA V. STATE OF IDAHO ET AL., US COURT OF APPEALS FOR THE NINTH CIRCUIT

- The United States challenged the constitutionality of several statutes enacted by the Idaho Legislature following the Idaho Supreme Court's decision in *Joyce Livestock Co. v. US*, 156 P.3d 508 (2007).
- *Memorandum Decision and Order* issued by Chief U.S. District Court Judge, David Nye, on August 28, 2024.
  - The Court concluded §§ 42-222 and 42-224 are constitutional as applied to the US and rejected the US' requests for permanent injunctions under those statutes.
  - The Court granted summary judgment to the US on the following statutes: §§ 42-113(2)(b), 42-502, and 42-504. The Court concluded that the US is entitled to a declaratory judgment that these three statutes violate the Supremacy Clause of the US Constitution. The Court also granted permanent injunction with respect to these three statutes.
- The US District Court issued the Amended Judgment on December 16, 2024 in response to Rule 60(a) Motion.

- Ninth Circuit Appellate briefing schedule has been set:
  - US' consolidated first brief on cross appeal is due April 30, 2025
  - Idaho's consolidated second brief on cross appeal is due May 30, 2025
  - US' consolidated third brief on dross appeal is due June 30, 2025
  - Idaho's optional reply brief is due July 21, 2025

All the remaining outstanding objections are to claims filed by private parties with a spring source, or to the corresponding federal reserved claims.








#### CFPRBA UPDATES


- The Director's Report for Basin 97 Part 1 was mailed on December 17, 2024.

- Adjudication staff are working on recommendations for the Basin 97 Part 2 Preliminary Director's Report.
















#### **BASIN 98 UPDATES**

- Petition to Commence Kootenai River Basin Adjudication filed on January 3, 2025.
- Hearing on Petition to Commence Kootenai River Basin Adjudication is scheduled for July 15, 2025.
- IDWR will be republishing the notice of filing pursuant to its obligations under Idaho Code § 42-1407.
- IDWR Senior Water Resource Agent Luke Bates continues to hold office hours at the Boundary County Annex Building in Bonners Ferry. These have typically been on the third Wednesday of each month to assist walk-ins with questions about the adjudication, water use, water rights, and more.





- Idaho Ground Water Appropriators Inc. v. Idaho Department of Water Resources
  - CM-MP-2016-001; Ada County Case CV01-23-7893; ISC Case 51784-2024
  - Notice of Appeal filed April 5, 2024.
  - ISC stayed matter pending settlement discussions.
  - Settlement reached and Director approved settlement as a stipulated mitigation plan.
  - The Idaho Supreme Court granted the stipulated motion to dismiss.
