Report of the Conservation, Infrastructure & Efficiency Fund (CIEF) Committee for Water Year 2024

To: Idaho Water Resources Board (IWRB), Idaho Department of Water Resources (IDWR) & Big Wood River Groundwater Management Area (BWRGWMA) Advisory Committee Date: December 10, 2024

The CIEF Committee respectfully submits this annual report to the above-named agencies pursuant to BWRGWMA Management Plan (GWMP), Paragraph V.1.C.7. which states:

The CIEF Committee shall report on the following items to the BWRGWMA Advisory Committee, IDWR, and the IWRB by December 1 of each year: CIEF contributions and expenditures, CIEF Committee decisions, and the results of any actions taken by the CIEF Committee.

This report consists of a narrative description of the Committee's activities this year, followed by a statement of financial status.

Summary of Significant Events:

The CIEF Committee met four times in 2024. In addition to the below described actions, the CIEF Committee heard updates on approved projects. It conducted ongoing discussions on how best to accomplish its mission, as experience has been gained, in accordance with the intent of the GWMP. In light of GWMP amendments, the Committee shortly will be asking IDWR for some new guidance. No storage water was leased this year.

At its March meeting, the Treasurer reported on the investment of cash balances in certificates of deposit. After lengthy discussion, direction was given to Upper Wood River Water Users Association (UWRWUA) & Project Big Wood, re: the Baseline Bypass Canal lining project proposal. No other actions taken.

At its May meeting, the Committee authorized a grant in the amount of \$30,000 to UWRWUA & Project Big Wood, re: the Baseline Bypass Canal lining project proposal, for installation & monitoring of data loggers as part of a seepage study. The Committee also authorized an additional \$100,000 for the canal lining itself, contingent upon Bureau of Reclamation grant funding (or other co-funding) and study results.

At its August meeting, the Committee authorized partial reimbursement in the amount of \$15,000.00 to Big Wood Canal Company, American Falls Reservoir District #2 & Water District 37 for the SCADA monitoring stations project. Though authorized for funding, it was reported the Slough Ditch project has not begun. Also at this meeting, the Committee approved an application by 4L Farms for 50% of the costs of an electrical system upgrade as part of an efficiency project, not-to-exceed \$65,000. (Nick Westendorf recused himself from deliberations & vote.)

At its December meeting, the Committee heard that flows at Station 10 on the Little Wood River fell below the 32cfs target five times, but never for longer than 1-2 days. It approved development of an investment guidelines document. It authorized reimbursement of \$30,000 to Project Big Wood for the seepage study. It gave direction to Alton Huyser, Big Wood Farms to get more information regarding the proposal for a pivot drag & drip line conversion demonstration project.
